HOUSE BILL NO. 293

AN ACT TO AMEND TITLE 25 OF THE DELAWARE CODE RELATING TO RULES AND REGULATIONS RELATING TO CERTAIN BUILDINGS SINGLE ROOM LEASE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

| 8 | of the rental agreement that the agreement shall terminate upon its expiration date. |
| 9 | Section 2. Amend § 5512, Title 25 of the Delaware Code by making deletions as shown by strike through and |
| 10 | insertions as shown by underline as follows: |
| 11 | § 5512. Rules and regulations relating to certain buildings; landlord remedies. |
| 12 | Any provision of the Landlord-Tenant Code [Chapters 51 through 59 of this title] to the contrary notwithstanding, |
| 13 | all rental agreements for the rental of single rooms in certain buildings may be terminated immediately upon notice to the |
| 14 | tenant for a tenant's material violation of a regulation which has been given to a tenant at the time of contract or lease, and |
| 15 | upon 15 days after written notice for any other reason, and the landlord shall be entitled to bring a proceeding for |
| 16 | possession where: |
| 17 | (1) The building is the primary residence of the landlord; and |
| 18 | (2) No more than 3 rooms in the building are rented to tenants; and |
| 19 | (3) No more than 3 tenants occupy such building. |

This bill requires a landlord to provide 15 days' notice to a single room tenant prior to the termination of a rental agreement for any reason other than a material violation. This notice provision ensures that the tenant has time to find suitable housing prior to the termination of their current lease, while still permitting a landlord to quickly remove a tenant renting a single room within a house.
