HOUSE BILL NO. 348

AN ACT TO AMEND TITLES 18 AND 24 OF THE DELAWARE CODE RELATING TO TELEMEDICINE SERVICES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. The General Assembly finds and declares all of the following:

2 (1) On March 12, 2020 Governor John C. Carney declared a State of Emergency effective as of March 13,
3 2020 due to the serious public health threat created by the novel coronavirus, "Covid-19."

4 (2) On March 18, 2020 Governor John C. Carney issued the Second Modification of the March 12, 2020
5 Declaration of a State of Emergency due to a Public Health Threat which, inter alia, suspended all Title 24 statutory
6 requirements that patients present in-person before telemedicine services may be provided so long as the patient is a
7 Delaware resident and directed that any out of state health care provider holding an active license in another
8 jurisdiction who would be permitted to provide telemedicine services in Delaware if licensed under Title 24 may
9 provide telemedicine services to a Delaware resident. The March 18, 2020 Second Modification also suspended the
10 Delaware Board of Medical Licensure and Discipline Regulation 19 requiring that telemedicine communications
11 include a visual communication component.

12 (3) On March 30, 2020 Governor John C. Carney issued the Eighth Modification of the March 12, 2020
13 Declaration of a State of Emergency due to a Public Health Threat which stated: "4. a. To the extent not suspended by
14 the Second Modification of the Declaration of a State of Emergency, all regulations requiring any in-person contact
15 before or during telemedicine services by any medical professional are hereby suspended."

16 (4) On April 6, 2020 Governor John C. Carney issued the Tenth Modification of the March 12, 2020
17 Declaration of a State of Emergency due to a Public Health Threat which stated: "6. INSURANCE: Pursuant to the
18 authority provided in 20 Del. C. §3116(a)(2), requirements for the provision of telemedicine and telehealth under Title
19 24 of the Delaware Code that require both audio and visual technology are suspended, which will allow the use of non-
20 smart phone or landline connections."

21 (5) The interest of Delawareans will be served by ensuring the provisions addressed in the Declaration of the
22 State of Emergency as modified pertaining to telemedicine are maintained into the foreseeable future to facilitate the

23 delivery of health care services during and in the aftermath of the serious public health threat occasioned by COVID-
24 19.

25 Section 2. Amend Chapter 33 of Title 18 of the Delaware Code by making deletions as shown by strike through
26 and insertions as shown by underline as follows:

27 Chapter 33. Health Insurance Contracts

28 § 3370. Telemedicine.

29 (a) As used in this section:

30 (1) “Distant site” means a site at which a health care provider legally allowed to practice in the state or at
31 which a health care provider licensed in another jurisdiction who would be permitted to provide services in Delaware if
32 licensed under this title is located while providing health care services by means of telemedicine or telehealth.

33 (2) “Originating site” means a site in Delaware or outside of Delaware if the patient is a Delaware resident at
34 which a patient is located at the time health care services are provided to him or her by means of telemedicine or
35 telehealth, unless the term is otherwise defined with respect to the provision in which it is used; provided, however,
36 notwithstanding any other provision of law, insurers and providers may agree to alternative siting arrangements
37 deemed appropriate by the parties.

38 (4) “Telehealth” means the use of information and communications technologies consisting of telephones,
39 remote patient monitoring devices or other electronic means which support clinical health care, provider consultation,
40 patient and professional health-related education, public health, health administration, and other services as described
41 in regulation; which may not require the use of technology permitting visual communication.

42 (5) “Telemedicine” means a form of telehealth which is the delivery of clinical health care services by means
43 of real time two-way audio, visual, or other telecommunications or electronic communications, including the
44 application of secure video conferencing or store and forward transfer technology to provide or support healthcare
45 delivery, which facilitate the assessment, diagnosis, consultation, treatment, education, care management and self-
46 management of a patient’s health care by a health care provider practicing within his or her scope of practice as would
47 be practiced in-person with a patient, and legally allowed to practice in the state, or other jurisdiction when treating a
48 Delaware resident, while such patient is at an originating site and the health care provider is at a distant site.

54 (1) "Distant site" means a site at which a health care provider legally allowed to practice in the state or at
55 which a health care provider licensed in another jurisdiction who would be permitted to provide services in Delaware if
56 licensed under this title is located while providing health care services by means of telemedicine or telehealth.

57 (2) "Originating site" means a site in Delaware or outside of Delaware if the patient is a Delaware resident at
58 which a patient is located at the time health care services are provided to him or her by means of telemedicine or
59 telehealth, unless the term is otherwise defined with respect to the provision in which it is used; provided, however,
60 notwithstanding any other provision of law, insurers and providers may agree to alternative siting arrangements
61 deemed appropriate by the parties.

62 (4) "Telehealth" means the use of information and communications technologies consisting of telephones,
63 remote patient monitoring devices or other electronic means which support clinical health care, provider consultation,

66 (5) "Telemedicine" means a form of telehealth which is the delivery of clinical health care services by means

68 application of secure video conferencing or store and forward transfer technology to provide or support healthcare
69 delivery, which facilitate the assessment, diagnosis, consultation, treatment, education, care management and self-
70 management of a patient's health care by a health care provider practicing within his or her scope of practice as would
71 be practiced in-person with a patient, and legally allowed to practice in the state, or other jurisdiction when treating a
72 Delaware resident while such patient is at an originating site and the health care provider is at a distant site.

73 (b) Each insurer proposing to issue individual or group accident and sickness insurance policies providing hospital,
74 medical and surgical, or major medical coverage on an expense-incurred basis; each corporation providing individual or
75 group accident and sickness subscription contracts; and each health maintenance organization providing a health care plan
76 for health care services shall provide coverage for the cost of such health care services provided through telemedicine.

77 (c) Each insurer proposing to issue individual or group accident and sickness insurance policies providing hospital,
78 medical and surgical, or major medical coverage on an expense-incurred basis; each corporation providing individual or
79 group accident and sickness subscription contracts; and each health maintenance organization providing a health care plan
80 for health care services shall provide coverage for the cost of such health care services provided through telehealth as
81 directed through regulations promulgated by the Department: which may not require the use of technology permitting
82 visual communication.

87 §1702 Definitions [Effective until Jan. 1, 2021].

130 (c) Treatment and consultation recommendations made in an online setting or through audio only communication,
131 including issuing a prescription via electronic means, will be held to the same standards of appropriate practice as those in
132 traditional (encounter in person) settings.

133 (g) Prescriptions, including for opioids, made through telemedicine and under a physician-patient relationship may
134 include controlled ~~substances, subject to limitations as set by the Board~~ substances. Prescribing controlled substances
135 utilizing telemedicine is subject to the same standard of care and requisite practice as prescribing for in-person visits.

136 (k) Telemedicine may be practiced without a physician-patient relationship during:

137 (1) Informal consultation performed by a physician outside the context of a contractual relationship and on an
138 irregular or infrequent basis without the expectation or exchange of direct or indirect compensation;

139 (2) Furnishing of medical assistance by a physician in case of an emergency or disaster if no charge is made
140 for the medical assistance; ~~or~~

141 (3) Episodic consultation by a medical specialist located in another jurisdiction who provides such
142 consultation services on request to a licensed health care professional.

143 (4) The pendency of the emergency resulting from COVID-19 which makes it impractical for a patient to
144 consult with a physician in-person prior to the delivery of telemedicine services.

166 privileges, or have fulfilled the credentialing criteria of the surgical committee of the Joint Committee on Accreditation
167 of Hospitals accredited hospital where the amputation is to be performed.

168 (17) “Telehealth” means the use of information and communications technologies consisting of telephones,

213 (a)(1) "Chiropractic" means a drugless system of health care based on the principle that interference with the
214 transmission of nerve impulses may cause disease.

215 (2) "Distant site" means a site at which a health care provider legally allowed to practice in the state or at
216 which a health care provider licensed in another jurisdiction who would be permitted to provide services in Delaware if
217 licensed under this title is located while providing health care services by means of telemedicine or telehealth.

218 (3) "Originating site" means a site in Delaware or outside of Delaware if the patient is a Delaware resident at
219 which a patient is located at the time health care services are provided to him or her by means of telemedicine or
220 telehealth, unless the term is otherwise defined with respect to the provision in which it is used; provided, however,

239 otherwise prohibited by this chapter.

261 to practice dentistry who by verbal claim, sign, advertisement, opening of an office, or in any other way, including use

262 of the words "dentist," "dental surgeon," the letters "D.D.S.," "D.M.D.," or other letters or titles, represents the
263 person to be a dentist or who holds himself or herself out as able to perform, or who does perform, dental services or
264 work. A person shall be regarded as practicing dentistry who is a manager, proprietor, operator or conductor of a place
265 for performing dental operations or who for a fee, salary or other reward paid, or to be paid either to himself or herself
266 or to another person, performs or advertises to perform dental operations of any kind.

267 (18) "Telehealth" means the use of information and communications technologies consisting of telephones,
268 remote patient monitoring devices or other electronic means which support clinical health care, provider consultation,
269 patient and professional health-related education, public health, health administration, and other services as described
270 in regulation: which may not require the use of technology permitting visual communication.

271 (19) "Telemedicine" means a form of telehealth which is the delivery of clinical health care services by means
272 of real time two-way audio, visual, or other telecommunications or electronic communications, including the
273 application of secure video conferencing or store and forward transfer technology to provide or support healthcare

316 (i) "Distant site" means a site at which a health care provider legally allowed to practice in the state or at

SYNOPSIS

This Act continues certain provisions in the Declaration of a State of Emergency for the State of Delaware dated March 12, 2020 due to a Public Health Threat as a result of the COVID-19 pandemic as modified related to telemedicine. The Second Modification of the State of Emergency suspended all Title 24 statutory requirements that patients present in-person before telemedicine services may be provided and the requirement that a patient must be in Delaware at the time the telemedicine services are provided; this Act continues the suspension of those requirements, but specifies that the requirement that a patient present in-person prior to the delivery of telemedicine services is excused only during the pendency of emergency conditions which make in-person presentation impractical. The Tenth Modification of the State of Emergency suspended any requirement in regulation that required both audio and visual technology; this Act prohibits any regulation pertaining to telemedicine requiring visual communication so as to permit telemedicine services via non-smart phones or land line connections.

Professions not covered by this Act include those professionals who require direct supervision by the nature of the work such as licensed associate counselors of mental health. Such professionals may engage in telemedicine and telehealth as provided by existing law.

This Act requires that telemedicine services permitted under this Act receive the same insurance coverage as under existing law.
