HOUSE SUBSTITUTE NO. 1 FOR HOUSE BILL NO. 92

AN ACT TO AMEND TITLE 14 OF THE DELAWARE CODE RELATING TO THE TERM OF SCHOOL BOARD MEMBERS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

| 1 | Section 1. Amend § 1052, Title 14 of the Delaware Code by making deletions as shown by strike through and |

| 6 | (d) Unless otherwise provided in this ehapter chapter, each school board member shall be elected for a term of $5\underline{4}$ |
| 7 | years commencing on July 1 following the member's election, except when such election is to fill an unexpired term, said |
| 8 | term commencing on July 1 following such member's election. term. |
| 9 | Section 2. Amend § 1065, Title 14 of the Delaware Code by making deletions as shown by strike through and |
| 10 | insertions as shown by underline as follows: |
| 11 | § 1065. Dissolution of school boards upon consolidation of reorganized school districts; appointments by State |
| 12 | Board of Education; members elected annually after consolidation; appointment by Governor. |
| 13 | (b) Except as provided in subsection (c) of this section, the State Board of Education shall upon consolidation |
| 14 | appoint 5 members of the previously existing school boards of the consolidating districts to the school board of the |
| 15 | consolidated district and shall designate 1 member to serve for a term of 5 years, 4 years, 3 years, 2 years, and 1 year, |
| 16 | respectively. The qualified voters of the consolidated district shall, at each annual election after consolidation, elect 1 |
| 17 | member for a term of 5_4 years who shall serve from the July 1 next succeeding that member's election and until that |
| 18 | member's successor qualifies. |
| 19 | Section 3. Amend § 1066, Title 14 of the Delaware Code by making deletions as shown by strike through and |

| 21 | § 1066. Dissolution of school board upon division of a reorganized school district; members of school board |

| 33 | Colonial School District and the Red Clay Consolidated School District. |
| 34 | (a) Notwithstanding anything contained in this chapter to the contrary, members of the school boards of the |
| 35 | Brandywine School District, the Christina School District, the Colonial School District District and the Red Clay |
| 36 | Consolidated School District shall be elected by the procedures described herein. Elections shall be conducted in |
| 37 | accordance with §§ 1071-1086 of this title; provided, however, that: |
| 38 | (2) The term of office for members of the school boards of the Brandywine School District, the Christina |
| 39 | School District, the Colonial School District and the Red Clay Consolidated School District shall be 5_4 years. All |
| 40 | terms shall end on June 30 and the terms shall be staggered so that no more than 2 terms in any school district ends on |
| 41 | any June 30. Any vacancy shall be filled for the remainder of the unexpired term in accordance with § 1054 of this |
| 42 | title. |
| 43 | Section 5. Amend § 1068, Title 14 of the Delaware Code by making deletions as shown by strike through and |

| 45 | § 1068. Indian River School Board. |
| 46 | (f) Each school board member shall be elected for a term of 5_4 years, said term to commence commencing on |
| 47 | July 1 following the school board member's election, except when such election is to fill an unexpired term, as provided in |
| 48 | this chapter, until a successor has been elected and duly qualified. |
| 49 | Section 6. Amend § 1069, Title 14 of the Delaware Code by making deletions as shown by strike through and |

| 52 | (c) School board members shall be elected in the following manner: |
| 53 | (7) Except for the shortened term of Area D for 1 year from 1997 to 1998 and Area D for 4 years from 1998 to |
| 54 | 2002, thereafter, each school board member shall be elected to a term of <u>5_4</u> years. An exception shall be when such |
| 55 | election is to fill an unexpired term as provided in this chapter, until a successor has been elected and duly qualified, |
| 56 | said term of such elected school board member to commence on July 1 following the election. |
| 57 | Section 7. This Act is applicable to the terms of members elected after December 31, 2021. |

SYNOPSIS

House Bill No. 92 reduces the term of a member elected to a school board from 5 years to 4 years for members elected after December 31, 2021.

House Substitute No. 1 for House Bill No. 92 differs from House Bill No. 92 because it clarifies that under § 1052(c) of Title 14, 2 members of a school board may be elected in the same year when the terms of both members expire the same year.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
