## DELAWARE STATE SENATE 151st GENERAL ASSEMBLY

## SENATE CONCURRENT RESOLUTION NO. 18

## RECOGNIZING MARCH 18 AS NATIONAL PUBLIC DEFENSE DAY.

1	WHEREAS, on March 18, 1963, the United States Supreme Court issued a landmark opinion in the case of
2	Gideon v. Wainwright. Clarence Earl Gideon was a Florida man convicted and incarcerated after he was refused an
3	attorney. Mr. Gideon always maintained his innocence. He was released years later after he was granted counsel by the
4	Supreme Court; and
5	WHEREAS, Gideon v. Wainwright established the 6th Amendment right to counsel for adults, even those who
6	could otherwise not afford an attorney; and
7	WHEREAS, the employees of the Office of Defense Services are tasked with the mission to zealously fight
8	injustice and abuses of power while guarding the human and Constitutional rights of the everyday citizen; and
9	WHEREAS, the employees of the Office of Defense Services are often the unsung heroes of our justice system,
10	making significant contributions to Delaware, including successfully arguing in Rauf v. Delaware, which ruled this state's
11	death penalty unconstitutional; and
12	WHEREAS, in 2015 this body passed Senate Bill 47, which established the Office of Defense Services and
13	modernized Delaware's indigent defense system; and
14	WHEREAS, the Office of Defense Services provides legal representation to any adult who cannot afford an
15	attorney and faces potential jail time, as well as to all juveniles in criminal and delinquency matters in Delaware; and
16	WHEREAS, the week of March 18 marks National Public Defense Week and the 58th anniversary of the U.S.
17	Supreme Court's landmark decision in Gideon.
18	NOW, THEREFORE:
19	BE IT RESOLVED by the Senate of the 151st General Assembly of the State of Delaware, the House of
20	Representatives concurring therein, that the legacy and importance of the Gideon decision is acknowledged, the necessity

of providing effective counsel to all accused of a crime or an act of delinquency in Delaware is recognized, and the

continuing mission of the Office of Defense Services to provide legal representation to the indigent commended.
