HOUSE OF REPRESENTATIVES 151st GENERAL ASSEMBLY

HOUSE BILL NO. 138

AN ACT TO AMEND THE CHARTER OF THE TOWN OF MILLVILLE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

1 Section 1. Amend the Charter of the Town of Millville by deleting it in its entirety and substituting in lieu thereof

- 2 as follows:
- 3 <u>Section 1.</u>
- 4 The inhabitants of The Town of Millville within the corporate limits as hereinafter defined in this Charter or as

5 extended as hereinafter provided are hereby declared to be a body politic incorporated in law and equity and shall be able

6 and capable to sue and be sued, plead and be impleaded, answer and be answered, defend and be defended in all courts of

7 judicature whatsoever by the corporate name of "The Town of Millville".

8 The Town shall have perpetual succession and shall succeed to own or possess all property, whether real, personal

9 or mixed, tangible or intangible, or whatever kind and nature, and all the powers, rights, privileges or immunities now or

10 heretofore belonging to, possessed or enjoyed by the Town of Millville previously incorporated at Chapter 217, Volume 24,

11 Laws of Delaware, as amended.

Territorial Limits

13 <u>Section 2.</u>

14 The limits and boundaries of the Town of Millville in Sussex County, Delaware, shall be as previously fixed and

15 established or hereafter altered according to law and shall be marked and defined according to maps and plots now of

16 record or hereafter recorded in the Office of the Recorder of Deeds in and for Sussex County pursuant to lawful annexation

17 proceedings. Such maps and plots, when so made and approved by Town Council, and when recorded in the Office of the

18 Recorder of Deeds of the State of Delaware in and for Sussex County, shall be deemed to be the true and correct maps and

19 plots of the Town and of all the streets, boundaries, lanes, and alleys thereof, and the same, or the record thereof, or a duly

- 20 certified copy of said record, shall be evidence in all courts of law and equity in the State of Delaware.

Annexation of Territory

22 <u>Section 3.</u>

23 In the event it becomes feasible and necessary in the future for The Town of Millville to enlarge its then existing

24 limits and territory, such annexation accomplished pursuant to the following procedures shall be lawful:

(a) At least eighty percent (80%) of property owners for the area seeking annexation of territory contiguous to the
 then existing corporate limits and territory of the Town of Millville, by written Petition with the signature of each such
 Petitioner duly acknowledged, shall request the Town Council to annex that certain territory in which they own property.
 However, for a Petition seeking annexation of an existing residential subdivision, at least eighty percent (80%) of the
 property owners of the lots of record, rather than the area, shall so request.

30 (b) The Petition shall include a description of the territory requested to be annexed, a current survey, and the 31 reasons for the requested annexation. If the Petition is requesting a higher density than an R – Residential zoning, a concept 32 plan is required. Further, the applicant or applicants shall notify all residents within 200 feet of any boundary of the 33 territory for which the applicant is seeking annexation at the applicant's expense and provide copies of such notification to 34 the Town Manager or designee.

35 (c) The Town Manager or designee having verified the notifications, the Mayor of the Town of Millville shall 36 appoint a three (3) member Annexation Committee to investigate the possibility of annexation and report back to the Town 37 Council in no more than ninety (90) days, unless evidence is presented that indicates due cause, including misinformation 38 or possible criminal intent. In that case, the Town Council may extend the reporting time for a fixed period to fully 39 investigate the allegation(s). Prior to beginning work on the report, the members of the Annexation Committee will have 40 been voted upon and approved by a majority of the Town Council. The Annexation Committee shall consist of two (2) 41 members of the current Town Council and one (1) member of the current Planning and Zoning Commission, none of whose 42 terms shall be set to expire for the expected duration of the business for which the Annexation Committee shall have been 43 appointed. 44 (d) Upon the majority vote of the Town Council approving each appointee to the Annexation Committee, the 45 Committee is to begin work immediately to prepare a written report of its findings within ninety (90) days, unless this 46 period is extended for due cause.

47 (e) The report by the Annexation Committee will consider the positive and negative impacts on the capacities and

48 qualities of the Town of Millville's town systems and services, the impact on Millville taxpayers, and other elements as

- 49 determined by the Town Council in consultation with the Town Manager or designee. By a 2/3rds vote approval by the
- 50 Town Council of the members present and voting, the Town Council will also determine if a cost/benefit analysis is to be
- 51 prepared so as to further identify the advantages and disadvantages to the Town of Millville with regard to the annexation.
- 52 The Annexation Committee may utilize the staff of the Town of Millville to assist in the conduct of its investigation and

53 report as to the annexation advantages and disadvantages. The report will include a listing of the advantages and 54 disadvantages of the Petition, with the interest of the Town of Millville being the sole concern of the Annexation

55 Committee. All meetings of the Annexation Committee shall comply with the Delaware Freedom of Information Act.

56 (f) Upon receipt of the report, the Town Council will vote to accept the report, reject the report, or refer it to the 57 Annexation Committee to accommodate new information. If referred to the Annexation Committee, the report must be 58 resubmitted to the Town Council by the Annexation Committee at its next regularly scheduled meeting and a vote must then be taken. If referred to the Annexation Committee, the Town Council must first vote to extend the due date of the 59 60 report to the next regularly scheduled meeting. If the report to the Town Council on the annexation determines that the 61 proposed annexation is advantageous overall to the Town of Millville, the Town Council shall vote on the recommendation. 62 If the Town Council accepts the report the Petition shall be referred to the Planning and Zoning Commission. Referral of 63 the annexation petition requires a simple majority vote of the members of Town Council present and voting. If the Town 64 Council reject the report, refer to subsection (g) of this Section.

65 (g) In the event that the Annexation Committee concludes that the proposed annexation is disadvantageous overall 66 to the Town of Millville, or if the Town Council rejects a report from the Annexation Committee that determined the 67 proposed annexation is advantageous to the Town, the applicant(s) for annexation must wait 365 days from the date of the 68 presentation to the Town Council by the Annexation Committee before again petitioning the Town Council. Each and all

69 the procedures pertaining to annexation, as provided in this Section, are again applicable and shall be repeated.

(h) Upon receipt of the Town Council's referral of the annexation petition to the Planning and Zoning Commission, said Commission shall consider and discuss the annexation request at its next duly noticed meeting and shall review the petition and concept plan (if required), including the zoning classification(s) requested by the petitioner. After not more than sixty (60) days the Planning and Zoning Commission shall make its recommendation on zoning classification[s] and transmit its recommendation(s) and comments on the petition and the concept plan (if required), in writing, back to the Town Council.

(i) At its next duly noticed meeting, following the Town Council's receipt of Planning and Zoning's report on the annexation request, concept plan (if required), and recommendation(s) for the zoning classifications, the Town Council shall schedule a public hearing on the petition, such hearing to be held not more than thirty (30) days after its next scheduled meeting. Following the public hearing, the Town Council shall, within thirty (30) days, exercise one of the following options: (1) take a final vote on whether or not to approve the annexation request, in which case the vote to annex must pass by the affirmative vote of two-thirds (2/3) of all the members of the Town Council present and voting; or (2) vote

82 by simple majority of the members present and voting, to hold a Town of Millville town-wide referendum on the petition.

83 The Town Council may add conditions to the terms of annexation, by simple majority vote of members present and voting,

84 prior to its final vote on the petition. If the Town Council votes to accept the petition, implementation of this decision must

85 wait thirty (30) days, during which time the citizenry of Millville may file a petition with the Town Manager or designee

86 requesting that a special referendum be held on the Town Council's decision to annex. This petition must include over 10%

87 of Millville's registered voters able to vote in a referendum, and the referendum shall be held within sixty (60 days

- 88 following the filing of the petition for referendum with the Millville Town Manager or designee.
- 89 (j) If a referendum on the annexation petition is to be held, the Town Council shall instruct the Town Manager or

90 designee of Millville to schedule a special referendum on the annexation petition. If the Town Council votes in favor of a

90 designee of Millville to schedule a special referendum on the annexation petition. If the Town Council votes in favor of a

91 referendum, the Town Council will order that a public referendum vote be scheduled no later than sixty (60) days

92 thereafter, and that a Resolution for annexation must be passed by a majority vote of the citizens of the Town of Millville

- 93 who voted, and results of the referendum vote will be binding.
- 94 (k) At this and all special Referenda, every non-resident property owner, whether an individual, partnership,

95 corporation or other artificial entity, in The Town of Millville shall have one (1) vote. Non-resident property owners whose

96 property is exempt from taxation or is not assessed for taxation shall not be entitled to vote. Every resident citizen of The

97 Town of Millville over the age of eighteen (18) years whether a property owner(s) or not shall have one (1) vote. The books

and records of The Town of Millville in the case of non-resident property owners, and a copy of the required personal

99 identification in the case of resident citizens of the Town, shall be conclusive evidence of the right of such property owners

100 and citizens to vote at the special referendum. The Board of Election of the Town of Millville shall supervise any special

101 <u>referenda.</u>

(1) The notice of the time and place of the special referendum shall be printed, within fifteen (15) days
 immediately following the vote or petition to hold a referendum, in at least one (1) newspaper having a general circulation
 in the Town of Millville, and posted in four (4) public places, including the Town bulletin board and posted on the Town of

105 <u>Millville website, at least fifteen (15) days prior to the date set for the special referendum.</u>

106 (m) Following the thirty (30) day hold period to accommodate the filing of a petition, if no petition is filed, and if 107 a favorable vote for annexation shall have been cast, the Town Council shall cause a description and a plot of the territory

so annexed to be recorded in the Office of the Recorder of Deeds, in and for Sussex County, but in no event shall said

109 recordation be completed more than one-hundred twenty (120) days following the date of the favorable Town Council vote

- 110 or the special referendum vote. The territory for annexation shall be considered to be a part of The Town of Millville from
- 111 the time of recordation. The failure to record the description or the plot within the specified time will cause the annexation
- 112 petition to be tabled before the Town Council. Failure to achieve recordation in the one-hundred twenty (120) day period

113	requires the Town Council to vote again on the annexation petition, whether or not the Town Council, or qualified voters of
114	Millville in a referendum, have voted on the annexation petition.
115	(n) All territories proposed to be annexed including those territories exempt from taxation, or which are not
116	assessed on the books on the Board of Assessment of Sussex County, shall also be required to follow all the processes and
117	procedures required for annexation under this Section. The Town Council and the Millville Planning and Zoning
118	Commission must proceed in the same manner as required of any annexation petition.
119	Structure of Government
120	Section 4.
121	The government of The Town and the exercise of all powers conferred by this Charter, except as otherwise
122	provided herein, shall be vested in the Town Council. The Town Council shall be composed of five (5) members, each of
123	whose terms shall be for a period of two (2) years, commencing at the Annual Meeting of the Town Council following his
124	or her election and continuing until his or her successor is duly elected and qualified. One of the members of the Town
125	Council shall be elected Mayor of the Town Council, pursuant to Section 8(b) of this Charter, and upon his or her election
126	shall have the title of Mayor of The Town of Millville and shall perform all duties prescribed herein to be performed by the
127	Mayor of The Town of Millville.

143 At a minimum, Title 15 of the Delaware Code shall be followed where applicable. However, certain items in this 144 Section exceed those requirements and are to be followed. Each candidate for Town Council member shall be nominated as 145 follows: 146 (a) Each candidate shall notify the Town Manager or designee in writing of his or her candidacy for the office of 147 Town Council member. At that time, the candidate shall fill out and file with the Town Manager or designee, the Ethics 148 Form in Appendix B of this Charter. 149 (b) All such notifications of candidacy, consent to the required background check, and the completed Ethics Form, 150 along with the Certificate of Intention or a Statement of Organization, must be filed with the Town Manager or designee 151 during the regular business hours of the Town on or before the close of business on the first Friday in the month of 152 February; and thereupon it shall be the duty of the Town Manager or designee to have a list of all candidates so filed printed 153 in at least one (1) newspaper of general circulation in the Town of Millville at least fifteen (15) days prior to the date of the 154 said Annual Municipal Election next ensuing; and, in the discretion of the Town Council, the Secretary may post a list of 155 names of all candidates designating the office sought by each candidate in at least five (5) public places in the Town and on 156 the Millville Town website. One of the public places shall be in or outside the Town Hall of the Town of Millville. 157 (c) The Town Manager or designee shall submit the names of candidates for each office up for election to the 158 Sussex County Department of Elections no later than one (1) business day following the deadlines for the elected positions. 159 Manner of Holding Annual Municipal Election 160 Section 7. 161 The procedure for holding the Annual Municipal Election shall be as follows: 162 (a) The Annual Municipal Election shall be held at a place designated by the Town Council within the corporate 163 limits of The Town of Millville on the First Saturday in March of each and every year from eleven (11:00) o'clock in the 164 morning, prevailing time, until 8:00 p.m., prevailing time. 165 (b) The Town Manager or designee shall make arrangements with the Sussex County Department of Elections for 166 voting machines to be placed in the polling place prior to the time set forth in this Charter for the beginning of the Annual 167 Municipal Election. 168 (c) Three Council members will be elected in odd numbered years and two in even numbered years. 169 (d) The Annual Municipal Election shall be conducted by a Board of Election consisting of an Inspector and two (2) Judges appointed by the Mayor of the Town of Millville with the concurrence of a majority of the members of the Town 170 171 Council present and voting not later than the last regular meeting of the Town Council prior to the date of the Annual 172 Municipal Election. Alternate Inspectors and Judges shall also be appointed with such concurrence. The Board of Election

- 173 shall determine who is and who is not lawfully entitled to vote thereat, take reasonable steps to see that the law pertaining
- 174 to the Annual Municipal Election receives compliance and for the purpose of counting the votes and certifying the result to
- 175 the Town Council. The Board of Election shall keep a list of all persons who voted at such Annual Municipal Election.
- 176 (e) At such Annual Municipal Election, every person, male or female, who shall have attained the age of eighteen
- 177 (18) years on the date of the said Annual Municipal Election and who shall be a bona fide resident of the Town of Millville
- 178 <u>shall have one (1) vote.</u>
- 179 (f) The Town Council may provide for any qualified voter to cast an absentee ballot.
- 180 (g) In the event that no person files or is nominated for office for which an election is to be held within the time set
- 181 forth in Section 6 of this Charter, the incumbent shall be deemed to be reelected for a full term and it shall not be necessary
- 182 <u>to have an election.</u>
- (h) In the event that only one person files or who is nominated for office for which an election is to be held within
 the time set forth in Section 6 of this Charter, the person who files or is nominated shall be deemed to be elected for a full
- 185 term and it shall not be necessary to have an election.

Organization and Annual Meeting Of Council

187 <u>Section 8.</u>

188 (a) Before entering upon the duties of their respective offices, the Council members elect shall be sworn by a

189 Notary Public. At the first regular meeting following the Organizational Municipal Election, "the Annual Meeting", the

190 Town Council shall meet at the Council Chamber and the newly elected officers shall assume the duties of office, being

191 <u>first duly sworn or affirmed to perform their duties with fidelity, as aforesaid.</u>

192 (b) At the Organizational Meeting held on the first regular meeting following the Annual Municipal Election, the

193 Town Council shall organize and elect a Mayor and a Deputy Mayor who shall hold office for the term of 1 year or until

- 194 their respective successors shall be duly qualified and elected. The person elected as Presiding Officer of the Town Council
- 195 shall have the title of Mayor of The Town of Millville. The Town Council shall likewise elect a Secretary and a Treasurer
- 196 from its own number to serve until the first regular meeting after the next Annual Municipal Election. The Town Council
- 197 may also elect an Assistant Secretary and an Assistant Treasurer to serve until the first regular meeting following the next
- 198 Annual Municipal Election who may or may not be from among their own number and such other officers and employees
- 199 <u>as may be determined to be necessary.</u>
- 200

Regular and Special Meetings

201 <u>Section 9.</u>

202 (a) Regular Meetings. The Town Council shall meet regularly during the year. The time and place of each regular 203 meeting shall be set by Council each year at their organizational meeting, but Council shall not hereby be prohibited from 204 rescheduling such meetings from time to time during the year as need arises. 205 (b) Special Meeting; Waiver of Notice. Special meetings shall be called by the Town Manager upon the written 206 request of the Mayor, or upon the written request of any 4 members of Council, stating the day, hour and place of the 207 special meeting requested and the subject or subjects proposed to be considered thereat. Such notice must be deposited in 208 the U.S. mail in the main post office in the Town at least 96 hours prior to the time set for such special meeting, provided, 209 however, that a waiver of such notice, (written, telegraphic, or recorded telephonic message) by all members of Council 210 prior to or immediately upon the convening of such special meeting shall make the 96-hour written notice unnecessary and 211 shall authorize and make valid the holding of a special meeting at any time and for any purpose named in such waiver, or 212 the transaction of any other business at the meeting, if the waiver so states. Subject to the scope of the notice, the Town 213 Council of the Town shall have the same power and authority to enact all ordinances, adopt all resolutions, pass all 214 motions, make all orders and transact all business at any such special meeting, called as aforesaid, as Council has at a 215 regular meeting. 216 Quorum 217 Section 10. 218 A majority of the members elected to The Town Council shall constitute a quorum at any regular or special 219 meeting regardless of any abstentions; but a lesser number may adjourn from time to time and may compel the attendance 220 of absent members in such manner and under such penalties as may be prescribed by Ordinance. 221 **Rules and Minutes of Council, Commissions, and Boards** 222 Section 11. 223 (a) Town Council, Commissions and Boards shall follow the Millville Town Council Policies and Procedures 224 Manual incorporated by reference herein, as may be amended. Minutes of all public Council, Commission and Board 225 meetings shall be recorded and transcribed by the Town Clerk or designee in electronic format and hard copy. Minutes shall 226 include who of the voting body specifically votes for and against a motion during meetings. Minutes of aforesaid meetings 227 shall be kept at Town Hall and published on the Town's website within a reasonable amount of time. Minutes of all 228 meetings shall be reviewed and approved at the next scheduled meeting or as soon thereafter as possible. 229 (b) In addition to other acts required by law or by specific provisions of this Charter to be done by ordinance, those 230 acts of the Town Council shall be by ordinance which:

231	(1) Adopt or amend an administrative code or establish, or abolish any town department, office, commission,
232	board, agency, or position;
233	(2) Provide for a fine or other penalty or establish a rule or regulation for violation of which a fine or other penalty
234	is imposed;
235	(3) Grant, renew or extend a franchise;
236	(4) Amend or repeal any ordinances previously adopted.
237	(c) Acts other than those referred to in the preceding may be done either by ordinance or by resolution. Every
238	ordinance and resolution shall be introduced in writing. Vote on any ordinance or resolution may be by voice vote and the
239	vote of each Council member on any ordinance shall be entered on the record. No ordinance or resolution shall be passed
240	unless it shall have the affirmative vote of a majority of the members present and voting thereon, unless a supermajority is
241	otherwise required.
242	Vacancies
243	Section 12.
244	If any vacancy shall occur in the office of Council member by death, resignation, loss of residence in The Town of
245	Millville, refusal to serve, or otherwise, the same may be filled by a majority vote of the remaining members of the Town
246	Council. The person or persons so chosen to fill such vacancy shall be qualified only after completing the Ethics Form in
247	Appendix B of this Charter and shall hold office until the end of fixed term of the vacated Town Council seat. Any person
248	appointed to a vacancy must meet the requirements as stated in Section 5 of this Charter.
249	Disqualifications, Forfeiture, and Censure
250	Section 13.
251	(a) If any Council member, during his or her term of office, shall be found guilty of any crime or misdemeanor and
252	sentenced to imprisonment for any term whatever or shall for any reason cease to be a resident of the Town, he or she shall
253	forthwith be disqualified to act as a member of Council and his or her office shall be deemed vacant and shall be filled by
254	the Town Council, as aforesaid.
255	(b) Forfeiture Proceedings. A forfeiture of his or her office shall occur when that Council member:
256	(1) lacks, at any time during his or her term of office, any qualification for the office prescribed by this Charter or
257	by law;
258	(2) willfully violates any express prohibition of this Charter;
259	(3) is convicted of a felony; or
260	(4) fails to attend 3 regular Council meetings without being excused by Council.

261	(c) Determination Concerning Forfeiture. Where the conditions set forth in Section 13(b)(3) or (4) occur, forfeiture
262	shall be automatic. Where the conditions set forth in Section 13(b)(1) or (2) are alleged to have occurred, a determination
263	concerning such alleged forfeiture shall be made by the Council, but the affected party shall not have a vote in any such
264	decision. Such deliberations may be had in executive session and if the Council determines by a unanimous vote of the

356	(a) The Secretary shall be selected from members of the Town Council for a one-year term.

359	the following meeting or as soon thereafter as possible.
360	(c) The Secretary shall sign all resolutions and ordinances once adopted by Town Council.

363	(a) The Treasurer shall be responsible for reviewing all vouchers and bills scheduled for payment and shall be the
364	second signatory on all checks.
365	(b) In addition to any other duties prescribed by Town Council, the Treasurer will meet with the Finance Director
366	and/or Town Manager to discuss and review the fiscal year budget prior to said budget being submitted to the Town
367	Council for action.
368	(c) The Treasurer shall review said budget with the Finance Director and/or Town Manager periodically during the
369	year to discuss any financial issues that may arise during the year.

372	(a) Town Council members, Planning and Zoning Commission members, and Board of Adjustment members may
373	be paid for their services any sum which may be agreed upon by the members of the Town Council as may be prescribed by

380	(a) The Town Council may appoint a Town Manager who shall be the Chief Administrative Officer of the Town.

- 381 (b) The Town Council shall impose such qualifications for Town Manager as may be deemed necessary; provided,
- 382 however, that no person holding the office of Town Council shall be chosen to be Town Manager during his or her term of
- 383 office as Council member, except pursuant to subsection (d) of this Section.
- 384 (c) The Town Manager shall hold office for a definite term and may be removed by a majority vote of the Town
- 385 <u>Council of the Town of Millville, pursuant to the terms of the Town Manager's employment contract. At least thirty (30)</u>
- 386 <u>days before such removal shall become effective, the Town Council shall, by a majority vote of all the elected members</u>

- 397 which the acting Town Manager shall receive for the performance of duties shall be fixed by the Town Council.
- (e) The Town Manager shall be responsible to the Town Council of Millville for the proper administration of the
 affairs of the Town placed in his or her charge and to that end, he or she shall have the power to make such appointment
 and to hire such employees at such compensations as the Town Council, by Resolution, shall determine, subject to such
- 401 rules and regulations as may be adopted by the Town Council. All employees shall be hired for an indefinite term and may
- 402 be removed by the Town Manager at any time unless otherwise provided by resolution of Council. He or she shall exercise
- 403 his or her sole discretion in the appointment or hiring of any such employees. The Town Manager shall be the sole judge of

- 414 (g) It shall be the duty of the Town Manager to supervise the administration of the affairs of the Town under his or

442	any such predecessor or predecessors with respect to any matter or thing pertaining to said office had been taken or
443	performed by the successor to such office.
444	(n) Upon the death, resignation, or removal from office of the Town Manager, the Town Council shall appoint
445	some suitable person, who may be an elected or appointed official of the Town of Millville, to perform the duties of the
446	Town Manager; provided, however, such person shall not serve for a period exceeding ninety (90) days from the date of his
447	or her appointment.

449	Section 20.
450	The Town Council shall select and appoint a Town Solicitor for an indefinite term who shall be removable at the
451	pleasure of the Town Council of The Town of Millville either with or without due cause stated. The Town Solicitor shall be
452	a member in good standing of the Bar of the State of Delaware. It shall be his or her duty to give legal advice to the Town
453	Council, and all Boards and Commissions as required, and to perform other legal services as may be required by the Town
454	Council, or the Town Manager or designee.
455	Board of Health
456	Section 21.
457	(a) The Town Council may appoint a Board of Health that shall operate in compliance with the Delaware Code. If
458	it is established, such Board shall consist of no fewer than three (3) nor more than five (5) members, at least one (1) of
459	whom shall be a physician authorized to practice medicine in the State of Delaware. Members of the Board of Health shall
460	serve for three (3) years or until their successors are duly appointed and qualified. Members of the Board of Health shall
461	have their primary residence - or in the case of a medical or scientific professional, the site of their professional practice -
462	within the town limits of the Town of Millville. The Board shall be appointed by the Mayor with the advice and consent of
463	a majority of the elected members of the Town Council. The Board of Health shall have cognizance of and interest in the
464	life and health of the people of the Town, including oversight of air, water and land quality, and shall inform the Town
465	Council, Town Manager or designee, of necessary measures to be taken to protect public health. The Board shall report to
466	the Town Council in writing whatever is deemed by the Board to be potentially injurious to the health of the people of the
467	Town and shall make recommendations to the Town Council concerning whatever may contribute to the health and
468	
100	sanitation of the citizens of The Town of Millville. The Board shall organize by the election of a Chairman and Secretary
469	sanitation of the citizens of The Town of Millville. The Board shall organize by the election of a Chairman and Secretary within ten (10) days after notice of their appointment and shall keep a record of their proceedings and acts. The Chairperson

471	(b) The Board of Health may make recommendations to the Town Council regarding the adoption of ordinances
472	relating to the health of the population of the Town or to prevent the introduction or spread of infectious or contagious
473	diseases or nuisances, or to mitigate against environmental contamination, affecting the same and such ordinances, when
474	adopted by the Town Council, shall extend to an area outside the Town limits for a distance of one (1) mile.
475	Police Force
476	Section 22.
477	(a) The Town Council may, from time to time, make such rules and regulations as may be necessary for the
478	organization, government and control of the police force. The police force, if created, shall preserve peace and order and
479	shall compel obedience within the Town limits to the Ordinances of the Town and the laws of the State of Delaware. The
480	Town Council may appoint a Chief of Police to recommend and hire policing staff with the Town Council approval. The
481	police force, under the direction of the Chief of Police, shall have such other duties as the Town Council shall prescribe.
482	The Chief of Police shall be subject to the direction of the Mayor and Town Manager acting on behalf of the Town Council.
483	The Chief of Police shall be charged with the establishment of Standard Operating procedures (SOP) for the Millville
484	Police Department.
485	(b) Each member of the police force shall have police powers as designated in the Delaware Code and shall be
486	conservators of the peace throughout The Town of Millville. They shall suppress all acts of violence and enforce all laws
487	relating to the safety of persons and property. They shall enforce all laws and ordinances enacted by the Town Council and
488	all criminal and motor vehicle laws enacted by the State of Delaware. In the case of a pursuit of an offender, the power and
489	authority of the police force shall extend outside the territorial limitations of The Town of Millville.
490	(c) Every person sentenced to imprisonment by a court of competent jurisdiction shall be delivered by a member
491	of the police force to the designated correctional institution to be there imprisoned for the term of his or her sentence.
492	<u>Annual Audit</u>
493	Section 23.
494	The Mayor, with the advice and consent of a majority of the elected members of the Town Council, shall retain the
495	services of a Delaware licensed Certified Public Accountant or accounting firm to examine the financial statements and
496	accounts of the Town. The selected accountant or accounting firm shall audit the accounts of the Town. The auditor shall
497	on or before the expiration of one hundred and twenty (120) days from the end of the fiscal year annually make and deliver
498	to the Town Council and Town Manager or designee a detailed report of any and all accounts, records, and books examined
499	and audited. Such report under his or her hand and seal and the executive summary if its findings shall be made available at

500 Town Hall. A notice of availability shall be published in at least one (1) newspaper having a general circulation in the 501 Town. The auditor-shall have access to all records and accounts of the Town. 502 **Board of Assessment** 503 Section 24. 504 (a) In the event the Town creates a Board of Assessment, the Board of Assessment shall be appointed by the 505 Mayor, with the advice and consent of a majority of the elected members of the Town Council for an indefinite term. The 506 Board of Assessment shall consist of three (3) members, all of whom shall be over the age of twenty-one (21) years, bona 507 fide residents of The Town of Millville and property owners of the Town. 508 (b) Members of the Board of Assessment shall be sworn or affirmed by the Mayor of The Town of Millville or by 509 a Notary Public to perform their duties with fidelity and without favor or bias. It shall be their duty to make a fair and 510 impartial assessment of property and persons subject to taxation situated within the corporate limits of the Town and to 511 perform such other duties and reference thereto as shall be prescribed by the Town Council. Compensation is to be by them 512 received for the performance of their duties in the hiring of employees to assist them in the performance of their duties shall 513 be fixed by and subject to the approval of the Town Council of The Town of Millville. 514 (c) In making such assessment, the rules and exemptions now applicable by law to the making of the assessment 515 for Sussex County of persons and property shall be applicable insofar as consistent with the provisions of this Charter. 516 (d) Adoption of Sussex County 100% land and improvement values (Values). The Town Council may elect to use 517 the 100% land and improvement values by the Sussex County Board of Assessment for all property located within the 518 corporate limits of the Town in lieu of making its own independent valuation and assessment of such property. In such 519 event, the 100% land and improvement values established by Sussex County shall be conclusive for purposes of levying 520 town taxes, and the Town Council shall have no authority to hear appeals regarding the same. If the Town Council elects to 521 adopt the Sussex County Values, only this section and Subsection (e) shall have effect; the Town Council has the authority 522 to consider appeals concerning any additions to tax bills under Subsection (e) at any regular or special meeting. 523 (e) Additions to Tax Bills. Whether utilizing the Sussex County Values or those prepared by the Town's own 524 Board of Assessment, the Town Council shall annually, prior to the posting of the assessment list, by resolution, provide for 525 the Mayor a list of any and all charges, costs or other assessments owed to the Town, which list of charges incurred shall 526 include, but not be limited to, the following: water bond sinking funds assessments, curb and gutter assessments, water 527 assessments, weed and grass cutting bills, trash collection bills, and past due water rents. Said amounts, when adopted and 528 set forth by resolution of the Mayor and Council, shall be shown on the copies of the assessments posted pursuant to the 529 provisions of Section 25 of this Chapter.

Assessment of Taxes

531	Section 25.
532	The Board of Assessment shall, within ninety (90) days prior to the beginning of the next fiscal year, make a just,
533	true and impartial annual valuation or assessment of all real estate and improvements located thereon within The Town of
534	Millville. All real estate shall be described with sufficient particularity to be identified. Real estate shall be assessed to the
535	owner(s) if they be known. If the owner(s) of real estate cannot be found or ascertained, it may be assessed to "Owner
536	Unknown." A mistake in the name of the owner(s) or a wrong name or an assessment to "Owner Unknown," shall not affect
537	the validity of the assessment of any municipal tax or assessment based thereon; Provided, however, the assessment shall
538	specify the last record owner or owners thereof as the same shall appear from the records in the Office of the Recorder of
539	Deeds, in and for Sussex County. The Board of Assessment may also make a personal assessment of all citizens of the
540	Town above the age of Eighteen (18) years, whether an owner of real estate or not; said personal assessment shall be
541	determined by the Town Council and certified to the Board of Assessment. Said personal assessment shall be in addition to
542	the assessment levied on real estate owned or assessed by any person or persons whomsoever.
543	(a) The Board of Assessment, after making such annual assessment, shall, at least ninety (90) days prior to the end
544	of the fiscal year, deliver to the Town Council of The Town of Millville a list containing the names of all persons assessed
545	and the amount of assessment against each. They shall also deliver at such time as many copies of said list as the Town
546	Council shall direct.
547	(b) The annual assessment shall distinguish the real and personal assessment of each person and shall also be
548	arranged so that the land, the improvements thereon, and the per capita assessment shall appear in separate columns or
549	spaces. In making this assessment, the Board shall make its valuation accordingly.
550	(c) The real property of the several members of the Board of Assessment shall be assessed by the Town Council of
551	The Town of Millville.
552	(d) Immediately upon receiving the annual assessment list from the Board of Assessment, the Town Council of
553	The Town of Millville shall cause a full and complete copy of the same, containing the amount assessed to each taxable to
554	be hung in a public place in The Town of Millville and there it shall remain for a period of at least ten (10) days for the
555	information of and examination by all concerned. Appended thereto and also in five (5) or more public places in said Town
556	shall be posted notices advertising to all concerned that, upon a certain day mentioned therein and not earlier than ten (10)
557	days after the date of posting of the true and correct copy of the annual assessment list and notices that, at the next regular
558	meeting of the Town Council, the Town Council will hold a court of appeals at which time and place they shall hear
559	appeals from the said annual assessment. The decision of the Town Council sitting as the Board of Appeals shall be final

560	and conclusive and said Town Council shall revise and complete said assessment at this sitting. No member of the Town
561	Council shall sit upon his or her own appeal but the same shall be heard and determined by the other councilmen.
562	(e) All the members of the Board of Assessment shall be present on the day fixed for hearing appeals and shall
563	furnish to the Town Council such information and answer such questions as the Town Council may require in respect to
564	any assessment for which an appeal has been taken. The Town Council shall have the authority to enforce the attendance of
565	the Board of Assessment by appropriate process.
566	Supplemental Assessment
567	Section 26.
568	(a) In addition to the annual assessment provided for in Section 25 of this Charter, the Board of Assessment may,
569	at its option, prepare a monthly supplemental assessment list for any of the following purposes:
570	(1) Adding property which was not included on the first annual assessment;
571	(2) Increasing or decreasing the assessed value of property which was included in the last assessment;
572	(3) Correcting errors on the prior annual assessment;
573	(4) Revising or modifying any exception from taxation applicable to property within the Town; or
574	(5) Due to improvement to property.
575	(b) The supplemental assessment list shall be prepared monthly by the Board of Assessment.
576	(c) On the date of certification of the supplemental assessment list of the Town Council by the Board of
577	Assessment each property owner shall be liable for the payment of prorated real estate taxes equal to the assessed value of
578	the property multiplied by the tax rate for the then current fiscal year applicable to the property and the amount of such tax,
579	together with any interest, penalty and collection charge shall be a lien for a period of ten (10) years and such lien shall
580	have preference and priority to all other created liens on real estate or upon improvements located on land under lease as
581	prescribed in the Charter or suffered by said property owner although such lien or liens be of a date prior to the time of the
582	attaching of such lien for taxes.
583	(d) Whenever the Board of Assessment places a property on a supplemental assessment list, they shall deposit
584	notice thereof in the regular mail addressed to the owner of the property affected thereby at the address shown on the
585	assessment list, or if the address of such owner does not appear on the assessment list, then to the person occupying the
586	property, or if there is no apparent occupant, such notice shall be posted on the property. Such notice shall be given no later
587	than the date on which the supplemental list on which the property appears is certified to the Town Council by the Board of
588	Assessment. The certification by the Board of Assessment that the notice required by this Subsection was mailed or posted,
589	as the case may be, shall be conclusive evidence that notice to the property owner was received.

590 (e) The Board of Assessment may publish a notice of the place or places where the supplemental assessment list 591 may be inspected together with a notice of the time and place in the Town when the Town Council, not earlier than ten (10) 592 days from the date of the last publication, shall sit, between the hours of one o'clock in the afternoon, prevailing time and 593 five o'clock in the afternoon, prevailing time, to hear appeals. Such notice shall appear at least once a week for two (2) 594 consecutive weeks in a newspaper of general circulation in the Town. The decision of the Town Council sitting as a Board 595 of Appeals, shall be final and conclusive and the said Town Council shall revise and complete the said supplemental 596 assessment at this sitting. Neither the Mayor nor any member of the Town Council shall sit upon his or her appeal but the 597 same shall be held and determined by the other members of the Town Council. 598 (f) Pending determination of the appeal, the property owner may either pay the tax imposed by the supplemental 599 assessment and if on appeal the assessment is reduced, the property owner shall be entitled to a refund of the taxes which he 600 has overpaid plus interest thereon at the rate of one percent (1%) per month for each month or fraction thereof from the date 601 of payment or the property owner may decline to pay the tax imposed by the supplemental assessment in which case, 602 interest and penalties shall accrue at the rate of one percent (1%) per month for each month or fraction thereof that the taxes 603 remain unpaid from the expiration of thirty (30) days following the date of mailing or the posting of the notice, as the case 604 may be, required by this Section. 605 (g) All taxes imposed by the supplemental assessment list paid more than thirty (30) days following the date that 606 notice is mailed by the Board of Assessment to the property owner as provided for in this Section shall be delinquent. 607 **Taxation of Real Estate Transfers** 608 Section 27. 609 (a) The Town Council of the Town of Millville, in addition to all other powers conferred upon it by this Act, shall 610 have the power and authority by ordinance or ordinances to levy, assess and collect or provide for the levying, assessment 611 and collection of such taxes as shall be determined by the Town Council to be paid by the transferor or transferee upon the 612 transfer of real property or any interest in real property situate within the corporate limits of the Town of Millville, 613 regardless of where the instruments making the transfers are made, executed or delivered or where the actual settlements on 614 such transfers occur; provided however, that no tax shall be levied upon an organization exempted from ad valorem real 615 estate taxes. No tax shall be imposed on conveyances when the actual value of the property being transferred is less than 616 \$100. 617 (b) If the taxing power authority granted under this Section shall be exercised by way of a stamp affixed to a 618 document presented for recording, the Recorder of Deeds, in and for Sussex County, shall not receive for record any 619 document subject to such tax unless such stamps are affixed thereto.

620	(c) The Town Council of the Town of Millville may adopt an ordinance or ordinances to provide for the effective
621	administration and regulation of any tax adopted pursuant to the provisions of this Section.
622	(d) No tax levied under this Section shall exceed one and one-half percent (1 ½%) of the sale price (including the
623	value of any assumed mortgage or mortgages) or of the fair market value of the real property so transferred; and provided
624	however, that no tax shall be imposed upon an organization which is exempted from ad valorem taxes. The provisions of
625	Section 5401 and Section 5403, Chapter 54, Title 30, Del. C., shall be applicable to any realty transfer tax imposed pursuant
626	to this Act.
627	(e) The Town Council may provide by Ordinance for the collection of such tax by the Recorder of Deeds, in and
628	for Sussex County, or such other agent as may be appointed by the Town Council and shall prescribe in such Ordinance the
629	charge that will be paid for such collection of such realty transfer tax authorized by this Section.
630	Levy of Annual Taxes and Other Revenue
631	Section 28.
632	(a) The Town Council, having revised and completed the assessment, shall determine, in its best judgment and
633	knowledge, the total amount necessary to be raised by the Town to meet the fixed and anticipated expenses and obligations
634	of the Town. Such amounts may include reasonable and appropriate reserves, for the next fiscal year as set forth in the
635	Town Budget for such year and may include a reasonable amount to cover unanticipated expenses, emergencies, and long-
636	term capital improvements and replacements.
637	(b) The Town Council should then proceed to determine, in consultation with the Town Manager or designee,
638	from which sources of the authorized revenues of the Town the amount so determined by them shall be raised and, within
639	the limits prescribed by this Charter with respect to any such source, the amount to be raised from each such source. They
640	shall then proceed to determine, assess, fix and/or levy as follows:
641	(1) The rate of tax on real estate including improvements thereon per One Hundred Dollars (\$100.00) of the
642	assessed value or Sussex County's 100% land and improvement values; and/or
643	(2) The rate of tax upon all poles, construction, erections, wires and appliances more particularly mentioned, or
644	intended so to be in Section 30 of this Charter as amended; and/or
645	(3) The several license fees to be charged for carrying on or conducting of the several businesses, professions or
646	occupations more particularly mentioned or intended so to be in this Charter, as amended; and/or
647	(4) The several rates to be charged for furnishing water service, sewer service, electric service, gas service, front
648	footage assessment; and/or

- 649 (5) The fees or rates to be charged in respect to any other authorized source of revenue sufficient to their judgment
- and estimation to realize the amount necessary, provided however, that in the case of sources (3), (4), and (5) assess, levy,
- alter, or change upon other than a fiscal year basis and that any meeting of the Town Council as the Town Council, in its
- 652 own proper discretion, shall determine.
- 653 (c) After the day fixed for hearing tax appeals of each and every year, the Town Council shall make, or cause to be
- 654 made, a full, true and correct Annual Tax List showing the amount of tax levied against each taxable entity thereon from all
- 655 sources above mentioned. This list shall be known as the Annual Tax List of The Town of Millville. In addition to the
- 656 information contained in the annual valuation or assessment list, it shall also contain information as to the rate of tax upon
- 657 real estate for each One Hundred Dollars (\$100.00) of assessed valuation thereof.
- 658 (d) Nothing contained in this Charter shall be construed to affect or impair in any way the validity of any tax, fee,
- assessment or other charge lawfully levied, assessed or due the Town under existing laws in reference to said Town and the
- 660 same are hereby declared to be valid, binding and vested in the Town.
- 661

Collection of Annual Taxes and Other Revenues

662 <u>Section 29.</u>

- (a) As soon as the Town Council shall have received a duplicate Annual Tax List, the Town Manager or designee
 shall proceed at once to collect the taxes and other charges and fees on said duplicate list.
- (b) All taxes, other charges or fees imposed by the Town in such Annual Tax List, or as levied or imposed

666 pursuant to Section 28 of this Charter, shall be and constitute a lien upon all the real estate within the Town of Millville

- 667 owned by the taxable person or entity for a period of ten (10) years. The lien shall be applied to any such real estate within
- the Town of Millville owned by that taxable person or entity at any time after taxes, fees or charges are imposed. Such lien
- shall have preference and priority to all other liens on such real estate, as aforesaid, even if such other lien or liens be of a
- 670 time and date prior to the time of the attaching of such lien of taxes, charges or fees due to the Town.
- 671 (c) All taxes, charges or fees, when and as collected by the Town Manager or designee, shall be paid to The Town
- 672 of Millville, and all taxes, charges or fees shall be due and payable at and from the time of the delivery of the Annual Tax
- 673 List to the-Town Manager or designee or when the charge or fee is imposed.
- 674 (d) All taxes, charges and fees shall be payable at the Town Office of The Town of Millville during the regular
- 675 <u>business hours of that office.</u>
- 676 (e) In the collection of said taxes, all taxes paid after the expiration of ninety (90) days from the beginning of the
- 677 fiscal year shall be delinquent. The Town Council shall have the power to make just allowances for delinquencies in the
- 678 collection of taxes. On all taxes paid on or after the expiration of ninety (90) days next succeeding completion of the

679 Annual tax List to the Treasurer, there shall be added interest at the rate of 0.5% per month and an additional sum of 1% per

- 680 month as a penalty for each month or fraction thereof such taxes shall remain unpaid and said penalties shall be collected in
- the same manner as the original amount of the tax. All taxes unpaid after the expiration of ninety (90) days from the

beginning of the fiscal year of The Town of Millville shall be considered delinquent. In effecting a collection of any

- 683 delinquent tax the Town Council may impose a collection charge not to exceed eighteen percent (18%) of the amount of the
- 684 tax and any interest or penalty imposed thereon.
- 685 (f) At the annual meeting of the Town Council of each year, the Town Manager or designee shall account to the
- 686 Town Council for all taxes, charges and fees collected by him or her during the prior fiscal year and shall account for any
- 687 uncollected taxes, charges and fees unless he or she can show to the satisfaction of the Town Council that all remedies
- 688 permitted for the collection of said taxes, charges and fees were pursued without result or, if not pursued the remedies
- 689 would have been without avail.
- 690 (g) The Town Manager or designee, when any tax, charge or fee has become delinquent, may, in the name of The
- 691 Town of Millville, institute suit before any Justice of the Peace or in the Court of Common Pleas of the State of Delaware,

692 in and for Sussex County, or in the Superior Court of the State of Delaware, in and for Sussex County, for the recovery of

- 693 the unpaid tax, charge or fee, together with interest, penalty and collection charge(s), in an action of debt, and upon
- 694 judgment obtained, may sue out writs of execution as in the case of other judgments recovered before a Justice of the Peace
- 695 or in the Court of Common Pleas, or in the Superior Court as the case may be.
- 696 (h) However, should the Town Manager or designee so elect, he or she is empowered to sell the real property of
- 697 the delinquent taxpayer or the real property of a delinquent taxpayer alienated subsequent to the levy of the tax by the
- 698 <u>following procedure:</u>
- 699 (1) The Town Manager or designee shall present in the name of The Town of Millville to the Superior Court of the
- 700 <u>State of Delaware, in and for Sussex County, a petition in which shall be stated:</u>
- 701 (A) The name of the taxable;
- 702 (B) The year for which the tax was levied;
- 703 (C) The rate of tax;
- 704 (D) The total amount due;
- 705 (E) The date from which interest and the penalty for nonpayment shall commence and the rate of such interest and
- 706 penalty and any collection charge permitted;
- 707 (F) A reasonable, precise description of the real property proposed to be sold;

- 708 (G) A statement that the bill of said tax has been mailed to the taxable at his or her last known post office address
- 709 with return receipt requested by certified mail and postage prepaid;
- (H) That it has been found impractical to attempt to collect the said tax by any other remedy hereinbefore
 provided. The petition shall be signed by the Town Manager or designee and shall be verified before a Notary Public.
- 712 (2) At least ten (10) days prior to the filing of any such petition as described herein, the Town Manager or
- 713 designee shall deposit in the mail in a sealed and stamped envelope and addressed to the taxable at his or her last known
- 714 address requiring a registered receipt returnable, an itemized statement of the tax due, together with all interest, penalties,
- 715 collection charges, and costs then due thereon, together with a notice to the delinquent taxpayer that he shall proceed to sell
- 716 the lands and tenements of the taxpayer for the payment of the tax. The Town Manager or designee shall exhibit the return
- 717 registry receipt to the Court by filing the same with the petition; provided, however, that if the taxpayer cannot be found, it
- 518 shall be sufficient for the Treasurer to file with said petition the evidence that such statement has been mailed in accordance
- 719 with this Subsection and has been returned.
- (3) Upon the filing of the petition, the Prothonotary shall record the same in a property indexed record of the
 Superior Court, in and for Sussex County, and shall endorse upon the said record of said petition the following: "This
 petition, filed the ______ day of _____, A.D., ____, and the Town Manager or designee of The Town of Millville is hereby
 authorized to proceed to sell the real property herein mentioned or a sufficient part thereof as may be necessary for the
- authorized to proceed to sell the real property herein mentioned or a sufficient part thereof as may be necessary for the
- 724 payment of the amount due-" This endorsement shall be signed by the Prothonotary.
- (4) Any sales of real property of a delinquent taxpayer shall be advertised in five (5) four (4) public places in The Town of Millville, to include Town bulletin board and posting on the Town's website and by printing the notice of said sale at least one (1) time in a newspaper of general circulation in the Town and by printing the notice of said sale at least one (1) time in a newspaper of general circulation in the Town. The notice shall contain the day, hour, place of sale and a short description of the premises sufficient to identify the same. The last of these notices shall be posted and published at least fifteen (15) days before the day fixed for the sale.
- (5) Each sale of real property shall be returned to the Superior Court of the State of Delaware, in and for Sussex
 County, at the next term thereof following the sale, and the Court shall inquire into the circumstances and either approve or
 set aside the sale. If the sale is approved, the Town Manager or designee making the sale shall make a deed to the purchaser
 which shall convey the right, title and interest of the delinquent taxpayer or his or her alience; if the sale be set aside, the
- 735 Superior Court may order another sale and so on until the tax be collected. The petition, return and deed shall be
- 736 presumptive evidence of the regularity of the proceedings.

- 737 (6) No sale shall be approved by the Superior Court if the owner is ready at court to pay the taxes, penalty,
- collection fees and costs, no deed shall be made until the expiration of ninety (90) days from the date of the sale within
- 739 which time the owner, his or her heirs, executors, or assigns, shall have the power to redeem the lands on payment to the
- 740 purchaser, his or her personal representatives or assigns, the costs, the amount of the purchase price, and twenty percent
- 741 (20%) interest thereon and the expense of having the deed prepared.
- 742 (7) After satisfying the tax, interest, penalties and collection charges due and the costs of expense of sale from the
- 743 proceeds of sale, the amount remaining shall be paid to the owner of the land, upon the refusal of the said owner to accept
- said residue, or if the owner is unknown or cannot be found, the amount remaining shall be deposited in a bank, either to
- 745 the credit of the owner or in a manner in which the fund may be identified.
- 746 (8) In the sale of real property for payment of delinquent taxes, interest, penalties and collection charges, the costs
- 747 for filing, recording and preparation of documents shall be allowed to be deducted from the proceeds of the sale or
- 748 chargeable against the owner, as the case may be. In addition, the cost of printing hand bills or notices, the publication of
- the advertisement of sale in a newspaper, and the auctioneer's fee shall be chargeable costs. The costs of the deed will shall
- not be chargeable as costs, but shall be paid by the purchaser of the property of the delinquent taxpayer. The total of any
- 751 Delaware and municipal transfer tax shall be paid by the purchaser of said lands at the tax sale.
- (9) If the owner of any real property against which a tax shall be levied and assessed shall be unknown, this fact
- 753 <u>shall be stated in the advertisement of sale.</u>
- (10) If any person is assessed for several parcels of real property in the same assessment in The Town of Millville,
- the total of said taxes, charges or fees may be collected from the sale of any part or portion of said real property, provided
- 756 that the land alienated by the delinquent taxpayer shall not be sold until other property of the taxpayer shall have been
- 757 disposed of and there still remains a delinquency.
- 758 (11) In the event of death, resignation or removal from office of the Town Manager or designee of The Town of
- 759 Millville before the proceedings for the sale of lands shall have been completed, his or her successor in office shall succeed
- 760 to all of his or her powers, rights, and duties in respect to said sale. In the event of the death of the purchaser of said sale
- 761 prior to his or her receiving a deed for the property purchased thereat, the person having right under him by consent, devise,
- 762 assignment, or otherwise, may refer to the Superior Court of the State of Delaware, in and for Sussex County, a petition
- representing the facts and praying for an order authorizing and requiring the Town Manager or designee to execute and
- acknowledge a deed conveying to the petitioner the premises so sold or a just portion thereof; and thereupon the court may
- 765 make such order touching the conveyance of the premises as shall be according to justice and equity.

766	(12) The Town Manager or designee shall have the same right to require the aid or assistance of any person or
767	persons in the performance of his or her duty of sale which the Sheriff of Sussex County now has by law or may hereafter
768	have.
769	(13) However, should the Town Manager or designee so elect, the Town Manager or designee is empowered to
770	sell the real property of the delinquent taxpayer or the real property a delinquent taxpayer alienated subsequent to the levy
771	of the tax, by the direction of the Town Council, using any of those procedures specified for the sale of land for the
772	collection of taxes on the part of the taxes for Sussex County, and all such procedures and methods available for the sale of
773	land, as aforesaid, as they are presently enacted and hereafter amended, are included herein and made part hereof by
774	reference in the statutes made and provided, substituting the Town of Millville for Sussex County therein.
775	<u>Town Budget</u>
776	Section 30.
777	(a) The fiscal year for The Town of Millville shall be May 1 through April 30 of each year, unless changed by
778	Resolution of the Town Council.
779	(b) Each year and not later than its regular meeting of the Town Council in March, the Town Manager and Finance
780	Director shall prepare a rough draft of the Town Budget. From this rough draft, the Town Council shall prepare the Town
781	Budget, containing the financial plan for conducting the affairs of the Town for the ensuing fiscal year.
782	(c) The budget shall contain the following information:
783	(1) A detailed estimate showing the expense of conducting each department and office of the Town for the ensuing
784	fiscal year;
785	(2) The amount of the debt of the Town, together with the schedule of maturities of Bond issues;
786	(3) An itemized statement by the Town's chart of accounts of all other estimated expenses to be incurred in the
787	affairs of the Town for the ensuing fiscal year;
788	(4) A statement of the amount required for interest on the bonded debt, the amount necessary to pay any bond
789	maturing during the year and the amount required for the "Sinking Fund" or "Sinking Funds";
790	(5) An estimate of the amount of money to be received from taxes, water rents, sewer service charges, front foot
791	assessments, license fees and all other anticipated income of the Town from any source or sources whatsoever.
792	(d) This budget shall be presented at a meeting of the Town Council, and not more than thirty (30) days later be
793	presented at a public hearing for citizen comments. At the next Town Council meeting, the Town Council shall vote on the
794	adoption of the budget, which may include revisions, and said budget shall be effective on the first day of the new fiscal
795	year.

796	(e) The Town Council shall, so far as possible, adhere to the budget so adopted in the making of appropriations.
797	Enumeration of Powers
798	Section 31.
799	(a) Not by way of limitation upon the power vested in the Town Council of The Town of Millville to exercise all
800	powers delegated by this Charter to the municipal corporation or to the Town Council except as may expressly appear
801	herein to the contrary, but, rather by way of enumeration and for purposes of clarity, the Town Council is vested by this
802	Charter with the following powers, to be exercised by the Town Council in the interest of good government and the safety,
803	health, and public welfare of the Town, its inhabitants and affairs, that is to say:
804	(1) To prohibit vice, drunkenness and immorality;
805	(2) To provide for and preserve the health, peace, safety, cleanliness, ornament, good order and public welfare of
806	the Town and its inhabitants;
807	(3) To prohibit all gaming and fraudulent devices;
808	(4) To prohibit, restrain, license or regulate all public sports, exhibitions, shows, parades, productions, gatherings,
809	circuses or other public performances, amusements and games;
810	(5) To ascertain, locate, lay out, establish, open, change, alter, widen, abandon, regulate the use and enjoyment of,
811	prevent or remove any obstruction of, level, grade, flag, dress, macadamize, pave, gravel, shell, improve, dredge, erect,
812	remove, repair or replace any new or present street, highway, lane, alley, water course, park, lake, crosswalk, wharf, dock,
813	sewer, drain, aqueduct, or pipeline or portion thereof, or any new or present sidewalk, curb, or gutter or portion thereof
814	within the Town; to specify the grade thereof, the materials to be used in the doing thereof and the manner in which the
815	same shall be done; to enter into contracts or agreements for the doing thereof, including contracts or agreements with the
816	State of Delaware for the permanent maintenance, repair and upkeep of any street, lane, alley, roadway or other public
817	thoroughfare within the Town;

- 829 (9) To enforce the removal of ice, snow or dirt or other foreign substance from sidewalks and gutters by owners or

- (10) To prohibit, remove or regulate the erection of any stoop, step, platform, bay window, cellar, gate, area,
 descent, sign, post or any other erection or projection in, over, upon or under any street, highway, alley, lane, water course,
- 833 park, lake, strand, sidewalk, crosswalk, wharf, dock, sewer, drain, aqueduct or pipeline of the Town;
- 834 (11) To define, prevent, abate or remove nuisances, obstructions or any other condition detrimental to the public
- 835 safety, health or welfare or the welfare, health and capacity of eco-systems that support the natural areas within the Town;
- 836 (12) To provide an ample supply of pure water for the Town and its inhabitants and to this end to acquire, lease,
- 837 erect, construct, maintain, operate, extend, enlarge, renew, replace, control and dispose of wells, reservoirs, pumps,
- 838 machines, stations, tanks, standpipes, water mains, fire hydrants and all other equipment, property or rights used in or about
- the collection, storage, purification, conveyance, or distribution or sale of water; to regulate and prescribe for what public or
- 840 private purposes the water furnished by The Town of Millville may be used, the manner of its use, the amounts to be paid
- 841 by the users thereof, the means whereby such amounts shall be collected and the fines or penalties, or both, for any willful
- 842 or negligent injury, or damage to or interference with the water system or the equipment of the Town; to furnish or refuse to
- 843 furnish water from the Town system to places and properties outside the Town limits; and to contract for and purchase
- 844 water and distribute the same to users within or without the Town with the same full powers as though such water had been
- 845 <u>initially reduced to usefulness by the municipality itself.</u>
- 846 (13) To provide, construct, extend, maintain, manage and control a sewer system and/or a sewage treatment and 847 disposal plant and facilities for the health, sanitation and convenience of the inhabitants of the Town; to regulate and 848 prescribe for what private or public uses or purposes the system may be used, the manner of its use, the amounts to be paid 849 by the users thereof, the means whereby such amounts shall be collected and the fines or penalties or both, for any willful 850 or negligent injury or damage to, or interference with the said system, plan or facilities. To furnish or refuse to furnish 851 sewer disposal service from the Town system to places and properties outside the Town limits. In the interest of the public's 852 health, to compel any and all properties in the Town to be connected to the sewer system of the Town; and to contract for 853 and purchase sewer disposal service and to resell the same to users within or without the Town with the same full powers as
- 854 though such service had been initially provided by the facilities therefor of the Town itself.

855	(14) To provide, construct, extend, maintain, manage and control the plant and system, or plants and systems, for
856	the generating, manufacturing and distributing of electric current or gas, or both, to the inhabitants of the Town and for
857	lighting the streets, highways, lanes, alleys, water courses, parks, lake, strands, sidewalks, crosswalks, wharves, docks,
858	public buildings or other public places in the Town, and to this end to acquire, lease, erect, construct, maintain, operate,
859	extend, enlarge, renew, replace, control and dispose of transmission and distribution lines, pipes, mains and other
860	conveyances for any such current or gas as may be necessarily proper to light the Town, and to furnish proper connections
861	for electric current and gas to the properties of the inhabitants of the Town who may desire the same; to regulate and
862	prescribe for what private or public purpose the current or gas furnished by the Town may be used, the manner of its use,
863	the amount to be paid by the users thereof, the means whereby such amounts are to be collected and the fines or penalties,
864	or both, for any willful or negligent injury or damage to or interference with the electric or gas system or systems of the
865	Town; to furnish or refuse to furnish electric current or gas from the Town's system or systems, to places and properties
866	outside the Town limits; and to contract for and purchase electric current or gas and distribute the same to users within or
867	without the Town with the same full powers as though such current or gas had been initially reduced to usefulness by the
868	Town itself.
869	(15) To fully control within the Town the drainage of all water and to that end to alter or change the course and
870	direction of any natural water course, runs or rivulet within the Town, to regulate, maintain, clean and keep the same open,
871	clean and unobstructed, and to provide, construct, extend and maintain, manage and control a surface water drainage system
872	and facilities for the health, sanitation and convenience of the inhabitants of the Town;
873	(16) To provide, construct, extend, maintain, manage and control jetties, bulkheads, embankments, flood gates,
874	piers, or fills for the preservation of any strand or high land within the limits of the Town and contiguous thereto to the end
875	that the same may be preserved, property protected that the general public might enjoy the use thereof.
876	(17) To grant franchises or licenses to any responsible person, firm, association or corporation for such period of
877	time, upon such terms, restrictions, stipulations and conditions and for such considerations as the Town Council shall deem
878	in the best interests of the municipality, to use the present and future streets, highways, lanes, alleys, water courses, parks,
879	lakes, strands, sidewalks, crosswalks, wharves, docks and other public places of the Town for the purpose of furnishing
880	heat, light, power, gas, water, sewer, drainage, electric current, telephone, telegraph, television, railroad excepting railroads
881	or railways engaged in Interstate Commerce, bus, taxi or other transportation, carrier or public service to the Town, unto the
882	persons, firms or corporations residing or located therein and for the purpose of transmitting the same from or through the
883	Town to points outside the limits thereof, and for the purpose of erecting wharves and piers and for the purpose of vending
884	any article or merchandise or service upon or from any vehicle upon any present and future street, highway, lane, alley, etc.;

- 886 <u>corporation whomsoever;</u>
- 887 (18) To regulate and control the exercise of any license or franchise;
- 888 (19) To direct, regulate and control the planning, rearing, treatment and preserving of ornamental shade trees in the
- 889 streets, avenues, highways, parks and grounds of the Town and to authorize or prohibit the removal or destruction of said
 890 trees;
- (20) To direct the digging down, draining, filling up, cleaning, cutting or fencing of lots, tracts, pieces or parcels of
 ground in the Town which may be deemed dangerous or unwholesome or necessary to carry out any improvements
- 893 <u>authorized by this Charter;</u>
- 894 (21) To provide for or regulate the numbering of houses and lots on the streets and the naming of streets and
 895 avenues,
- 896 (22) To regulate, control or prevent the use or storage of gun powder, fireworks, tar, pitch, resin, and all other
- 897 combustible materials and the use of candles, lamps, and other lights in stores, shops, stables and other places; to suppress,
- 898 remove or secure any fireplace, stove, chimney, oven, broiler, or other apparatus which may be dangerous in causing fires;
- 899 (23) For the prevention of fire and the preservation of the beauty of the Town, to regulate and control the manner
- 900 of building or removal of dwelling houses and other buildings; to establish a Code for the same and to provide for the
- 901 granting of permits for the same; to establish a building line for buildings to be erected; to zone or district the Town and
- 902 make particular provisions for particular zones or districts with regard to building or building material; and generally to
- 903 exercise all powers and authorities vested in the legislative body of cities and incorporated towns under and by virtue of

- 908 any correctional institution or detention facility located in the State of Delaware may be used for any such purpose;

- 911 (26) To regulate or prevent the use of guns, air guns, spring guns, pistols, sling shots, bean shooters, and any other
- 912 devices for discharging projectiles which may cause bodily injury or injury or harm to property; and to regulate or prevent
- 913 the use of fireworks, bombs and detonating works of all kinds;

- 914 (27) To provide for the punishment of a violation of any Ordinance of the Town by fine not exceeding One
 915 Thousand Dollars (\$1,000.00);
- 916 (28) To provide for the organization and the control and government of any of the following: a fire department, an
- 917 ambulance service, or emergency treatment service; to establish fire limits and to do all things necessary for the prevention
- 918 or extinguishment of fires: and at the discretion of the Town Council, to contribute, donate or give an amount or amounts
- 919 not to exceed in the total during any fiscal year six percent (6%) of the total taxes levied on real estate unto any of the
- 920 following individually or in combination: volunteer fire company or companies incorporated under the laws of the State of
- 921 Delaware; any volunteer fire association or associations maintaining and operating firefighting equipment and service to the

- 929 (30) To levy and collect taxes for any and all municipal purposes upon all real estate and improvements located
- 930 thereon; provided, however, that the amount to be raised from this source shall not exceed in any one year the sum of more
- 931 than three percent (3%) of the total assessed value of all taxable real estate and the improvements thereon; and provided
- 932 further that there shall be no limitation upon the amount which may be raised from the taxation of real estate for the

- 947 (33) To determine from which authorized source and in what proportion taxes shall be levied and used each year to

- 950 (34) To provide for the collection of and disbursement of all moneys to which the Town may become entitled by
- 951 <u>law, including licenses and fines where no provision for the collection and disbursement thereof is otherwise provided in</u>
- 952 <u>this Charter;</u>
- 953 (35) To borrow money in the name of the Town for any proper municipal purpose and in order to secure the
- 954 payment of the same to issue bonds or other forms or kinds of certificate or certificates of indebtedness, pledging the full
- 955 faith and credit of the Town or such other security or securities as the Town Council shall select for the payment of the
- 956 principal thereof and the interest due thereon, all of which bonds or other kinds or forms of certificates of indebtedness
- 957 issued by the Town shall be exempt from all state, county or municipal taxes; provided, however, that in no event shall the
- 958 indebtedness of the Town for any and all purposes at any one time exceed in the aggregate twenty-five percent (25%) of the
- 959 assessed value of all real property;
- 960 (36) To acquire, and/or to vacate the use of lands, tenements, personalty, property, easements, rights of way, or
- 961 any interest in property, either within or without the limits of the Town, by way of condemnation and eminent domain for
- 962 any proper and lawful municipal purpose or whenever required properly to carry out, exercise or fulfill any power conferred
- 963 upon or delegated to The Town of Millville by this Charter. Proceedings by way of condemnation in any case shall be as
- 964 prescribed in Chapter 61, Title 10 of the Delaware Code;
- 965 (37) To appropriate money to pay the debts, liabilities and expenditures of the Town, or any part or item thereof,
- 966 from any fund applicable thereto, and to transfer temporarily money from one fund to another fund of the Town in case of
- 967 <u>emergency;</u>
- 968 (38) To provide for the payment of any tax, fine, penalty, license, forfeiture, assessment, fee, charge, or other
 969 amount due the Town by the performance of labor or service for the Town by any person owing the same;
- 970 (39) To inquire into and investigate the conduct of any officer, agent or employee of the Town or any municipal
- 971 affair and for such purpose or purposes to subpoena witnesses, administer oaths or affirmations, and compel the attendance
- 972 of witnesses and the production of books, papers, or other evidence by subpoena;

973 (40) To borrow money in anticipation of revenues on the full faith and credit of the Town of Millville sum or sums 974 not exceeding five hundred thousand dollars (\$500,000.00) in any one (1) year when, in the opinion of a majority of the 975 Town Council of the Town of Millville, the needs of the Town require it. Any sum so borrowed shall be secured by 976 promissory notes of the Town of Millville, duly authorized by Resolution adopted by the Town Council of the Town of 977 Millville, and signed by the Mayor of the Town of Millville, and attested by the Secretary of the Town Council with the 978 corporate seal affixed, and no officer or member of the Town Council shall be liable for the payments of such notes because 979 it is signed by them as officers of the Town and is authorized by the Resolution of the Town Council; provided, however, 980 that the total sum outstanding at any one time shall not exceeds five hundred thousand dollars (\$500,000.00); and provided 981 further, that any sum of money so borrowed, as aforesaid, in any fiscal year, shall be paid from the general fund of the 982 Town and shall be completely repaid at any time, but must be completely paid at the end of twenty (20) fiscal years 983 following the first fiscal year when said sum or sums were borrowed, with interest thereon; and provided that such ad 984 valorem taxes shall be levied as is necessary to pay the principal or the interest on said bonds as is required without regard 985 to any other limitation concerning the maximum rate of taxation and such notes and the interest thereon shall be exempt 986 from all taxation by the State of Delaware or by any political subdivision, agency or subdivision thereof. 987 (41) To effect the collection of any delinquent charge the Town Council of The Town of Millville may impose a 988 collection charge not exceeding eighteen percent (18%) of the amount of such charge and any interest or penalty imposed 989 thereon; 990 (42) [Repealed.] 991 (43) To contribute, donate or give an amount or amounts unto community organizations providing services to the 992 community in The Town of Millville provided that such contribution, donation or gift may be made subject to such 993 conditions and stipulations as to the sum thereof as the Town Council shall deem advisable. 994 (44) To impose, upon new development or construction or upon first-time occupancy of new construction, such 995 'impact fees' as are reasonably calculated to recover the cost of installing, enlarging, improving or expanding public or 996 municipal improvements which have a rational nexus to such new construction; and/or to contribute to the costs of 997 operations of those volunteer fire companies and/or ambulance/paramedic companies providing services within the Town. 998 (45) In addition to all other powers the Town Council of the Town of Millville may have, and notwithstanding any 999 limitation of law, the Town Council of the Town of Millville shall have all powers and may undertake all actions for the

- 1000 purposes set forth in, and in accordance with Title 22 of the Delaware Code, Chapter 17, relating to the Municipal Tax
- 1001 Increment Financing Act and Chapter 18 relating to Special Development Districts and, in addition, with respect to Special
- 1002 Development Districts under Title 22 of the Delaware Code, Chapter 18, the term 'municipality' and 'municipal' set forth in

- 1003 Title 22 of the Delaware Code, Chapter 18, § 1801(2)a. and b. shall include not only the Town of Millville, but also the
- 1004 State of Delaware, and any agency or instrumentality thereof, and any county, and any local political subdivision,
- 1005 instrumentality, agency, body politic, utility district or similar entity within the State of Delaware.
- 1006 Bonds are non-recourse to the Town and shall only be paid from Tax Increment Financing (TIF) or Special
- 1007 Development Districts (SDD) assessments permitted by 22 Del. C. Chapters 17 and 18. These bonds are non-recourse to
- 1008 property owners who purchase subject to a TIF or SDD. Property owners who purchase subject to a TIF or SDD shall only
- 1009 be responsible for TIF or SDD obligations determined by the individual assessment of their property and from (i) voluntary
- 1010 contributions by entities exempt from taxation and assessment for public purposes under 9 Del. C. § 8105, (ii) bond
- 1011 proceeds on deposit in debt service reserve funds and other funds established under an indenture for such bonds, (iii)
- 1012 proceeds of any tax or monition sales (including accrued interest and penalties) properly allocable to unpaid TIF or SDD

- 1014 (b) The Town Council may adopt, alter and amend all such ordinances, regulations, resolutions and rules not
- 1015 contrary to the Constitution and Laws of the United States and the State of Delaware as the Town Council may deem
- 1016 necessary to carry into effect any of the provisions of this Charter or any federal or state law relating generally to municipal
- 1017 corporations or which may be deemed proper and necessary for the order, protection and good government of the town; the
- 1018 protection of persons and preservation of property; and the protection of the public health and welfare of the town and its
- 1019 inhabitants. Any ordinance relating to the public health of the town and its inhabitants or designed to prevent the
- 1020 introduction or spread of infectious or contagious diseases or to prevent nuisances affecting the same shall apply not only
- 1021 within the corporate limits of the town but as well to all areas and persons outside the town within one (1) mile from its
- 1022 <u>corporate limits.</u>
- 1023 (c) All provisions of this Section 31 and any other section of this Charter limiting the amounts of indebtedness to 1024 be incurred or taxes to be levied by the Town Council of the Town of Millville shall not apply to any indebtedness incurred 1025 or any special ad valorem taxes, special taxes or ad valorem taxes levied pursuant to or in connection with Section
- 1026 <u>31(a)(45) of this Charter.</u>

- **Streets**
- 1029 (a) The Town Council shall have the power and authority to lay out, locate and open new streets or to widen and
- 1030 alter existing streets or parts thereof and to vacate or abandon streets or parts thereof, whenever the Town Council shall
- 1031 deem it for the best interest of the Town, but only after such recommended action(s) have been presented at a meeting of
- 1032 the Town Council, and the opportunity for public comment has been provided.

1033 (b) In addition, the procedure to be used for any of those things heretofore listed in this Section shall be as follows: 1034 (1) Whenever five (5) or more property owners in a portion of the Town directly affected or abutting on the 1035 proposed street to be opened, laid out, changed, altered, widened, vacated or closed shall by written petition with each 1036 signature duly acknowledged request the Town Council to lay out, locate, or open a new street or to widen or alter any 1037 existing street or any part thereof or to vacate or abandon a street or any part thereof, the Mayor shall appoint a committee 1038 composed of not less than two (2) of the elected members of the Town Council and one (1) of the Planning and Zoning 1039 Commission to investigate the possibility of changing the structure of said streets in the Town. The petition presented to the 1040 Council by the property owners shall include a description of the property through which the proposed street shall be laid 1041 out or description of the street on which any of the other actions heretofore described shall take place and the reasons why 1042 the change in the structure of the streets of the Town should be undertaken; or the Town Council, by a majority vote of the 1043 elected members thereof may, by resolution, propose that a committee composed of not less than three (3) of its elected 1044 members be appointed by the Mayor to investigate the possibility of changing the street structure of the Town.

1045 (2) Not later than ninety (90) days following its appointment, the committee shall submit a report concerning its 1046 findings to the Mayor and to the Town Council. The report shall contain the advantages and disadvantages to the Town 1047 caused by the changes of the street structure and shall contain the conclusion of said committee, recommending or 1048 disapproving the change of said street structure. If the report of the committee appointed by the Mayor recommends 1049 changing the existing street structure of the Town, the Council by resolution, passed by a majority of the elected members 1050 of the Town Council concurring therein, shall propose to the property owners and citizens of the Town that the Council 1051 proposes to change the street structure by opening a new street or by doing any of those other things hereinbefore described 1052 to the existing street structure of the Town. If the report of the committee is not in favor of changing the existing street 1053 structure, the resolution proposing the change in the street structure to the property owners and citizens of the Town shall be 1054 passed by a majority of three fourths (3/4ths) of the elected members of the Town Council. The resolution shall contain a 1055 description of the proposed change and shall affix a time and place for a public hearing on the matter of changing the street 1056 structure. The resolution adopted by the Town Council shall be printed in at least one (1) newspaper having a general 1057 circulation in The Town and shall be posted in five (5) public places in the Town for at least fifteen (15) days before the 1058 time set for the public hearing. The resolution shall also state the hour and place where and when the Town Council shall sit 1059 to hear objections and to award current market compensation to anyone who will be deprived of property by the proposed 1060 change in the existing street structure of the town. 1061 (3) Whenever the Town Council shall have determined to locate or lay out or widen any street, lane or alley and

1062 shall have affixed compensation therefor, it shall be the duty of the Town Council immediately after the survey and location

1063 of said street, lane or alley, to notify by certified mail with return receipt requested and postage prepaid, the owner or 1064 owners of the real estate through or over whom such street, lane or alley may run of their determination to open or widen 1065 the same and to furnish a general description or location thereof; also the amount of compensation or damages allowed to 1066 each such property owner, and if such owner be not a resident of the Town, to notify the holder or tenant of said real estate 1067 and the owner of such property if his or her address be known; that if there be no holder or tenant resident in the Town and 1068 the address of the owner be unknown, or if there is a holder or tenant and the address of the owner is unknown, the said 1069 notice may be affixed to any part of the premises. If the owner be dissatisfied with the amount of compensation or damages 1070 allowed by the Town, as aforesaid, said property owner may, within twenty (20) days after such notice, as aforesaid, was 1071 posted or mailed appeal from written notice of assessment or compensation or damages by serving written notice by 1072 certified mail with return receipt requested and postage prepaid on the Mayor to the effect that he or she is dissatisfied with 1073 the amount of such compensation or damages, and that it is his or her intention to make written application to one of the 1074 Judges of the Superior Court of the State of Delaware, in and for Sussex County, for the appointment of a commission to 1075 hear and determine the matter in controversy; and in order to prosecute said appeal, such owner shall, within fifteen (15) 1076 days after serving said notice upon the Mayor as aforesaid, make written application to said Judge of the Superior Court of 1077 the State of Delaware, in and for Sussex County, for the appointment of such a commission; and thereupon the said Judge 1078 shall issue an appoint a commission made up of five (5) property owners whom shall be residents of The Town, requiring 1079 them to assess the damages which the owner of the real estate through or over which the said street, lane or alley shall pass 1080 or who shall have suffered damage because of any other action taken by the Town pursuant to the provisions hereof and 1081 who shall have notified the said Town Council of their intention to appeal may incur by reason thereof and to make a return 1082 of their proceeding to the said Judge at the time therein appointed. 1083 (4) The property owners named in such commission, being first duly sworn or affirmed, shall view the premises 1084 and may, or a majority of them, shall assess the damages, as aforesaid, and shall make return in writing of their proceedings 1085 to the said Judge who shall deliver and return to the Town Council which shall be final and conclusive. The said Judge shall 1086 have the power to fill any vacancy in the commission. The amount of damages being so ascertained, the Town Council may 1087 pay or tender the same to the person or persons entitled thereto within thirty (30) days after the same shall be finally 1088 ascertained or if the person or persons so entitled reside out of or are absent from the Town during the said period of thirty 1089 (30) days, then the same shall be deposited to his or her credit in the the banking institution designated by the Town 1090 Council, with offices in Sussex County, Delaware, within said time and thereupon the said property on lands may be taken

1091 <u>or occupied for the use as aforesaid.</u>

1092	(5) If the ascertainment and assessment of damages by the freeholders appointed by the Judge, as aforesaid, shall
1093	be increased, the cost of the appeal shall be paid by the Town out of any money in the hands of the Town Manager or

1106	and character thereof and thereupon it shall be the duty of such owner or owners to cause such construction, repair or

<u>SYNOPSIS</u>

This bill reincorporates the Charter of the Town of Millville. The bill updates various processes, including the municipal election, annexation, competitive bidding, and the Town budget. The bill also updates the descriptions and duties of the Secretary and Treasurer. The bill removed antiquated language and clarified language in matters such as assessments and repairs.
