## DELAWARE STATE SENATE 151st GENERAL ASSEMBLY

## SENATE BILL NO. 107

AN ACT TO AMEND TITLE 18, TITLE 29, AND TITLE 31 OF THE DELAWARE CODE RELATING TO INSURANCE COVERAGE OF INSULIN PUMPS.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Chapter 33, Title 18 of the Delaware Code by making deletions as shown by strike through and
2	insertions as shown by underline as follows:
3	§ 3344C. Coverage for insulin pumps.
4	(a) For purposes of this section, "insulin pump" means a small, portable medical device that is approved by the
5	U.S. Food and Drug Administration to provide continuous subcutaneous insulin infusion.
6	(b) All individual health insurance policies, contracts, or certificates that are delivered, issued for delivery,
7	renewed, extended, or modified in this State shall provide coverage for a medically necessary insulin pump at no cost to a
8	covered individual, including deductible payments and cost-sharing amounts charged once a deductible is met.
9	(c) Except as provided under subsection (b) of this section, nothing in this section prevents the operation of a
10	policy provision required by this section as a deductible, coinsurance, allowable charge limitation, coordination of benefits,
11	or a provision restricting coverage to services by a licensed, certified, or carrier-approved provider or facility.
12	(d) This section does not apply to accident-only, specified disease, hospital indemnity, Medicare supplement, long
13	term care, disability income, or other limited benefit health insurance policies.
14	(e) This section applies to all policies, contracts, or certificates issued, renewed, modified, altered, amended, or
15	reissued after December 31, 2021.
16	Section 2. Amend Chapter 35, Title 18 of the Delaware Code by making deletions as shown by strike through and
17	insertions as shown by underline as follows:
18	§ 3560B. Coverage for insulin pumps.
19	(a) For purposes of this section, "insulin pump" means a small, portable medical device that is approved by the
20	U.S. Food and Drug Administration to provide continuous subcutaneous insulin infusion.

21	(b) All group and blanket health insurance policies, contracts, or certificates that are delivered, issued for delivery,
22	renewed, extended, or modified in this State shall provide coverage for a medically necessary insulin pump at no cost to a
23	covered individual, including deductible payments and cost-sharing amounts charged once a deductible is met.
24	(c) Except as provided under subsection (b) of this section, nothing in this section prevents the operation of a
25	policy provision required by this section as a deductible, coinsurance, allowable charge limitation, coordination of benefits,
26	or a provision restricting coverage to services by a licensed, certified, or carrier-approved provider or facility.
27	(d) This section does not apply to accident-only, specified disease, hospital indemnity, Medicare supplement, long-
28	term care, disability income, or other limited benefit health insurance policies.
29	(e) This section applies to all policies, contracts, or certificates issued, renewed, modified, altered, amended, or
30	reissued after December 31, 2021.
31	Section 3. Amend Chapter 52, Title 29 of the Delaware Code by making deletions as shown by strike through and
32	insertions as shown by underline as follows:
33	§ 5213. Coverage for insulin pumps.
34	(a) For purposes of this section, "insulin pump" means a small, portable medical device that is approved by the
35	U.S. Food and Drug Administration to provide continuous subcutaneous insulin infusion.
36	(b) The plan shall provide coverage for a medically necessary insulin pump at no cost to a covered individual,
37	including deductible payments and cost-sharing amounts charged once a deductible is met.
38	Section 4. Amend Chapter 5, Title 31 of the Delaware Code by making deletions as shown by strike through and
39	insertions as shown by underline as follows:
10	§ 528. Coverage for insulin pumps.
<b>1</b> 1	(a) For purposes of this section, "insulin pump" means a small, portable medical device that is approved by the
12	U.S. Food and Drug Administration to provide continuous subcutaneous insulin infusion.
13	(b) Carriers shall provide coverage for a medically necessary insulin pump at no cost in all health benefit plans
14	delivered or issued for delivery under § 505(3) of this title.
	SYNOPSIS
	This Act requires that individual, group, State employee, and public assistance insurance plans provide coverage for a medically necessary insulin pump at no cost to a covered individual.
