DELAWARE STATE SENATE 151st GENERAL ASSEMBLY

SENATE CONCURRENT RESOLUTION NO. 28

PROCLAIMING APRIL 2021 AS "SECOND CHANCE MONTH" IN THE STATE OF DELAWARE.

1	WHEREAS, everyone deserves an opportunity to rebuild their lives, reach their fullest potential and become
2	productive members of society; and
3	WHEREAS, an estimated 70 million Americans have a criminal record, and more than 600,000 individuals return
4	to their communities from state and federal prisons each year; and
5	WHEREAS, individuals returning from prison often struggle to find housing, employment, or regain voting rights
6	as a result of their conviction and incarceration; and
7	WHEREAS, mass incarceration and failed criminal justice policies have emphasized imprisonment over
8	rehabilitation and prevention for years, resulting in nearly 1 in 4 American adults having a criminal record; and
9	WHEREAS, the stigma and legal barriers associated with a criminal record results in lost human capital and lost
10	economic output for the United States; and
11	WHEREAS, reducing barriers contributes to public safety by reducing recidivism, increasing the economic well-
12	being of entire communities, and allowing individuals the opportunity to seek a better life for themselves and their families
13	and to contribute to society in a positive and meaningful way; and
14	WHEREAS, gaining meaningful employment is one of the most significant predictors of successful reentry and
15	reducing future criminal activity; and
16	WHEREAS, Delaware's criminal justice reform efforts have expanded the availability of juvenile and adult
17	expungements, increased judicial discretion in the stacking of sentences and lessened restrictions on professional licensure
18	occupations; and
19	WHEREAS, many system-impacted individuals are still not aware of the opportunities available from criminal
20	justice reforms; and
21	WHEREAS, focusing on prevention, reentry, and social support, rather than incarceration, ensures that America is
22	a land of second chances and opportunity for all people; and

23	WHEREAS, Second Chance Month increases public awareness about the need for closure for those who have paid
24	their debts and provides an opportunity for individuals, employers, congregations, and communities to extend second
25	chances to those with criminal records; and
26	WHEREAS, on March 31, 2021, President Biden proclaimed April 2021 as Second Chance Month.
27	NOW, THEREFORE:
28	BE IT RESOLVED by the Senate of the 151st General Assembly of the State of Delaware, the House of
29	Representatives concurring therein, that April 2021 is hereby recognized as "Second Chance Month" in the State of
30	Delaware.
