AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO BODY WORN CAMERAS.

- 3 Chapter 81A. Body Worn Cameras for Law Enforcement Officers.
- 4 <u>§ 8101A. Definitions.</u>
- 5 For the purposes of this chapter:
- 6 (1) "Body worn camera" means an electronic device that is worn by a law-enforcement officer and records
- 7 <u>audio and video data on the device itself or transmits audio and video data to another location for recording.</u>
- 8 (2) "Law-enforcement officer" means a sworn member of a law-enforcement agency.
- 9 (3) "Law-enforcement agency" means any of the following:
- 10 <u>a. A police department of any political subdivision of this State.</u>
- 11 <u>b. Delaware State Police.</u>
- 12 <u>c. Capitol Police.</u>
- 13 <u>d. University of Delaware Police.</u>
- 14 e. Delaware State University Police.
- 15 <u>f. A division within the Department of Natural Resources and Environmental Control that employs law-</u>

16 <u>enforcement officers.</u>

- g. A task force which includes officers of the Bureau of Community Corrections of the Department of
  Correction.
- 19 <u>h. A special investigator or serious juvenile offender officers of the Division of Youth Rehabilitative</u>
- 20 <u>Services of the Department of Services for Children, Youth, and their Families.</u>

- 22 § 8102A. Body worn camera requirements.
- 23 (a) A law-enforcement officer shall wear a body worn camera while on duty in a role in which the law-
- 24 <u>enforcement-officer is likely to interact with a member of the public.</u>
- 25 (b) A law-enforcement officer required to wear a body worn camera under subsection (a) of this section shall use
- 26 the body worn camera to record all interactions with a member of the public while on duty.
- 27 (c) A law-enforcement agency shall retain any recording made by the body worn camera under subsection (b) of
- 28 this section for at least 90 days following the interaction, unless the agency has received a request or a court order to
- 29 preserve the recording for a longer period.

## **SYNOPSIS**

This Act requires certain law-enforcement officer to wear and use a body worn camera to record all interactions with a member of the public. The Act also requires law-enforcement agencies to retain body worn camera recordings for at least 90 days following the interaction unless the agency has received a request or a court order to preserve the recording for a longer period of time.
