HOUSE OF REPRESENTATIVES 151st GENERAL ASSEMBLY

HOUSE BILL NO. 190

AN ACT TO AMEND TITLE 10 AND TITLE 11 OF THE DELAWARE CODE RELATING TO DOMESTIC VIOLENCE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Chapter 9, Title 10 of the Delaware Code by making deletions as shown by strike through and
2	insertions as shown by underline as follows:
3	§ 1024. First offenders domestic violence diversion program.
4	(a) For the purposes of this section, "domestic violence" shall be considered as means any act or acts committed
5	by an adult against another person who falls into the protected class defined in § 1041(2)b. of this title, member of a family
6	against 1 or more members of the person's family, as that term is defined in § 901(12) of this title, which constitute any of
7	the following criminal offenses under Title 11:
8	(1) offensive Offensive touching (§ 601).
9	(2) menacing (§ 602); Menacing (§ 602).
10	(3) reckless Reckless endangering in the second degree (§ 603); (§ 603).
11	(4) assault Assault in the third degree (§ 611); (§ 611).
12	(5) terroristic Terroristic threatening (§ 621); (§ 621).
13	(6) vehicular Vehicular assault in the second degree ([former] § 628); ([former] § 628).
14	(7) sexual harassment (§ 763); Sexual harassment (§ 763).
15	(8) unlawful Unlawful sexual contact in the third degree (§ 767); (§ 767).
16	(9) unlawful Unlawful imprisonment in the second degree (§ 781); (§ 781).
17	(10) coercion (§ 791); Coercion (§ 791).
18	(11) reckless Reckless burning or exploding (§ 804); (§ 804).
19	(12) eriminal Criminal mischief classified as a misdemeanor (§ 811); (§ 811).

24	(b) Those acts of domestic violence for which an offender may elect to apply for first offender status under this
25	rule shall be limited to the following criminal offenses under Title 11:

28	(3) Assault in the third degree (§ 611).
29	(4) sexual harassment (§ 763); Sexual harassment (§ 763).

36	(c) Any adult who: who meets all of the following may qualify for first offense election at the time of arraignment:
37	(1) Has not been convicted of a violent felony or any domestic violence offense under Title 11 listed in
38	subsection (a) of this section, or under any statute of the United States or of any state thereof including the District of
39	Columbia relating to a violent felony or acts of domestic violence substantially similar to those criminal offenses listed
40	in subsection (a) of this section; section.
41	(2) Has not previously been afforded first offender treatment or other diversion programs for domestic
42	violence; violence.
43	(3) Has been charged with a domestic violence offense listed in subsection (b) of this section; and section.
44	(4) Has appeared at Family Court for a bail review/domestic violence interview,-may qualify for the first
45	offense election at the time of arraignment.
46	(d) At the time of arraignment any Any person qualifying under subsection (c) of this section as a first offender
47	and who elects to apply under this section shall admit to the offense by entering a plea of guilty, as a first offender. The
48	court, without entering a judgment of guilt and with the consent of the accused, accused and the State, may defer further
49	proceedings and shall place the offender on probation for a period of 1 year upon terms and conditions of which shall
50	include: include but not be limited to:

51	(1) Enrollment with a Delaware Domestic Violence Coordinating Council certified domestic violence
52	treatment provider for the purposes of evaluation and such treatment as the evaluation counselor deems necessary
53	necessary.
54	(2) Satisfactory completion of the Delaware Domestic Violence Coordinating Council certified treatmen
55	program; <u>program.</u>
56	(3) Evaluation for alcohol and other drug abuse, and successful completion of a course of treatment as may be
57	indicated by the evaluation; evaluation.
58	(4) Restitution, where appropriate, to the victim; victim.
59	(5) No unlawful contact with the victim during the period of probation; and probation.
60	(6) Other such terms and conditions as the Court may impose.
61	Section 2. Amend Chapter 42, Title 11 of the Delaware Code by making deletions as shown by strike through and
62	insertions as shown by underline as follows:
63	§ 4218. Probation before judgement.
64	(b) This section may not be substituted for: shall not apply to any of the following:
65	(1) Any Title 11 "domestic violence" offense as defined in Section 1024(a) Section 1024 of Title 10. First
66	offenders domestic violence diversion program; program.
67	(2) Section 900A of this title. Conditional discharge for issuing a bad check as first offense; or offense.

SYNOPSIS

(3) Section 4177B of Title 21. First offenders; election in lieu of trial.

This Act updates the domestic violence first offender diversion program to allow the following offenses to be eligible for the program: assault third, terroristic threatening, and criminal contempt of a domestic violence protective order or lethal violence protective order. In addition, the Act makes these same offenses ineligible for probation before judgement in the Court of Common Pleas and Family Court.
