DELAWARE STATE SENATE 151st GENERAL ASSEMBLY

SENATE SUBSTITUTE NO. 1 **FOR** SENATE BILL NO. 65

AN ACT TO AMEND TITLE 19 OF THE DELAWARE CODE RELATING TO THE FOCUS ON ALTERNATIVE SKILLS TRAINING PROGRAM.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Chapter 34, Title 19 of the Delaware Code by making deletions as shown by strike through and
2	insertions as shown by underline as follows:
3	§ 3404. Focus on Alternative Skills Training Program.
4	(a) This section establishes the Focus on Alternative Skills Training Program ("FAST") within the Division of
5	Employment and Training. FAST provides tuition for an eligible individual for an approved non-degree credit certificate
6	program that provides industry-accepted skill training and certification.
7	(b) An individual must provide proof of all of the following to be eligible for FAST:
8	(1) That the individual is a resident of Delaware.
9	(2) That the individual has attained any of the following:
10	a. A diploma from a Delaware public, charter, or nonpublic high school, or homeschool.
11	b. A Diploma of Alternate Achievement Standards under § 152 of Title 14.
12	c. A Delaware secondary credential.
13	(3) That the individual enrolled in an approved non-degree credit certificate program no later than 24 months
14	after graduating from high school.
15	(4) If employed, a statement from the individual's employer providing the amount of financial assistance the
16	employer paid toward tuition for the non-degree credit certificate program.
17	(c)(1) The Workforce Development Board, or its successor, shall maintain a list of non-degree credit certificate
18	programs approved for FAST. The list of non-degree credit certificate programs approved for FAST must be updated
19	annually.

20	(2) The Workforce Development Board must include the following criteria in the decision to approve a non-
21	degree credit certificate program for FAST:
22	a. The skill requirements of employers in the State, including the skill needs of an in-demand industry
23	sector or occupation in the State.
24	b. The job placement rate for graduates.
25	(d) A FAST payment under this section must be made as follows:
26	(1) The total amount of FAST payments for each eligible individual may not exceed \$10,000.
27	(2) A FAST payment may not pay an individual's tuition for longer than 12 months, but multiple tuition
28	payments may be made on behalf of an individual.
29	(3) The FAST payment is equal to the difference between the full amount of tuition charged by the non-degree
30	credit certificate program and any financial assistance the individual received.
31	(4) FAST payments must be paid on a first-come, first-served basis.
32	(5) The FAST program is subject to the availability of funds appropriated for this specific purpose. This
33	subsection does not create a right or entitlement in an individual to receive a monetary payment under the
34	compensation program.
35	(e) The Department of Labor may adopt policies and procedures to implement this section.
36	Section 2. This Act is effective upon enactment and is to be implemented the earlier of the following:
37	(1) Six months from the date of the Act's enactment.
38	(2) Upon promulgation of the list of approved non-degree credit certificate programs under § 3404(c) of Titl
39	19 and the Secretary of the Department of Labor providing notice to the Registrar of Regulations, published in th
10	Register of Regulations, that this contingency has been fulfilled.
1 1	Section 3. Section 3404 of Title 19 expires 2 years after the Act's enactment into law, unless terminated of
12	extended by subsequent action of the General Assembly.
13	Section 4. The money appropriated to implement this Act, not to exceed \$1 million, shall be paid by the State
14	Treasurer out of funds in the General Fund of the State of Delaware not otherwise appropriated or eligible federal funds.

SYNOPSIS

Senate Bill No. 65 establishes the Focus on Alternative Skills Training Program ("FAST"). FAST will provide tuition assistance, to Delaware residents who have obtained a high school diploma, Diploma of Alternate Achievement Standards, or a Delaware secondary credential, which includes earning a GED, and have enrolled in an approved non-degree credit certificate program. The Workforce Development Board will create a list of non-degree credit certificate programs approved for the FAST program.

Senate Substitute No. 1 for Senate Bill No. 65 differs from Senate Bill No. 65 as follows:

- 1. Extends eligibility from 18 to 24 months after an individual graduates from high school.
- 2. Increases the maximum amount of assistance that an individual may receive from \$9,000 to \$10,000.
- 3. Allows tuition payments for up to 12 months instead of 6 months.
- 4. Requires FAST to be implemented within 6 months of enactment, instead of 1 year.
- 5. Acknowledges the expected availability of federal funds for FAST.
- 6. Sunsets FAST 2 years after enactment.
