DELAWARE STATE SENATE 151st GENERAL ASSEMBLY

SENATE BILL NO. 10

AN ACT TO AMEND TITLE 9 OF THE DELAWARE CODE RELATING TO STORMWATER MANAGEMENT DISTRICTS IN NEW CASTLE COUNTY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Part II, Title 9 of the Delaware Code by creating a new Chapter 34 by making deletions as
2	shown by strike through and insertions as shown by underline as follows:
3	Chapter 34. Stormwater Management
4	§ 3401. Definitions.
5	For purposes of this chapter:
6	(1) "Stormwater maintenance district" means an area in New Castle County, created under this chapter, that
7	has ascertainable boundaries and provides efficient and economical stormwater maintenance.
8	(2) "Stormwater management" means a system of vegetative, structural, and other measures that does all of
9	the following:
10	a. For water quantity control, controls the volume and rate of stormwater runoff which may be caused by
11	land disturbing activities or activities upon the land.
12	b. For water quality control, controls adverse effects on water quality that may be caused by land
13	disturbing activities or activities upon the land.
14	§ 3402. Establishing a stormwater maintenance district.
15	(a) County government shall adopt an ordinance implementing this chapter, that provides the procedures and
16	criteria for the establishment and operation of stormwater maintenance districts.
17	(b) Subdivisions and land developments approved after [the implementation date of this Act]. Any new
18	subdivision or land development in any unincorporated area in New Castle County that is approved after [the
19	implementation date of this Act], shall establish a stormwater maintenance district, as required by the ordinance adopted
20	under subsection (a) of this section, as a condition of plan approval. Fees for the district must not be incurred until the
21	subdivision or land development is complete and the stormwater infrastructure is approved by the appropriate regulating
22	agency.

23	(c) Subdivisions and land developments established before [the implementation date of this Act]. Any subdivision
24	or land development established before [the implementation date of this Act], in any unincorporated area in New Castle
25	County contained within ascertainable boundaries, may petition county government under the ordinance adopted under
26	subsection (a) of this section to declare the area a stormwater maintenance district.
27	(d) The county government may establish a stormwater maintenance district within an incorporated area of the
28	County under subsection (a) of this section, but only with the concurrence of the local governing body.
29	§ 3403. Public hearing.
30	(a) Upon receipt of a petition under § 3402(c) of this title from an existing subdivision or land development, the
31	county government shall hold a public hearing on the petition. The notice of the public hearing must be published at least
32	once in a newspaper published within New Castle County. The notice must be published between 10 and 21 days before the
33	public hearing and must contain all of the following:
34	(1) A description of the boundaries of the proposed stormwater maintenance district.
35	(2) A statement that the county government will hold a hearing to consider whether or not to create the
36	proposed district.
37	(3) A statement that in the event the county government decides to create the proposed stormwater
38	maintenance district, the county government will assess the unit costs of stormwater maintenance against each unit of
39	real property within the stormwater maintenance district.
40	(b) Any new subdivision or land development required to establish a stormwater maintenance district under § 3402
41	of this title is also subject to all hearing procedures and all requirements for a proposed plan as established under the New
42	Castle County Code.
43	§ 3404. Creation of stormwater maintenance district.
44	(a) If the county government determines, after the public hearing required under § 3403 of this title, that it is in the
45	public interest to establish the proposed stormwater maintenance district under the ordinance adopted under § 3402(a) of
46	this title, county government shall adopt an ordinance establishing the stormwater maintenance district.
47	(b) Except as provided under the ordinance adopted under § 3402(a) of this section, the establishment of a
48	stormwater maintenance district and the resulting infrastructure maintenance managed by New Castle County takes
49	precedence over any homeowner obligation for stormwater management included in declarations of restrictions or similar
50	development agreements. Any common open space or infrastructure within a community not maintained as part of a
51	stormwater maintenance district remains the responsibility of the homeowners.
52	§ 3405. Agreements for stormwater maintenance authorized.

53	The county government may enter into an agreement with the New Castle Conservation District or other
54	government, nonprofit, or for-profit agency or organization to maintain the stormwater infrastructure of each stormwater
55	maintenance district.
56	§ 3406. Award of contracts.
57	Either county government or the New Castle Conservation District may enter into contracts for maintenance of
58	stormwater infrastructure that cannot be completed by existing staff. All contracts entered under this section must follow
59	applicable state and local laws and policies.
60	§ 3407. Levy and collection of stormwater maintenance fee.
61	(a) In order to fund the annual and long-term costs for each stormwater maintenance district, the county
62	government shall establish a fee structure for each district and divide the annual cost, plus a pro rata administrative cost as
63	determined by the county government, by the total number of applicable units within the stormwater maintenance district to
64	arrive at the annual unit cost. The annual unit cost shall be assessed against each unit located within the boundaries of the
65	stormwater maintenance district. No parcel of real estate may be exempt from paying its annual unit cost. The established
66	fee structure does not need to be uniform among districts.
67	(b) County government shall levy and collect the annual unit cost assessed against each unit in a stormwater
68	maintenance district at the same time and in the same manner as other New Castle County taxes and the annual unit cost is
69	a lien on real property the same as other New Castle County taxes. The county government shall include this fee on tax bills
70	under the heading "stormwater maintenance fee."
71	§ 3408. Administration of funds.
72	All amounts collected under this chapter shall be paid into a fund of New Castle County as provided under the
73	ordinance adopted under § 3402(a) and all payments for stormwater maintenance shall be paid out of this fund. Should New
74	Castle County fail in any one year to collect all of the fees in the stormwater maintenance district necessary to pay the price
75	for stormwater maintenance in any year, the county government may pay the deficit out of this fund pending enforcement
76	of the lien. The county government may make payments out of this fund in anticipation of collection of the stormwater
77	maintenance fee.
78	§ 3409. Continuation and termination of contracts; consolidation of stormwater maintenance districts.
79	The county government may determine not to continue stormwater maintenance for any stormwater maintenance
80	district at the expiration of any agreement entered into under this chapter. The county government may, without further
81	public hearings, consolidate 2 or more stormwater maintenance districts into a single district.
82	§ 3410. Annual budgeting.

- (a) The annual amounts required for stormwater maintenance under this chapter must be included in the annual budget under separate headings for each stormwater maintenance district. County expenditures related to stormwater maintenance districts will be available for public review on the county government website.
- (b) After levying the stormwater maintenance fee, the county government shall deliver a separate fee collection warrant, together with a list of charges in each stormwater maintenance district, to the County Chief Financial Officer and shall command that the County Chief Financial Officer collect from the persons named in the list their stormwater maintenance fee and its amount.
- (c) Should a stormwater maintenance district be formed after the commencement of any fiscal year, the county government shall include an amount sufficient to reimburse the general fund for the expenditure during the last fiscal year in the next annual budget, as well as an amount sufficient to pay the cost for the coming fiscal year.
 - Section 2. This Act is effective immediately and implemented as follows:
 - (1) The Clerk of New Castle County Council shall provide notice, published in the Register of Regulations, that the ordinance required under § 3402(a) of Title 9 has been adopted by county government and the date this ordinance was adopted.
 - (2) The implementation date is the date the ordinance required under § 3402(a) of Title 9 was adopted, as provided under paragraph (1).

SYNOPSIS

This Act provides for the establishment of stormwater maintenance districts in New Castle County and for the collection and use of stormwater maintenance fees to help pay for maintenance in the districts. This Act is modeled on Chapter 52 of Title 9 that has allowed Kent County to create stormwater maintenance districts and differs only in format for clarity and to conform to the standards of the Delaware Legislative Drafting Manual.

Under this Act, New Castle County will adopt an ordinance that provides the procedures and criteria related to the establishment of stormwater maintenance districts. The adoption of the ordinance is required to implement this Act. Once this Act is implemented, it is mandatory that any new subdivision or land development in any unincorporated area in New Castle County establish a stormwater maintenance district, if required to do so under the implementing ordinance. Subdivisions and land developments in existence when this Act is implemented may petition the county government to declare the area a stormwater maintenance district. A stormwater maintenance district may be established within an incorporated area, but only with the concurrence of the local governing body.
