HOUSE OF REPRESENTATIVES 151st GENERAL ASSEMBLY

HOUSE BILL NO. 334

AN ACT TO AMEND TITLE 24 RELATING TO PRACTICE BY TELEHEALTH AND TELEMEDICINE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Chapter, 60, Title 24 of the Delaware Code by making insertions as shown by underlines and
2	deletions as shown by strike through as follows:
3	§ 6002. Authorization to practice by telehealth and telemedicine.
4	(a) Health-care providers licensed by the following professional boards existing under this title are authorized to
5	deliver health-care services by telehealth and telemedicine subject to the provisions of this chapter:
6	(1) The Board of Podiatry created pursuant to Chapter 5 of this title.
7	(2) The Board of Chiropractic created pursuant to Chapter 7 of this title.
8	(3) The Board of Medical Licensure and Discipline created pursuant Chapter 17 of this title.
9	(4) The State Board of Dentistry and Dental Hygiene created pursuant to Chapter 11 of this title.
10	(5) The Delaware Board of Nursing created pursuant to Chapter 19 of this title.
11	(6) The Board of Occupational Therapy Practice created pursuant to Chapter 20 of this title.
12	(7) The Board of Examiners in Optometry created pursuant to Chapter 21 of this title.
13	(8) The Board of Pharmacy created pursuant to Chapter 25 of this title.
14	(9) The Board of Mental Health and Chemical Dependency Professionals created pursuant to Chapter 30 of
15	this title.
16	(10) The Board of Examiners of Psychologists created pursuant to Chapter 35 of this title.
17	(11) The State Board of Dietetics/Nutrition created pursuant to Chapter 38 of this title.
18	(12) The Board of Social Work Examiners created pursuant to Chapter 39 of this title.
19	(b) A professional board listed in subsection (a) of this section may promulgate or revise regulations and establish
20	or revise rules applicable to health-care providers under the professional board's jurisdiction in order to facilitate the

22	(c) Health-care providers licensed in a state other than Delaware are authorized to deliver health-care services by
23	telehealth and telemedicine to patients in this State subject to the provisions of this chapter only if a health-care provider
24	patient relationship has been established pursuant to § 6003 of this title.
25	§ 6003. Scope of practice; provider-patient relationship required.
26	(a) Except for the instances listed in this chapter, health-care providers may not deliver health-care services by
27	telehealth and telemedicine in the absence of a health-care provider-patient relationship. A health-care provider-patient
28	relationship may be established either in-person or through telehealth and telemedicine but must include all of the
29	following:
30	(1) Thorough verification and authentication of the location and, to the extent possible, identity of the patient.
31	(2) Disclosure and validation of the provider's identity and credentials.
32	(3) Receipt of appropriate consent from a patient after disclosure regarding the delivery model and treatmen
33	method or limitations, including informed consent regarding the use of telemedicine technologies as required by
34	paragraph (a)(5) of this section.
35	(4) Establishment of a diagnosis through the use of acceptable medical practices, such as patient history
36	mental status examination, physical examination (unless not warranted by the patient's mental condition), and
37	appropriate diagnostic and laboratory testing to establish diagnoses, as well as identification of underlying conditions
38	or contraindications, or both, for treatment recommended or provided.
39	(5) Discussion with the patient of any diagnosis and supporting evidence as well as risks and benefits o
40	various treatment options.
41	(6) The availability of a distant site provider or other coverage of the patient for appropriate follow-up care.
42	(7) A written visit summary provided to the patient.
43	(b) Health-care services delivered by telehealth and telemedicine may be synchronous or asynchronous using
44	store-and-forward technology. Telehealth and telemedicine services may be used to establish a provider-patient relationship
45	only if the provider determines that the provider is able to meet the same standard of care as if the health-care services were
46	being provided in-person.
47	(c) Treatment and consultation recommendations delivered by telehealth and telemedicine shall be subject to the
48	same standards of appropriate practice as those in traditional (in-person encounter) settings. In the absence of a prope
49	health-care provider-patient relationship, health-care providers are prohibited from issuing prescriptions solely in response

to an internet questionnaire, an internet consult, or a telephone consult.

SYNOPSIS

This bill permits health-care providers who are licensed in a state other than Delaware to deliver health-care services by telehealth and telemedicine only if a health-care provider-patient relationship has been established in accordance with § 6003 of Title 24.
