HOUSE BILL NO. 367

AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO THE STATE COUNCIL FOR PERSONS WITH DISABILITIES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend Chapter 82, 11tle 29 of the Delaware Code by making deletions as snown by strike through and
2	insertions as shown by underline as follows:
3	§ 8210. State Council for Persons with Disabilities.
4	(a) There is hereby established a State Council for Persons with Disabilities.
5	(b) This Council shall have the following duties and responsibilities:
6	(7) Serve as a central state clearinghouse for Obtain, evaluate, and disseminate, as appropriate, information
7	and data regarding:
8	a. The current numbers of persons with disabilities and their needs;
9	b. The location, provision and availability of services and programs for persons with disabilities;
10	c. Any other relevant information and data about persons with disabilities which the council deems
11	appropriate.
12	(10) Serve as the primary brain injury council for the State. In furtherance of this role, the Council shall:
13	c. Maintain a standing brain injury committee to facilitate prevention and centralized interdisciplinary
14	planning, assessment assessment, and an approved service delivery system for individuals with brain injury
15	eomprised composed of the following members, or designees of such members:
16	4. Director of the Division of Services for Aging and Adults with Physical Disabilities;
17	(d) This Council shall consist of the following members:
18	(1) The Secretary of Health and Social Services, or a designee of the Secretary;
19	(2) The Secretary of Labor, or a designee of the Secretary;
20	(3) The Secretary of Education, or a designee of the Secretary;
21	(4) The Secretary of Services to Children, Youth and Their Families, or a designee of the Secretary;

22	(5) The following councils, committees, agencies and organizations shall elect 1 of their members to serve as
23	a member of the Council:

36	j. Council on Deaf and Hard of Hearing Equality;
37	k. Criminal Justice Council;
38	1. State Rehabilitation Advisory Council; and
39	m. Other councils, committees, agencies and organizations as approved by both the State Council for
40	Persons with Disabilities and the affected council, committee, agency or organization;
41	(5) The Secretary of Transportation, or a designee of the Secretary.

59	(7) Individuals appointed by Council to ensure that at least 50% of the total membership are individuals with

62	(k) As used in this section, "persons with disabilities" means any person who has a physical or mental impairment
63	which substantially limits 1 or more major life activities, has a record of such impairment. a person who has a physical or
64	mental impairment that substantially limits 1 or more major life activities, a person who has a history or record of such an
65	impairment, or a person who is regarded by others as having such an impairment.
66	(l) For purposes of this section, the operations and activities of the Division for the Visually Impaired and the
67	Governor's Advisory Council on the Blind shall be exempt from the purview of the State Council for Persons with
68	Disabilities. [Repealed.]

SYNOPSIS

This Act makes the State Council for Persons with Disabilities consistent with current practice by revising its responsibilities to collect data regarding persons with disabilities. This Act also amends the members of the Council and clarifies the definition of "persons with disabilities". This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
