HOUSE OF REPRESENTATIVES 151st GENERAL ASSEMBLY

HOUSE BILL NO. 32 AS AMENDED BY HOUSE AMENDMENT NO. 1

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO TRASH CONTAINERS ON HIGHWAYS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

Section 1. Amend § 1709, Title 16 of the Delaware Code by making deletions as shown by strike through and insertions as shown by underline as follows:

§ 1709. Trash containers on highways; penalty.

(a)(1) A person, by agent or otherwise, may not cause a trash container having a capacity of 2 cubic yards or greater to be placed in this State anywhere upon a highway, which means the entire width between the boundary lines, including parking spaces, berms, and shoulders, of any way or place of whatever nature open to the use of the public as a matter of right for purposes of vehicular travel, but not including a road or driveway upon grounds owned by private persons, colleges, universities, or other private institutions, unless: on a highway, unless the container has all of the following:

- (1) The container, at a minimum, has a <u>a. A</u> strip of 4-inch, red and white, high-intensity, reflective conspicuity adhesive tape <u>that is no less than 4 inches wide and</u> wrapped fully around <u>it at its midpoint</u>, <u>the midpoint of the container. The midpoint of the container is</u> between the bottom of the container and the opening at the <u>top</u>; and <u>top</u>.
- (2) The container clearly displays in letters and numbers at least 3 inches high the <u>b</u>. The name and phone number of the owner of the container, or the owner's agent. agent, in font that is no less than 3 inches high.
- (2) For purposes of this section, "highway" means a way or place open to the use of the public as a matter of right for purposes of vehicular travel and includes the entire width between the boundary lines of the way or place, including parking spaces, berms, and shoulders. "Highway" does not mean a road or driveway on grounds owned by private persons, colleges, universities, or other private institutions.
- (b) A violation of this section is punishable by a fine of (1) An owner of a container that refuses, fails, or neglects to comply with this section is subject to a civil penalty in an amount that is not less than \$50 nor or more than \$500.

(2) Any law-enforcement officer, as defined under § 9702 of this title, may enforce this section.
