HOUSE AMENDMENT NO. 1

AN ACT TO AMEND TITLES 14 AND 29 OF THE DELAWARE CODE RELATING TO LEAVE FOR STATE EMPLOYEES, TEACHERS AND SCHOOL EMPLOYEES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

| 1 | Section 1. Amend Chapter 51, Title 29 of the Delaware Code by inserting a new section as follows: |

| 2 | "Section. 5121. Leave for bone marrow or organ donation. |
| 3 | (a) Definitions: |
| 4 | (1) 'Bone marrow' means the soft material that fills human bone cavities; |
| 5 | (2) 'Bone marrow donor' means a person from whose body bone marrow is taken to be |
| 6 | transferred to the body of another person. |
| 7 | (3) 'Organ' means a human organ that is capable of being transferred from the body of a |
| 8 | person to the body of another person; |
| 9 | (4) 'Organ donor' means a person from whose body an organ is taken to be transferred to the |
| 10 | body of another person. |
| 11 | (b) In any calendar year, a state employee is entitled to the following leave in order to serve as a bone- |
| 12 | marrow donor or organ donor: |
| 13 | (1) No more than seven days of leave to serve as a bone-marrow donor; |
| 14 | (2) No more than thirty days of leave to serve as an organ-donor. |
| 15 | (c) A state employee may use the leave provided by this section without loss or reduction of pay, leave |
| 16 | to which the employee is otherwise entitled, credit for time or service, or performance or efficiency |
| 17 | rating. |

| 18 | (d) This section applies to employees who are included in a collective bargaining unit, unless a |

| 21 | Section 2. Amend Chapter 13, Title 14 of the Delaware Code by inserting a new section as follows: |
| 22 | "Section 1318B. Leave for bone marrow or organ donation. |
| 23 | (a) Definitions. As used in this section: |
| 24 | (1) 'Bone marrow' means the soft material that fills the human bone cavities; |
| 25 | (2) 'Bone marrow donor' means a person from whose body bone marrow is taken to be |
| 26 | transferred to the body of another person; |
| 27 | (3) 'Organ' means a human organ that is capable of being transferred from the body of a |
| 28 | person to the body of another person; |
| 29 | (4) 'Organ donor' means a person from whose body an organ is taken to be transferred to the |
| 30 | body of another person. |
| 31 | (b) In any calendar year, a teacher or school employee is entitled to the following leave in order to |
| 32 | serve as a bone marrow donor or organ donor: |
| 33 | (1) No more than seven days of leave to serve as a bone-marrow donor; |
| 34 | (2) No more than thirty days of leave to serve as an organ-donor. |
| 35 | (c) A teacher or school employee may use the leave provided by this section without loss or reduction |
| 36 | of pay, leave to which the teacher or employee is otherwise entitled, credit for time or service, or |
| 37 | performance or efficiency rating. |
| 38 | (d) This section applies to teachers and school employees who are included in a collective bargaining |
| 39 | unit, unless a collective bargaining agreement contains provisions dealing with leave for bone-marrow |
| 40 | donation and organ donation." |
