SENATE BILL NO. 146

AN ACT TO AMEND TITLE 18 OF THE DELAWARE CODE RELATING TO LICENSING OF INSURANCE AGENTS, BROKERS, AND OTHER LICENSEES OF THE INSURANCE DEPARTMENT.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

- Section 1. Amend Chapter 17 of Title 18 of the Delaware Code by striking said Chapter 17 in its entirety and inserting in

29	§1701.	Purpose and Scope.	
30	(a) Thi	is chapter governs the qualifications and procedures for the licensing of insurance producers, surplus lines	
31	brokers, fraternal representatives, adjusters, apprentice adjusters, property damage appraisers, apprentice property damage		
32	appraisers, and temporary licensees. This chapter shall apply to all lines of insurance including, but not limited to, life,		
33	health, variable annuity and variable life, property, casualty, surety, title, credit, personal lines, travel, transportation and		
34	marine, and to all types of insurers, whether operating on a mutual, stock, reciprocal, fraternal, group or other plan.		
35	It simplifies and organizes some statutory language to improve efficiency, permits the use of new technology and reduces		
36	costs associated with issuing and renewing insurance licenses.		
37	(b) Thi	is chapter shall establish the qualifications for granting licenses to professional insurance personnel and	
38	establish the pro	cedures to be followed in determining the initial and continuing qualifications for such personnel to	
39	provide definition	ons of their authorities, duties, responsibilities and prohibitions, in a manner that will provide guidance to	
40	such personnel a	and control over such personnel by the Commissioner of Insurance for the benefit and protection of the	
41	citizens of the S	tate.	
42	(c) All	transactions entered into by a surplus lines broker shall also be subject to Chapter 19 of this Title.	
43	§1702.	Definitions	
44	(a) 'Ad	ljuster' means a licensee of the Department who, as an independent contractor, or on behalf of an	
45	independent con	tractor, insurer, self-insurer, producer, or managing general agent, investigates and/or negotiates	

settlement of claims arising under insurance contracts.

47	(b) 'Agent of the Insurer' means a licensed producer of the Department appointed by an insurer to sell, solicit or
48	negotiate applications for policies of insurance on its behalf and, if authorized to do so by the insurer, to issue conditional
49	receipts.
50	(c) 'Appraiser' means a licensee of the Department who assesses property damage to motor vehicles.
51	(d) 'Apprentice' means a licensee of the Department who is qualified in all respects as an adjuster or appraiser,
52	except as to experience, education, and/or training.
53	(e) 'Broker of Insured' means a licensed producer of the Department who for compensation negotiates on behalf
54	of others contracts for insurance from companies to whom he or she is not appointed.
55	(f) 'Business entity' means a corporation, association, partnership, limited liability company, limited liability
56	partnership, or other legal entity.
57	(g) 'Fraternal Representative' means a licensee of the Department who is appointed or authorized to act for a
58	society of fraternal organization to sell, solicit or negotiate, or making of a life insurance, accident, and health insurance
59	or annuity contract, for no compensation except as specifically exempted from this requirement by § 6233 of this Title.
60	(h) 'Home state' means the District of Columbia and any state or territory of the United States in which an
61	insurance producer maintains his or her principal place of residence or principal place of business and is licensed to act as
62	an insurance producer.
63	(i) 'Insurance producer' means a person required to be licensed under the laws of this State to sell, solicit or
64	negotiate contracts of insurance or annuity or the lines of authority authorized within the scope of such license. For the
65	purposes of Title 18, Delaware Code, the term 'insurance agent,' 'insurance broker,' and 'insurance consultant' shall be
66	used interchangeably with the term 'insurance producer'.
67	(j) 'License' means a document issued by this State's Insurance Commissioner authorizing a person to act as an
68	insurance producer for the lines of authority specified in the document. The license itself does not create any authority,
69	actual, apparent or inherent, in the holder to represent or commit an insurance carrier.
70	(k) 'Limited line credit insurance' includes credit life, credit disability, credit property, credit unemployment,
71	involuntary unemployment, mortgage life, mortgage guaranty, mortgage disability, guaranteed automobile protection
72	(gap) insurance, and any other form of insurance offered in connection with an extension of credit that is limited to
73	partially or wholly extinguishing that credit obligation that the Insurance Commissioner determines should be designated

a form of limited line credit insurance.

- (l) 'Limited line credit insurance producer' means a person who sells, solicits or negotiates one or more forms of limited line credit insurance coverage to individuals through a master, corporate, group or individual policy.
- (m) 'Limited lines insurance' means those lines of insurance defined in Section 1707 (b) or any other line of insurance that the Insurance Commissioner deems necessary to recognize for the purposes of complying with Section 1708 (e).
- (n) 'Limited lines producer' means a person authorized by the Insurance Commissioner to sell, solicit or negotiate limited lines insurance.
- (o) 'Negotiate' means the act of conferring directly with or offering advice directly to a purchaser or prospective purchaser of a particular contract of insurance concerning any of the substantive benefits, terms or conditions of the contract, provided that the person engaged in that act either sells insurance or obtains insurance from insurers for purchasers.
 - (p) 'Person' means an individual or a business entity.
- (q) 'Revocation' means recalling or taking back an insurance license(s) for a minimum period of 12 months. Any insurer appointments of such license shall likewise be revoked. No individual whose license is revoked shall be issued another license without first complying with all requirements of Title 18 <u>Del. C.</u> §1706
- (r) 'Sell' means to exchange a contract of insurance by any means, for money or its equivalent, on behalf of an insurance company.
- (s) 'Solicit' means attempting to sell insurance or asking or urging a person to apply for a particular kind of insurance from a particular company.
- (t) 'Suspension' means to bar temporarily the privileges of an insurance license(s), granted under Chapter 17 of Title 18 of the Delaware Code, for a maximum of 12 months. A suspension shall also include a suspension of the appointment of such licensee. Upon the expiration of the suspension period and upon satisfactory completion of such terms and conditions as the Commissioner has imposed pursuant to the suspension, all licenses and appointments shall be reinstated.
- (u) 'Terminate' means the cancellation of the relationship between an insurance producer and the insurer or the termination of a producer's authority to transact insurance.

101	(v) 'Travel Accident & Baggage licensee' means a limited line producer of the Department who is a ticket-
102	selling agent or other representative of a common carrier who solicits over-the-counter, short-term, non-renewable, travel
103	accident ticket policies and baggage insurance
104	(w) 'Uniform Business Entity Application' means the current version of the NAIC Uniform Business Entity
105	Application for resident and nonresident business entities.
106	(x) 'Uniform Application' means the current version of the NAIC Uniform Application for resident and
107	nonresident producer licensing.
108	§1703. License Required
109	A person shall not sell, solicit or negotiate insurance in this State for any class or classes of insurance unless the
110	person is licensed for that line of authority in accordance with this Chapter.
111	§1704. Exceptions to Licensing
112	(a) Nothing in this Chapter shall be construed to require an insurer to obtain an insurance producer license. In
113	this section, the term "insurer" does not include an insurer's officers, directors, employees, subsidiaries or
114	affiliates.
115	(b) A license as an insurance producer shall not be required of the following:
116	(1) An officer, director or employee of an insurer or of an insurance producer, provided that the
117	officer, director or employee does not receive any commission on policies written or sold to insure risks
118	residing, located or to be performed in this state and:
119	a. The officer, director or employee's activities are executive, administrative, managerial,
120	clerical or a combination of these, and are only indirectly related to the sale, solicitation or
121	negotiation of insurance; or
122	b. The officer, director or employee's function relates to underwriting; or
123	c. The officer, director or employee is acting in the capacity of a special agent or agency
124	supervisor assisting insurance producers where the person's activities are limited to providing
125	technical advice and assistance to licensed insurance producers and do not include the sale,
126	solicitation or negotiation of insurance;
127	(2) A person who secures and furnishes information for the purpose of group life insurance, group
128	property and casualty insurance, group annuities, group or blanket accident and health insurance; or for

129 the purpose of enrolling individuals under plans; issuing certificates under plans or otherwise assisting 130 in administering plans; or performs administrative services related to mass marketed property and 131 casualty insurance; where no commission is paid to the person for the service; 132 (3) An employer or association or its officers, directors, employees, or the trustees of an employee 133 trust plan, to the extent that the employers, officers, employees, director or trustees are engaged in the 134 administration or operation of a program of employee benefits for the employer's or association's own 135 employees or the employees of its subsidiaries or affiliates, which program involves the use of 136 insurance issued by an insurer, as long as the employers, associations, officers, directors, employees or 137 trustees are not in any manner compensated, directly or indirectly, by the company issuing the contracts; 138 **(4)** Employees of insurers or organizations employed by insurers who are engaging in the rating or 139 classification of risks, or in the supervision of the training of insurance producers and who are not 140 individually engaged in the sale, solicitation or negotiation of insurance; 141 A person whose activities in this state are limited to advertising without the intent to solicit (5) 142 insurance in this state through communications in printed publications or other forms of electronic mass 143 media whose distribution is not limited to residents of the state, provided that the person does not sell, 144 solicit or negotiate insurance that would insure risks residing, located or to be performed in this state; 145 (6) A person who is not a resident of this state who sells, solicits or negotiates a contract of 146 insurance for commercial property and casualty risks to an insured with risks located in more than one 147 state insured under that contract, provided that that person is otherwise licensed as an insurance 148 producer to sell, solicit or negotiate that insurance in the state where the insured maintains its principal 149 place of business and the contract of insurance insures risks located in that state; or 150 A salaried full-time employee who counsels or advises his or her employer relative to the (7) 151 insurance interests of the employer or of the subsidiaries or business affiliates of the employer provided 152 that the employee does not sell or solicit insurance or receive a commission. 153 §1705. Application for Examination 154 (a) A resident individual applying for an insurance producer license shall pass a written examination unless 155 exempt pursuant to § 1709. The examination shall test the knowledge of the individual concerning the lines of authority

156	for which application is made, the duties and responsibilities of an insurance producer, general insurance knowledge,
157	insurance ethics as established by the Commissioner and the insurance laws and regulations of this state.
158	(b) The Insurance Commissioner may make arrangements for administration and grading by an independent
159	testing service as specified by contract.
160	(c) An individual who fails to appear for the examination as scheduled or fails to pass the examination, shall
161	reapply for an examination and remit all required fees and forms before being rescheduled for another examination.
162	Reexamination. The failure of an applicant to pass an examination or the failure to appear for the examination or to take
163	or complete the examination does not preclude the applicant from taking subsequent examinations.
164	(d) All examination score reports are valid for a period of 12 months from the date of examination.
165	§1706. Application for License
166	(a) A person applying for a resident insurance producer license shall make application to the Insurance
167	Commissioner on the Uniform Application or on forms prescribed by the Commissioner for license types and lines of
168	authority not available on the Uniform Application and declare under penalty of refusal, suspension or revocation of the
169	license that the statements made in the application are true, correct and complete to the best of the individual's knowledge
170	and belief. Before approving the application, the Insurance Commissioner shall find that the individual:
171	(1) Is at least eighteen (18) years of age;
172	(2) Has not committed any act that is a ground for denial, suspension or revocation set forth in § 1712;
173	(3) Has paid the fees set forth in Title 18 Delaware Code, Chapter 7; and
174	(4) Has successfully passed the examinations for the lines of authority for which the person has applied
175	unless specifically exempted from such examination by this chapter.
176	(b) Each resident application shall further contain a statement of the applicant's criminal history, which the
177	applicant shall obtain from the Delaware State Bureau of Identification pursuant to § 8513(a)(2) of Title 11 of the
178	Delaware Code.
179	(c) Every applicant for a license as an apprentice adjuster or apprentice property damage appraiser must file with
180	the Commissioner a certification from one holding a license as an adjuster or property damage appraiser in which said
181	holder of the license assumes responsibility for the applicant's training and for all actions undertaken by the applicant
182	pursuant to the requested license.

183	(d) Every applicant for a license as an agent for the line of variable annuity must hold a license as a life
184	insurance agent and must be registered with the National Association of Security Dealers.
185	(e) All premiums, return premiums, or other funds received in any manner by a producer or a surplus lines
186	broker shall be held in a fiduciary capacity and shall be accounted for by such producer or surplus lines broker. The
187	producer or surplus lines broker shall, in the ordinary course of business, pay the funds to the insured or his assignee,
188	insurer, insurance premium finance company or agent entitled to the payment.
189	(f) Change in residency status.
190	(1) A licensed nonresident agent, after becoming a Delaware resident, may retain authority under the
191	nonresident agent license for a maximum of 60 days or until a resident license is issued, whichever occurs first,
192	and at which time all authority granted under the nonresident license shall cease.
193	(2) A licensed resident agent, after becoming a resident of another state, may retain authority in
194	Delaware under the resident agent license for a maximum of sixty (60) days or until a nonresident license is
195	issued, whichever occurs first, and at which time all authority granted under the resident license shall cease.
196	(3) Criteria used by the Commissioner to establish residency shall include, but not be limited to:
197	a. Jurisdiction for payment of state taxes.
198	b. Jurisdiction for automobile driver's license and motor vehicle registration.
199	c. Location of voter registration.
200	d. Location of principal residence, such as owned or rented dwelling, condominium or
201	apartment; and
202	e. Location of principal place of business.
203	(g) A business entity acting as an insurance producer is required to obtain an insurance producer license.
204	Application shall be made using the Uniform Business Entity Application or on forms prescribed by the Commissioner
205	for license types and lines of authority not available on the Uniform Business Entity Application. Before approving the
206	application, the Insurance Commissioner shall find that:
207	(1) The business entity has paid the fees set forth in Title 18 Delaware Code, Chapter 7; and
208	(2) The business entity has designated a licensed producer responsible for the business entity's
209	compliance with the insurance laws rules and regulations of this state

210	(h) The Insurance Commissioner may require any documents reasonably necessary to verify the information
211	contained in an application.
212	(i) Each insurer that sells, solicits or negotiates any form of limited line credit insurance shall provide to each
213	individual whose duties will include selling, soliciting or negotiating limited line credit insurance a program of instruction
214	that may be approved by the Insurance Commissioner.
215	§1707. License
216	(a) Unless denied licensure pursuant to § 1712, persons who have met the requirements of § 1705 and § 1706
217	shall be issued an insurance producer license. An insurance producer may receive qualification for a license in one or
218	more of the following lines of authority:
219	(1) Life insurance coverage on human lives including benefits of endowment and annuities, and may
220	include benefits in the event of death or dismemberment by accident and benefits for disability income as defined
221	in § 902 of this Title.
222	(2) Accident and health or sickness insurance coverage for sickness, bodily injury or accidental death
223	and may include benefits for disability income as defined in § 903 of this Title.
224	(3) Property insurance coverage for the direct or consequential loss or damage to property of every kind
225	as defined in § 904 of this Title.
226	(4) Casualty insurance coverage against legal liability, including that for death, injury or disability or
227	damage to real or personal property as defined in § 906 of this Title.
228	(5) Variable life and variable annuity products insurance coverage provided under variable life
229	insurance contracts and variable annuities.
230	(6) Personal lines property and casualty insurance coverage sold to individuals and families for
231	noncommercial purposes.
232	(7) Fidelity and surety, as defined in § 905 of this Title.
233	(8) Marine and transportation insurance, as defined in § 907 of this Title.
234	(9) Title insurance, as defined in § 908 of this Title.
235	(10) Any other line of insurance permitted under state laws or regulations.
236	(b) Limited lines producer may be qualified and licensed and a qualified producer may hold one or more of the
237	following limited lines of authority:

238	(1) Credit insurance lines.
239	(2) Life insurance or annuity products used solely to fund a pre-arranged funeral program.
240	(3) Travel Accident & Baggage.
241	(4) Any other limited line of insurance permitted under state laws or regulations.
242	(5) A property damage appraiser's license shall convey authority for the appraisal of damage to motor
243	vehicles as defined in 21 <u>Del</u> . <u>C</u> . § 101.
244	(c) An adjuster's license shall convey authority to investigate and negotiate settlement of claims on behalf of
245	licensed agents, brokers, self-insurers, or insurers in one or more of the following lines of insurance:
246	(1) Property insurance.
247	(2) Casualty insurance.
248	(3) Fidelity and surety insurance.
249	(4) Automobile insurance.
250	(5) Marine and transportation insurance.
251	(d) An insurance producer license shall remain in effect unless revoked or suspended as long as the fee set forth
252	in Title 18 Delaware Code, Chapter 7 is paid and education requirements for resident individual producers are met by the
253	due date.
254	(e) An individual insurance producer who allows his or her license to lapse may, within twelve (12) months
255	from the due date of the renewal fee, reinstate the same license without the necessity of passing a written examination.
256	However, a penalty in the amount of double the unpaid renewal fee shall be required for any renewal fee received after the
257	due date and within the first grace period of six (6) months from the due date of the renewal fee; and may be subject to a
258	civil fine of not less than \$200 and not more than \$1,000 within the second grace period of six (6) months after the due
259	date of the first grace period.
260	(f) A licensed insurance producer who is unable to comply with license renewal procedures due to military
261	service or some other extenuating circumstance (e.g., a long-term medical disability) may request a waiver of those
262	procedures. The producer may also request a waiver of any examination requirement or any other fine or sanction
263	imposed for failure to comply with renewal procedures.

- (g) The license shall contain the licensee's name, address, personal identification number, and the date of issuance, the lines of authority, the expiration date and any other information the Insurance Commissioner deems necessary.
- (h) Licensees shall inform the Insurance Commissioner by any means acceptable to the Insurance Commissioner of a change of address within thirty (30) days of the change. Failure to timely inform the Insurance Commissioner of a change in legal name or address shall result in a penalty pursuant to § 1712(D) of this Act.
- (i) The Commissioner may issue a new license for any lost, stolen, or destroyed license issued pursuant to this Chapter upon written request from the licensee and payment of appropriate fees for such duplicate license.

 In order to assist in the performance of the Insurance Commissioner's duties, the Insurance Commissioner may contract with non-governmental entities, including the National Association of Insurance Commissioners (NAIC) or any affiliates or subsidiaries that the NAIC oversees, to perform any ministerial functions, including the collection of fees, related to producer licensing that the Insurance Commissioner and the non-governmental entity may deem appropriate.
- (j) The Commissioner may participate, in whole or in part, with the NAIC, or any affiliates or subsidiaries the NAIC oversees, in a centralized producer license registry where insurance producer licenses and appointments may be centrally or simultaneously effected for all states that require an insurance producer license and participate in such centralized producer license registry. If the Commissioner finds that participation in such a centralized producer license registry is in the public interest, the Commissioner may adopt by rule any uniform standards and procedures as necessary to participate in the registry. This includes the central collection of all fees for licenses or appointments that are processed through the registry.

(k) Records

(1) The licensee shall maintain at his/her principal place of business the license issued by the Commissioner, together with such records as may be reasonably required by the Commissioner. Such records shall show, for each policy or contract placed or countersigned by or through the licensee, names of the insurers, insureds, policy number, expiration date thereof, premium payable under the terms of the policy or contract, and such other information as the Commissioner may, from time to time, require. Records shall be retained and available for inspection by the Commissioner for a period of three years.

§1708. Nonresident Licensing

291	(a)	Unless denied licensure pursuant to 1712, a nonresident person shall receive a nonresident producer
292		license if:
293		(1) The person is currently licensed as a resident and in good standing in his or her home state; and
294		(2) The person has submitted the proper request for licensure and has paid the fees required by
295		Title 18 Delaware Insurance Code Chapter 7. Notwithstanding any other provision of the Title,
296		every applicant for a nonresident license shall be subject to the same fees as a resident applicant;
297		and
298		(3) The person has submitted or transmitted to the Insurance Commissioner the application for
299		licensure that the person submitted to his or her home state, or in lieu of the same, a completed
300		Uniform Application or on forms prescribed by the Commissioner for license types and lines of
301		authority not available on the Uniform Application; and
302		(4) The person's home state awards non-resident producer licenses to residents of this state on the
303		same basis.
304		(5) Except where prohibited by state or federal law, by submitting an application for license, the
305		applicant shall be deemed to have appointed the Commissioner as the agent for service of process
306		on the applicant in any action or proceeding arising in this State out of or in connection with the
307		exercise of the license. Such appointment of the Commissioner as agent for service of process shall
808		be irrevocable during the period within which a cause of action against the applicant may arise out
309		of transactions with respect to subjects of insurance in this State. Process shall be served upon the
310		Commissioner or any Deputy Insurance Commissioner or such other person(s) as the
311		Commissioner shall designate by rule or regulation.
312	(b) The Insu	rance Commissioner may verify the producer's licensing status through the Producer Database
313	maintained by the Na	tional Association of Insurance Commissioners, its affiliates or subsidiaries.
314	A nonresident produc	er who moves from one state to another state or a resident producer who moves from this state to
315	another state shall file	e a change of address and provide certification from the new resident state within thirty (30) days of
316	the change of legal re	sidence. No license fee or license application is required.
317	(c) Notwiths	standing any other provision of this Chapter, a person licensed as a surplus lines broker in his or her

home state shall receive a nonresident surplus lines broker license pursuant to Subsection (a) of this section. Except as to

- (d) Notwithstanding any other provision of this Chapter, a person licensed as a limited line credit insurance or other type of limited lines producer in his or her home state shall receive a nonresident limited lines producer license, pursuant to Subsection (a) of this section, granting the same scope of authority as granted under the license issued by the producer's home state. For the purposes of § 1708 (e), limited line insurance is any authority granted by the home state which restricts the authority of the license to less than the total authority prescribed in the associated major lines pursuant to § 1707 (a)(1) through (6).
- (e) Miscellaneous Limited Line Insurance: Insurance for an insurer authorized to do business in Delaware which is permitted as a limited line of insurance in a Delaware nonresident producer's home state and is not described in this section shall have the same scope of authority as granted under the limited license issued by the producer's resident state which shall be briefly described on the license issued.

§1709. Exemption from Examination

- (a) An individual who applies for an insurance producer license in this state who was previously licensed for the same lines of authority in another state shall not be required to complete any prelicensing education or examination. This exemption is only available if the person is currently licensed in that state or if the application is received within ninety (90) days of the cancellation of the applicant's previous license and if the prior state issues a certification that, at the time of cancellation, the applicant was in good standing in that state or the state's Producer Database records, maintained by the National Association of Insurance Commissioners, its affiliates or subsidiaries, indicate that the producer is or was licensed in good standing for the line of authority requested.
- (b) A person licensed as an insurance producer in another state who moves to this state shall make application within ninety (90) days of establishing legal residence to become a resident licensee pursuant to § 1706. No prelicensing education or examination shall be required of that person to obtain any line of authority previously held in the prior state except where the Insurance Commissioner determines otherwise by regulation.
- (c) Every applicant for a license as a producer for title insurance who is an attorney licensed to practice law in this state.
 - (d) Every applicant for a license as a Travel Accident & Baggage licensee.

§1710. Assumed Names

An insurance producer doing business under any name other than the producer's legal name is required to notify the Insurance Commissioner prior to using the assumed name.

§1711. Temporary Licensing

- (a) The Insurance Commissioner may issue a temporary insurance producer license for a period not to exceed one hundred eighty (180) days without requiring an examination if the Insurance Commissioner deems that the temporary license is necessary for the servicing of an insurance business in the following cases:
 - (1) To the surviving spouse or court-appointed personal representative of a licensed insurance producer who dies or becomes mentally or physically disabled to allow adequate time for the sale of the insurance business owned by the producer or for the recovery or return of the producer to the business or to provide for the training and licensing of new personnel to operate the producer's business;
 - (2) To a member or employee of a business entity licensed as an insurance producer, upon the death or disability of an individual designated in the business entity application or the license;
 - (3) To the designee of a licensed insurance producer entering active service in the armed forces of the United States of America; or
 - (4) In any other circumstance where the Insurance Commissioner deems that the public interest will best be served by the issuance of this license.
- (b) The Insurance Commissioner may by order limit the authority of any temporary licensee in any way deemed necessary to protect insureds and the public. The Insurance Commissioner may require the temporary licensee to have a suitable sponsor who is a licensed producer or insurer and who assumes responsibility for all acts of the temporary licensee and may impose other similar requirements designed to protect insureds and the public. The Insurance Commissioner may by order revoke a temporary license if the interest of insureds or the public are endangered. A temporary license may not continue after the owner or the personal representative disposes of the business.

§1712. License Denial, Nonrenewal or Revocation

(a) The Insurance Commissioner may place on probation, suspend, revoke or refuse to issue or renew an insurance producer's license or may levy a penalty in accordance with § 1712 (d) or any combination of actions, for any one or more of the following causes:

374	(1) Providing incorrect, misleading, incomplete or materially untrue information in the license
375	application;
376	(2) Violating any insurance laws, or violating any regulation, subpoena or order of the Insurance
377	Commissioner or of another state's Insurance Commissioner;
378	(3) Obtaining or attempting to obtain a license through misrepresentation or fraud;
379	(4) Improperly withholding, misappropriating or converting any monies or properties received in the
380	course of doing insurance business;
381	(5) Intentionally misrepresenting the terms of an actual or proposed insurance contract or application
382	for insurance;
383	(6) Having been convicted of a felony;
384	(7) Having admitted or been found to have committed any insurance unfair trade practice or fraud;
385	(8) Using fraudulent, coercive, or dishonest practices, or demonstrating incompetence,
386	untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere;
387	(9) Having an insurance producer license, or its equivalent, denied, suspended or revoked in any other
388	state, province, district or territory;
389	(10) Forging another's name to an application for insurance or to any document related to an insurance
390	transaction;
391	(11) Improperly using notes or any other reference material to complete an examination for an
392	insurance license;
393	(12) Knowingly accepting insurance business from an individual who is not licensed;
394	(13) Failing to comply with an administrative or court order imposing a child support obligation; or
395	(14) Failing to pay state income tax or comply with any administrative or court order directing payment
396	of state income tax.
397	(b) In the event that the action by the Insurance Commissioner is to nonrenew or to deny an application for a
398	license, the Insurance Commissioner shall notify the applicant or licensee and advise, in writing, the applicant or licensee
399	of the reason for the denial or nonrenewal of the applicant's or licensee's license. The applicant or licensee may make
400	written demand upon the Insurance Commissioner within ten (10) days for a hearing before the Insurance Commissioner
401	to determine the reasonableness of the Insurance Commissioner's action. The hearing shall be held within twenty (20)

days and shall be held pursuant to the Administrative Procedures Act, 29 <u>Del</u>. <u>C</u>. §101 et seq. and such additional implemented regulations as may be published by the Commissioner.

- (c) The license of a business entity may be suspended, revoked or refused if the Insurance Commissioner finds, after hearing, that an individual licensee's violation was known or should have been known by one or more of the partners, officers or managers acting on behalf of the partnership or corporation and the violation was neither reported to the Insurance Commissioner nor corrective action taken.
- (d) In addition to or in lieu of any applicable denial, suspension or revocation of a license, a person may, after hearing, be subject to a fine of not less than \$200 and not more than \$20,000 for each such violation. The Commissioner's order shall specify the date upon which such fine shall be paid and shall revoke the license of any licensee failing to comply with such order. The date on which payment shall be due shall be not less than thirty (30) days following the date of the Commissioner's order unless otherwise specified in the order. The Commissioner may institute a civil action to recover fines so levied and shall pay over all fines paid and recovered to the State Treasurer.
- (e) The Insurance Commissioner shall retain the authority to enforce the provisions of and impose any penalty or remedy authorized by this chapter and Title 18 Delaware Code against any person who is under investigation for or charged with a violation of this chapter or Title 18 Delaware Code even if the person's license or registration has been surrendered or has lapsed by operation of law. The Commissioner may, upon his or her discretion reinstate a suspended license at any time, and may impose as conditions upon the reinstatement such terms and conditions as the Commissioner determines appropriate.
- (f) The Commissioner may place any individual, or business entity on probation for a period of one year for violation of any insurance laws, rules, regulations and orders. The probationary period will not exceed one (1) year. Until such person shall qualify for licensing in accordance with the applicable provisions of this Title. A person whose license has been revoked or suspended on two occasions shall not again be licensed under this Title.
 - §1713. Conservation of producer business.
- (a) If the Commissioner finds that the business of any licensed producer in this State has become financially impaired or insolvent, or has been abandoned by the licensee, or has been conducted in such a manner as to require or justify revocation of the licenses of that licensee, and if the Commissioner further finds that the conservation and administration of the business of the licensee would be in the public interest, he/she shall file in the Court of Chancery in

soliciting or negotiating insurance in this state if that person is required to be licensed under this chapter and is not so

(b) A person shall not accept a commission, service fee, brokerage or other valuable consideration for selling,

in this state if the person was required to be licensed under this chapter at the time of the sale, solicitation or negotiation and was so licensed at that time.

- (c) An insurer or insurance producer may pay or assign commissions, service fees, brokerages or other valuable consideration to an insurance agency or to persons who do not sell, solicit or negotiate insurance in this state, unless the payment would violate Title 18 Delaware Code, § 2303 and § 2304.
- (d) No producer acting as a consultant may accept any fee, commission, or other consideration from an insurer for any activity for which the producer acting as a consultant has received or will receive a fee from his/her client.

 An insurer or insurance producer shall not pay a commission, service fee, brokerage or other valuable consideration to a person for selling, soliciting or negotiating insurance in this state if that person is required to be licensed under this chapter and is not so licensed. Nothing in this section allows an insurer to pay commissions to a non-appointed insurance producer when an appointment is otherwise required.

§1715. Appointments

- (a) An insurance producer shall not act as an agent of an insurer unless the insurance producer becomes an appointed agent of that insurer. An insurance producer who is not acting as an agent of an insurer is not required to become appointed.
- (b) To appoint a producer as its agent, the appointing insurer shall file, in a format approved by the Insurance Commissioner, a notice of appointment within fifteen (15) days from the date the agency contract is executed or the first insurance application is submitted. An insurer may also elect to appoint a producer to all or some insurers within the insurer's holding company system or group by the filing of a single appointment request. The group appointment provision of this section is only applicable upon implementation by this Department of an electronic appointment process.
- (c) Upon receipt of the notice of appointment, the Insurance Commissioner shall verify within a reasonable time not to exceed thirty (30) days that the insurance producer is eligible for appointment. If the insurance producer is determined to be ineligible for appointment, the Insurance Commissioner shall notify the insurer within five (5) days of its determination.
- (d) An insurer shall pay an appointment fee, in the amount and method of payment set forth in Title 18 Delaware Code, Chapter 7, for each insurance producer appointed by the insurer.
 - §1716. Notification to Insurance Commissioner of Termination

- (b) Termination Without Cause. An insurer or authorized representative of the insurer that terminates the appointment, employment, or contract with a producer for any reason not set forth in § 1712, shall notify the Insurance Commissioner within thirty (30) days following the effective date of the termination, using a format prescribed by the Insurance Commissioner. Upon written request of the Insurance Commissioner, the insurer shall provide additional information, documents, records or other data pertaining to the termination.
- (c) Ongoing Notification Requirement. The insurer or the authorized representative of the insurer shall promptly notify the Insurance Commissioner in a format acceptable to the Insurance Commissioner if, upon further review or investigation, the insurer discovers additional information that would have been reportable to the Insurance Commissioner in accordance with Subsection A had the insurer then known of its existence.
 - (d) Copy of Notification to be Provided to Producer.
 - (1) Within fifteen (15) days after making the notification required by Subsections A, B and C, the insurer shall mail a copy of the notification to the producer at his or her last known address. If the producer is terminated for cause for any of the reasons listed in § 1712, the insurer shall provide a copy of the notification to the producer at his or her last known address by certified mail, return receipt requested, postage prepaid or by overnight delivery using a nationally recognized carrier.
 - (2) Within thirty (30) days after the producer has received the original or additional notification, the producer may file written comments concerning the substance of the notification with the Insurance Commissioner. The producer shall, by the same means, simultaneously send a copy of the comments to the reporting insurer, and the comments shall become a part of the Insurance Commissioner's file and accompany every copy of a report distributed or disclosed for any reason about the producer as permitted under Subsection F.

(e) Immunities.

(1) In the absence of actual malice, an insurer, the authorized representative of the insurer, a producer,
the Insurance Commissioner, or an organization of which the Insurance Commissioner is a member and
that compiles the information and makes it available to other Insurance Commissioners or regulatory or
law enforcement agencies shall not be subject to civil liability, and a civil cause of action of any nature
shall not arise against these entities or their respective agents or employees, as a result of any statement
or information required by or provided pursuant to this section or any information relating to any
statement that may be requested in writing by the Insurance Commissioner, from an insurer or producer;
or a statement by a terminating insurer or producer to an insurer or producer limited solely and
exclusively to whether a termination for cause under Subsection (a) was reported to the Insurance
Commissioner, provided that the propriety of any termination for cause under Subsection (a) is certified
in writing by an officer or authorized representative of the insurer or producer terminating the
relationship.

- (2) In any action brought against a person that may have immunity under Paragraph (1) for making any statement required by this section or providing any information relating to any statement that may be requested by the Insurance Commissioner, the party bringing the action shall plead specifically in any allegation that Paragraph (1) does not apply because the person making the statement or providing the information did so with actual malice.
- (3) Paragraph (1) or (2) shall not abrogate or modify any existing statutory or common law privileges or immunities.

(f) Confidentiality.

(1) Any documents, materials or other information in the control or possession of the Department of Insurance that is furnished by an insurer, producer or an employee or agent thereof acting on behalf of the insurer or producer, or obtained by the Insurance Commissioner in an investigation pursuant to this section shall be confidential by law and privileged, shall not be subject to Chapter 100 of Title 29, shall not be subject to subpoena, and shall not be subject to discovery or admissible in evidence in any private civil action. However, the Insurance Commissioner is authorized to use the documents, materials or

539	other information in the furtherance of any regulatory or legal action brought as a part of the Insurance
540	Commissioner's duties.
541	(2) Neither the Insurance Commissioner nor any person who received documents, materials or other
542	information while acting under the authority of the Insurance Commissioner shall be permitted or
543	required to testify in any private civil action concerning any confidential documents, materials, or
544	information subject to Paragraph (1).
545	(3) In order to assist in the performance of the Insurance Commissioner's duties under this Chapter, the
546	Insurance Commissioner:
547	a. May share documents, materials or other information, including the confidential and
548	privileged documents, materials or information subject to Paragraph (1), with other state,
549	federal, and international regulatory agencies, with the National Association of Insurance
550	Commissioners, its affiliates or subsidiaries, and with state, federal, and international law
551	enforcement authorities, provided that the recipient agrees to maintain the confidentiality and
552	privileged status of the document, material or other information;
553	b. May receive documents, materials or information, including otherwise confidential and
554	privileged documents, materials or information, from the National Association of Insurance
555	Commissioners, its affiliates or subsidiaries and from regulatory and law enforcement officials
556	of other foreign or domestic jurisdictions, and shall maintain as confidential or privileged any
557	document, material or information received with notice or the understanding that it is
558	confidential or privileged under the laws of the jurisdiction that is the source of the document,
559	material or information; and
560	c. May enter into agreements governing sharing and use of information consistent with this
561	subsection.
562	d. No waiver of any applicable privilege or claim of confidentiality in the documents,
563	materials, or information shall occur as a result of disclosure to the Commissioner under this
564	section or as a result of sharing as authorized in Paragraph (3).
565	e. Nothing in this Chapter shall prohibit the Insurance Commissioner from releasing final,
566	adjudicated actions including for cause terminations that are open to public inspection pursuant

567	to Chapter 100 of Title 29 to a database or other clearinghouse service maintained by the
568	National Association of Insurance Commissioners, its affiliates or subsidiaries of the National
569	Association of Insurance Commissioners.
570	f. Penalties for Failing to Report. An insurer, the authorized representative of the insurer, or
571	producer that fails to report as required under the provisions of this section or that is found to
572	have reported with actual malice by a court of competent jurisdiction may, after notice and
573	hearing, have its license or certificate of authority suspended or revoked and may be fined in
574	accordance with Title 18 Delaware Code.
575	§1717. Reciprocity
576	(a) The Insurance Commissioner shall waive any requirements for a nonresident license applicant with a valid
577	license from his or her home state, except the requirements imposed by § 1708 of this chapter, if the applicant's home
578	state awards nonresident licenses to residents of this state on the same basis.
579	(b) A nonresident producer's satisfaction of his or her home state's continuing education requirements for
580	licensed insurance producers shall constitute satisfaction of this state's continuing education requirements if the
581	nonresident producer's home state recognizes the satisfaction of its continuing education requirements imposed upon
582	producers from this state on the same basis.
583	§1718. Additional or Continuing Education
584	In addition to meeting the standards prescribed in other sections of this chapter for the issuance of a license, the
585	Commissioner may promulgate regulations and/or prerequisites which will establish reasonable standards and criteria for
586	requiring additional or continuing education of licensees, in order to ensure the maintenance or improvement of a
587	licensee's insurance skills and knowledge. Failure to provide proof of meeting continuing education requirements may
588	result in suspension of license(s).
589	§1719. Reporting of Actions
590	(a) A producer shall report to the Insurance Commissioner any administrative action taken against the producer
591	in another jurisdiction or by another governmental agency in this state within (30) thirty days of the final disposition of

the matter. This report shall include a copy of the order, consent to order or other relevant legal documents.

593	(b) Within thirty (30) days of the initial pretrial hearing date, a producer shall report to the Insurance
594	Commissioner any criminal prosecution of the producer taken in any jurisdiction. The report shall include a copy of the
595	initial complaint filed, the order resulting from the hearing and any other relevant legal documents.
596	§1720. Regulations
597	The Insurance Commissioner may promulgate reasonable regulations as are necessary or proper to carry out the
598	purposes of this chapter.
599	§1721. Enforcement after license, lapses or is surrendered
600	The Commissioner shall retain authority to enforce the provisions of, and impose any penalty or remedy
601	authorized by, this chapter and title against any person who is under investigation for, or charged with, a violation of thi
602	chapter and title even if, while the investigation or charges are pending, such person's license, or registration is
603	surrendered or lapses by operation of law.
604	§1722. Severability
605	If any provisions of this chapter, or the application of a provision to any person or circumstances, shall be held
606	invalid, the remainder of the chapter, and the application of the provision to persons or circumstances other than those to
607	which it is held invalid, shall not be affected.
608	§1723. Effective Date
609	This Chapter shall take effect March 1, 2002.

SYNOPSIS

This Bill replaces the current Insurance Department Statute for agent, broker and other licensees of the Department and creates a system of reciprocity for producer licensing and creates uniform standards for key areas of producer licensing. It complies with Public Law 106-102 (the Gramm-Leach-Bliley Act) which mandates that a majority of the states 1) enact uniform laws and regulations governing the licensure of individuals and entities authorized to sell and solicit the purchase of insurance within the state or 2) enact reciprocity laws and regulations governing the licensure of nonresident individuals and entities authorized to sell and solicit insurance within those states. If states do not enact such uniform laws and regulations or enact a system of reciprocal licensing by November 12, 2002, the National Association of Registered Agents and Brokers will be established to provide a mechanism through which uniform licensing, appointment, continuing education and other insurance producer sales qualification requirements and conditions can be adopted and applied on a multistate basis and Delaware will lose regulatory oversight.

This Bill when adopted will preserve the authority of Delaware to license insurance producers. It creates a system of reciprocity for producer licensing and creates a more uniform and efficient system of producer licensing.
