## DELAWARE STATE SENATE 150th GENERAL ASSEMBLY

## SENATE BILL NO. 9

AN ACT TO AMEND THE LAWS OF DELAWARE RELATING TO BOND AND CAPITAL IMPROVEMENTS ACTS OF THE STATE OF DELAWARE AND CERTAIN OF THEIR AUTHORITIES FOR THE FISCAL YEARS ENDING JUNE 30, 2018 AND JUNE 30, 2019.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

- 1 Section 1. Amend Chapter 303, Volume 81 of the Laws of Delaware by adding a new Section 160 by making 2 deletions as shown by strike through and insertions as shown by underline as follows:
- 3 Section 160. Community Transportation Funds. Notwithstanding any provision of Title 29 to the contrary, the
- 4 Delaware Department of Transportation is hereby authorized to use Community Transportation Funds for a one-time
- 5 reimbursement to each of the following:
- 6 1. The Devonshire Civic Association, in the amount of \$1,800 for snow removal reimbursement.
- 7 The Little Creek Volunteer Fire Company, in the amount of \$50,000 for purchase of a command vehicle. 2.
- 8 The Smyrna Volunteer Fire Company, in the amount of \$50,000 for purchase of a command vehicle.
- 9 The Clayton Volunteer Fire Company, in the amount of \$50,000 for purchase of a command vehicle. 4.
- 10 5 The Delaware SPCA-Newark, in the amount of \$9,974 for an entrance sign.
- 11 Section 2. Amend Chapter 303, Volume 81 of the Laws of Delaware by adding a new Section 161 by making
- 12 deletions as shown by strike through and insertions as shown by underline as follows:
- 13 Section 161. Approquinimink School District Transfer. The Approquinimink School District, with the approval
- 14 of the Secretary of Education, the Director of the Office of Management and Budget and the Controller General, is
- 15 authorized to transfer non-obligated major capital improvement funds from the Whitehall Elementary School project (CN
- 1829 C) to the Fairfield Campus project (CN 1829 D) to address increased costs attributable to extraordinary site conditions 16
- 17 encountered at the Fairfield Campus project.

48 Section 165. Approquinimink School District Conveyances. Notwithstanding the provisions of 14 Del. C. § 49 1057, the Approquinimink School District (the "District") is authorized to convey approximately 28.19 ± acres of land being 50 generally known as Silver Lake Park which is currently a portion of New Castle County tax parcel number 23-009.00-162 51 to the Mayor and Council of the Town of Middletown ("Middletown") in exchange for the conveyance by Middletown to 52 the District of a 24.81± acre parcel of land having New Castle County tax parcel number 23-057.00-002 to be used for a 53 public purpose which is adjacent to the District's Brick Elementary School facility. Middletown shall be responsible for 54 obtaining all required approvals to subdivide the 28.19 ± acre parcel from New Castle County tax parcel 23-009.00-162 as 55 well as the payment of transaction costs incurred by Middletown associated with the property to be conveyed by the 56 District. Middletown shall receive the  $28.19 \pm \text{acre parcel in "as is" condition.}$ 

## **SYNOPSIS**

This Act amends the Fiscal Years 2018 and 2019 Bond and Capital Improvements Acts to (1) authorize the Department of Transportation to use Community Transportation Funds for one-time reimbursements for various projects; (2) allow the transfer of funds between capital projects for the Appoquinimink School District; (3) authorize a transfer of funds from the Office of Management and Budget for other listed projects; (4) revise the fund amount for the Garashes L Project and expand the use of funds for road projects at the Wilmington Riverfront Sports Project; (5) authorize funding from the Delaware Strategic Fund when interest earnings are not available for the New Castle County and Middletown Chamber of Commerce's business incubators; (6) authorize the Delaware National Guard to use appropriated funds for the 198th Readiness Center Facilities and Georgetown Readiness Center and 7) authorize the conveyance of property between the Appoquinimink School District and the Town of Middletown.
