DELAWARE STATE SENATE

143rd GENERAL ASSEMBLY

SENATE BILL NO. 30

AN ACT ESTABLISHING THE SEED SCHOLARSHIP PROGRAM AT DELAWARE TECHNICAL AND COMMUNITY COLLEGE.

1 WHEREAS, the General Assembly finds that providing the opportunity to achieve a college degree can serve as an incentive for  
2 high school students to stay in school, achieve good grades and graduate; and

3 WHEREAS, the General Assembly finds that providing the opportunity for Delaware students to achieve a college degree will  
4 result in demonstrable economic development benefits to the State in the form of a larger, more diverse, highly skilled workforce;  
5 and

6 WHEREAS, many Delaware students who have the opportunity to pursue a college degree will be the first in their families to go to  
7 college; and

8 WHEREAS, Delaware Technical and Community College provides a quality curriculum for Delaware students in all three counties  
9 of Delaware;

10 NOW THEREFORE:

11 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

12 Section 1. Amend Chapter 34, Title 14 of the Delaware Code by adding thereto a new subchapter, designated as  
13 Subchapter XIV, which new subchapter shall read as follows:

14 “SUBCHAPTER XIV. THE DELAWARE STUDENT EXCELLENCE EQUALS DEGREE ACT

15 §3401A. Purpose.

16 There is hereby created the Delaware Student Excellence Equals Degree, hereafter referred to as “SEED”, Program. Under  
17 this subchapter, qualified, college-bound state resident students are relieved of the burden of paying undergraduate tuition at  
18 Delaware Technical and Community College provided that these students meet the criteria set forth in this Act and are pursuing  
19 studies leading to an associate degree at Delaware Technical and Community College. Students who qualify under this Act shall  
20 not have to repay the State of Delaware because it is the intent and purpose of the Delaware General Assembly, through this  
21 subchapter, to help ensure that Delaware students stay in high school, excel academically, and have better access to higher  
22 education regardless of a family’s financial circumstances and therefore payments under this Program shall be grants, not loans.

23 §3402A. Definitions.

24 The following words, terms and phrases, when used in this Act, shall have the meaning ascribed to them except where the  
25 context clearly indicates a different meaning:

26 (a) ‘Family’ for a dependent applicant shall mean the applicant, the applicant’s parents or legal guardian, relative  
27 caregiver, and other children under the age of twenty-one of the applicant’s parents, legal guardian or relative caregiver. The term  
28 ‘family’ for an independent applicant shall mean the applicant, an applicant’s spouse and any dependent children.

29 (b) “Institution” shall mean Delaware Technical and Community College.

30 (c) “Full time” shall mean a minimum of 24 credit hours in each academic year.

31 (d) “Academic Year” shall mean the three consecutive academic semesters beginning with the fall semester.

32 §3403A. Administration.

33 (a) This subchapter shall be administered by the Institution.

34 (b) The Institution shall adopt such rules and regulations as it deems necessary and proper to the administration of this  
35 subchapter.

36 (c) The Institution shall annually report to the General Assembly of the State the names of those students enrolled in the  
37 SEED Program and the total amount of expenditures made under this subchapter.

38 §3404A. Eligibility.

39 To be eligible to participate in the Delaware SEED Program and to qualify for a grant to pay tuition by the State of  
40 Delaware pursuant to this subchapter for the first semester or other academic unit of post-secondary enrollment at Delaware  
41 Technical and Community College, a student shall meet all of the following:

42 (a) A student shall be eligible for such grant that satisfies the Delaware residency requirements as set forth in the  
43 Institution's residency policy and is enrolled on a full time, degree seeking basis.

44 (b) The student shall not have been convicted of any crime and no criminal proceedings shall be pending against the  
45 student, other than misdemeanor traffic violations, and the student and his or her parent, legal guardian or relative caregiver shall  
46 certify such fact.

47 (c) A student shall have applied for all appropriate forms of financial aid for which the student is eligible including, but  
48 not limited to, the Federal Pell Grant, financial aid programs administered by the Delaware Higher Education Commission, and  
49 financial aid programs administered by Delaware Technical and Community College, and shall have accepted all such financial  
50 assistance offered or awarded to the student, except for loans.

51 (d) A student shall have graduated from a Delaware public or non-public high school with a minimum cumulative average  
52 of 80% or higher or equivalent G.P.A. of 2.5 or higher on a 4.0 scale.

53 (e) A student shall have satisfied admission standards as determined by Delaware Technical and Community College for  
54 entering students; provided, however, that no student participating in the Delaware SEED Program shall be admitted into Delaware  
55 Technical and Community College by special admission standards.

56 (f) A student shall be admitted and attend classes at the Institution no later than the fall semester immediately after the  
57 student's graduation from high school.

58 §3405A. Grant Awards/Operations.

59 The Institution shall establish and implement procedures to award grants to eligible students subject to appropriations for  
60 such purpose, including, but not limited to, a procedure to determine priority among applicants in the event that the amount of  
61 grants requested by eligible applicants exceeds the appropriation, which may include consideration of financial need and academic  
62 achievement. Grant awards shall not exceed the available appropriation for each fiscal year. Grant awards shall be disbursed as  
63 follows:

64 (a) Beginning with the 2006-2007 academic year, tuition assistance shall be provided to qualifying applicants in an  
65 amount equal to the following:

66 (1) A grant recipient receiving no other financial assistance specifically designated for tuition and/or other  
67 regularly assessed fees with the exception of loans shall receive a grant equal to the full amount of tuition charged by the  
68 Institution.

(2) A grant recipient receiving other financial assistance specifically designated for tuition and other regularly assessed fees shall receive a grant equal to the difference between the amount of tuition charged by the Institution and the amount of the other financial assistance.

(3) If, as a result of applying for federal and state student financial aid, or through other means, it becomes apparent that deliberate fraud was involved in the application process, the Institution may reevaluate the recipient's eligibility for grant assistance, and may withdraw a grant award. Any grant award made as the result of deliberate fraud may be recovered by the State through an action at law.

#### §3406A. Maintaining Eligibility.

(a) To maintain continued state payment of tuition once enrolled at Delaware Technical and Community College, the student shall meet all of the following:

(1) Make steady academic progress toward an associate degree, earning not less than the minimum number of hours of credit required for full-time standing in each academic year.

(2) Maintain continuous enrollment for not less than two semesters in each successive academic year, unless granted an exception for cause by the institution.

(3) Have a cumulative grade point average of at least 2.5 calculated on a 4.0 scale at the end of the first academic year and thereafter maintain such a cumulative grade point average. The Institution may grant exceptions upon appeal.

(4) The student and family shall certify that the student has no criminal record in any jurisdiction, not including misdemeanor traffic violations, and is not under the probation of any court of law in any jurisdiction.

(b) Grants made by the SEED Program shall not be allowed for courses or other post-secondary units repeated or taken in excess of the requirements for completion of an associate degree with the exception of those courses required by the Institution for program admission.

(c) Students are eligible to participate in this program for a period not to exceed six continuous semesters, not including the summer semester.

#### §3407A. Disbursement.

(a) Funds awarded from this program shall be disbursed on a semester by semester basis upon receipt of enrollment verification.

(b) No disbursement on behalf of an individual student, pursuant to this subchapter, shall be greater than the tuition charged by the institution.

#### §3408A. Additional Responsibilities.

98 (a) The Institution shall develop, promote, and coordinate a public awareness program to inform students and parents of  
99 the Delaware SEED Program.

100 (b) The Department of Education shall ensure that every school district, and each charter and non-public high school,  
101 designates at least one SEED Program contact person, who shall be either a counselor or teacher, at each high school site in this  
102 State.”

103 Section 2. The Delaware SEED Program shall be available to those Delaware students graduating from high school in the school  
104 year 2005-2006.

#### SYNOPSIS

This Act creates the Delaware Student Excellence Equals Degree (SEED) Program. The goal of this Act is to encourage Delaware students to stay in school, avoid contact with the criminal justice system, excel academically, and have access to higher education regardless of a family’s financial circumstances. Specifically, this program provides a tuition scholarship for eligible students enrolling on a full time basis in pursuit of an associate’s degree at Delaware Technical and Community College directly after graduating from high school. The program will be effective for students graduating in the 2005-2006 school year.
