SENATE BILL NO. 30

AN ACT ESTABLISHING THE SEED SCHOLARSHIP PROGRAM AT DELAWARE TECHNICAL AND COMMUNITY COLLEGE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

- WHEREAS, the General Assembly finds that providing the opportunity to achieve a college degree can serve as
- 2 an incentive for high school students to stay in school, achieve good grades and graduate; and
- 3 WHEREAS, the General Assembly finds that providing the opportunity for Delaware students to achieve a college
- 4 degree will result in demonstrable economic development benefits to the State in the form of a larger, more diverse, highly
- 5 skilled workforce; and
- 6 WHEREAS, many Delaware students who have the opportunity to pursue a college degree will be the first in their
- 7 families to go to college; and
- 8 WHEREAS, Delaware Technical and Community College provides a quality curriculum for Delaware students in
- 9 all three counties of Delaware;
- 10 NOW THEREFORE:
- 11 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

12	Section 1. Amend Chapter 34, Title 14 of the Delaware Code by adding thereto a new subchapter, designated as
13	Subchapter XIV, which new subchapter shall read as follows:
14	"SUBCHAPTER XIV. THE DELAWARE STUDENT EXCELLENCE EQUALS DEGREE ACT
15	§3401A. Purpose.
16	There is hereby created the Delaware Student Excellence Equals Degree, hereafter referred to as "SEED",
17	Program. Under this subchapter, qualified, college-bound state resident students are relieved of the burden of paying
18	undergraduate tuition at Delaware Technical and Community College provided that these students meet the criteria set forth
19	in this Act and are pursuing studies leading to an associate degree at Delaware Technical and Community College.
20	Students who qualify under this Act shall not have to repay the State of Delaware because it is the intent and purpose of the
21	Delaware General Assembly, through this subchapter, to help ensure that Delaware students stay in high school, excel
22	academically, and have better access to higher education regardless of a family's financial circumstances and therefore
23	payments under this Program shall be grants, not loans.
24	§3402A. Definitions.
25	The following words, terms and phrases, when used in this Act, shall have the meaning ascribed to them except
26	where the context clearly indicates a different meaning:
27	(a) 'Family' for a dependent applicant shall mean the applicant, the applicant's parents or legal guardian, relative
28	caregiver, and other children under the age of twenty-one of the applicant's parents, legal guardian or relative caregiver.
29	The term 'family' for an independent applicant shall mean the applicant, an applicant's spouse and any dependent children.
30	(b) "Institution" shall mean Delaware Technical and Community College.
31	(c) "Full time" shall mean a minimum of 24 credit hours in each academic year.
32	(d) "Academic Year" shall mean the three consecutive academic semesters beginning with the fall semester.
33	§3403A. Administration.
34	(a) This subchapter shall be administered by the Institution.
35	(b) The Institution shall adopt such rules and regulations as it deems necessary and proper to the administration of
36	this subchapter.
37	(c) The Institution shall annually report to the General Assembly of the State the names of those students enrolled
38	in the SEED Program and the total amount of expenditures made under this subchapter.
39	§3404A. Eligibility.

40 To be eligible to participate in the Delaware SEED Program and to qualify for a grant to pay tuition by the State of 41 Delaware pursuant to this subchapter for the first semester or other academic unit of post-secondary enrollment at Delaware 42 Technical and Community College, a student shall meet all of the following: 43 (a) A student who satisfies the Delaware residency requirements set forth in the Institution's residency policy 44 shall be eligible for such grant if that student is enrolled on a full time, degree seeking basis or is a student with a disability 45 seeking a degree through the Institution's academic accommodation policy. 46 (b) The student shall not have been convicted of any felony and no felony criminal proceedings shall be pending 47 against the student, and the student and his or her parent, legal guardian, or relative caregiver shall certify such fact. 48 (c) A student shall have applied for all appropriate forms of financial aid for which the student is eligible 49 including, but not limited to, the Federal Pell Grant, financial aid programs administered by the Delaware Higher Education 50 Commission, and financial aid programs administered by Delaware Technical and Community College, and/or the 51 University of Delaware, and shall have accepted all such financial assistance offered or awarded to the student, except for 52 loans. 53 (d) A student shall have graduated from a Delaware public or non-public high school with a minimum cumulative 54 average of 80% or higher or equivalent G.P.A. of 2.5 or higher on a 4.0 scale. 55 (e) A student shall have satisfied admission standards as determined by Delaware Technical and Community 56 College for entering students or as determined by the University of Delaware for the Associates in Arts Program; provided, 57 however, that no student participating in the Delaware SEED Program shall be admitted into Delaware Technical and 58 Community College by special admission standards. 59 (f) A student shall be admitted and attend classes at the Institution no later than the fall semester immediately after 60 the student's graduation from high school. 61 (g) The Institution shall create and implement equivalency standards for subsections (d) and (f) of this section in 62 establishing eligibility of Delaware home schooled students for grants under the Delaware SEED Program. 63 §3405A. Grant Awards/Operations. 64 The Institution shall establish and implement procedures to award grants to eligible students subject to

appropriations for such purpose, including, but not limited to, a procedure to determine priority among applicants in the event that the amount of grants requested by eligible applicants exceeds the appropriation, which may include consideration of financial need and academic achievement. Grants shall also be available for the Associates in Arts Program courses

- 97 (c) Students are eligible to participate in this program for a period not to exceed six continuous semesters, not 98 including the summer semester. 99 §3407A. Disbursement. 100 (a) Funds awarded from this program shall be disbursed on a semester by semester basis upon receipt of 101 enrollment verification. 102 (b) No disbursement on behalf of an individual student, pursuant to this subchapter, shall be greater than the 103 tuition charged by the institution. 104 §3408A. Additional Responsibilities. 105 (a) The Institution shall develop, promote, and coordinate a public awareness program to inform students and 106 parents of the Delaware SEED Program. 107 (b) The Department of Education shall ensure that every school district, and each charter and non-public high 108 school, designates at least one SEED Program contact person, who shall be either a counselor or teacher, at each high
- 110 Section 2. The Delaware SEED Program shall be available beginning with the school year 2005-2006.

SYNOPSIS

This Act creates the Delaware Student Excellence Equals Degree (SEED) Program. The goal of this Act is to encourage Delaware students to stay in school, avoid contact with the criminal justice system, excel academically, and have access to higher education regardless of a family's financial circumstances. Specifically, this program provides a tuition scholarship for eligible students enrolling on a full time basis in pursuit of an associate's degree at Delaware Technical and Community College or through the Associates in Arts Program. The program will be effective for students graduating in the 2005-2006 school year.
