#### HOUSE BILL NO. 362

# AN ACT TO AMEND TITLE 6 OF THE DELAWARE CODE RELATING TO COMMERCE AND TRADE.

Section 1: Amend Title 6 of the Delaware Code by adding thereto a new chapter as follows:

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

2	"CHAPTER 25C. TOY SAFETY
3	This Chapter may be cited as the 'Children's Toy Safety Act'.
4	§ 2501C. Definitions.
5	As used in this Chapter, unless the context otherwise requires:
6	(1) 'Child' shall be defined as an individual less than 12 years of age.
7	(2) 'Consumer' shall have the meaning as set forth in the Consumer Product Safety Act, 15 U.S.C.
8	§§ 2051 - 2085.
9	(3) 'Person' means an individual, partnership, corporation, association, governmental entity,
10	business entity, or other legal entity.
11	(4) 'Toxic substance' means: a substance that contains lead, or a coating on an item that contains
12	lead where the lead content is more than 0.04% of the total weight; 1,4-Butanediol; or a substance that
13	has been deemed toxic or harmful to the health of children by the Consumer Product Safety Commission,
14	or another state or federal agency. Toxic substance does not include glass or crystal decorative
15	components.
16	(5) 'Toy' means an article designed and made for the amusement of a child or for the child's use in
17	play.
18	§ 2502C. Prohibited Conduct.
19	(1) A person shall not sell, offer for sale, or transfer a toy in the State of Delaware that contains a
20	toxic substance or that is otherwise unsafe to a child.

21	(2) A person shall not knowingly fail to remove for sale or transfer any toy that has been identified
22	as containing lead and/or unsafe or has been the subject of a recall, as described more fully at § 2503C(2)
23	(3) This section does not apply to the sale of an antique or collectible toy that is not marketed to or
24	intended to be used by a child.
25	§ 2503C. Criteria.
26	A toy will be deemed unsafe if it meets one or more of the following criteria:
27	(1) The toy does not conform to all state and federal laws and regulations setting forth
28	standards for the toy;
29	(2) The toy has been recalled by a state or federal agency, the toy's manufacturer,
30	distributor, or importer, or the toy has been listed by the U.S. Consumer Product Safety Commission as a
31	recalled product; and the recall has not been rescinded; or
32	(3) A state or federal agency has issued a warning that a toy's intended use constitutes a safety
33	hazard and such warning has not been rescinded.
34	§ 2504C. Penalties.
35	(1) Except as otherwise provided in § 2502C, a person who violates this Chapter is subject to the
36	following:
37	(A) If the person is not an individual consumer, a civil fine of not more than
38	\$100.00 per incident not to exceed \$5,000.00 total.
39	(B) If the person is not an individual consumer and the violation is the person's
40	second offense under this Chapter, a civil fine of not more than \$500.00 per incident not to
41	exceed \$25,000.00 total.
42	(C) If the person is not an individual consumer and the violation is the person's
43	third or subsequent offense under this part, a civil fine of not more than \$1,000.00 per incident
44	not to exceed \$50,000.00 total.
45	(D) If a person knowingly violates this Chapter and the person is not an individual
46	consumer, a civil fine equal to three (3) times the amount in the preceding subsection (C).
47	(2) A civil fine imposed under this section shall be waived if it is determined that a person acted in
48	good faith to be in compliance with this Chapter, pursued compliance with due diligence, and promptly
49	corrected any noncompliance after discovery of the violation.

§ 2506C. Child Care Facilities.				
	(1)	Such regulations, as they relate to standards and requirements for licensure and approval of child care		
		facilities, which shall include daycare centers, family daycare homes, public and private nursery		
		schools, preschools and kindergartens, family foster care facilities, placement agency facilities, group		
		care facilities, and temporary shelter facilities shall be required to certify that no unsafe toys or toys		
		containing a toxic substance are being used or kept on the premises, with the exception that antique		

or collectible children's products may be kept if they are not used by, or accessible to, any child in

the child care facility."

This Act, which shall hereafter be referred to as the "Children's Toy Safety Act", prohibits the sale or distribution of toys that are harmful to and threaten the health of our children in the State of Delaware.
