## HOUSE OF REPRESENTATIVES 144th GENERAL ASSEMBLY

## HOUSE BILL NO. 402

AN ACT TO AMEND THE CHARTER OF THE TOWN OF FENWICK ISLAND, DELAWARE, CHAPTER 302, VOLUME 49, LAWS OF DELAWARE, AS AMENDED, ENTITLED "AN ACT TO INCORPORATE THE TOWN OF FENWICK ISLAND, DELAWARE", TO AMEND SECTION 6, ELECTIONS, SECTION 7, NOMINATIONS AND SECTION 9, QUALIFICATIONS OF VOTERS, TO CONFORM WITH STATE LAW AND CLARIFY CERTAIN PROVISIONS CONTAINED THEREIN.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

1 Section 1. Amend Section 6 of the Charter of the Town of Fenwick Island, Chapter 302, Volume 49, Laws of 2 Delaware, as amended, by striking the phrase "so long as he or she is qualified to vote" as it appears therein and 3 substituting in lieu thereof the phrase "so long as he or she holds the requirements to be a candidate". 4 Section 2. Amend Section 7 of the Charter of the Town of Fenwick Island, Chapter 302, Volume 49, Laws of 5 <u>Delaware</u>, as amended, by striking the third and fourth sentence thereof and substituting in lieu thereof the following: 6 "Voting machines shall be utilized during Annual Municipal Elections in compliance with the applicable 7 provisions of 15 Del. C. § 7501, et seq.". 8 Section 3. Further Amend Section 7 of the Charter of the Town of Fenwick Island, Chapter 302, Volume 49, Laws of Delaware, as amended by striking the following: "Any qualified voter may cast his vote by absentee ballot if he is 9 10 unable to appear at the polling place because of being: 11 (1) In the public service of the United States or of this State; or 12 (2) In the Armed Forces of the United States or the Merchant Marine of the United States, or attached to and serving with the Armed Forces of the United States in the American Red Cross, Society of Friends, or 13 United Service Organization; or 14 15 Unavoidably absent from the Town of Fenwick Island on the day of the annual municipal election; or (3) 16 Sick or physically disabled." in its entirety and substituting in lieu thereof the following: (4) 17 "The Town may, by ordinance, provide for any qualified voter to cast an absentee ballot if such person is unable to 18 appear and cast his, her, or its ballot.". 19 Section 4. Further Amend Section 7 of the Charter of the Town of Fenwick Island, Chapter 302, Volume 49,

27	A.	Voter q	ualifications.
28		(1)	Resident: Every natural person, who is a citizen of the United States, age 18 or before the date
29			of the election, a bona fide resident of the Town as of March 1 prior to the annual municipal
30			election, and registered to vote, if provided by ordinance, shall have one (1) vote.
31		(2)	Non-residents. Every property owner as of March 1 prior to the annual municipal election,
32			whether a natural person or artificial entity, including but not limited to corporations,
33			partnerships, trusts, and limited liability companies, and who is registered to vote, if provided by
34			ordinance, shall have one (1) vote. A natural person shall be a citizen of the United States and
35			age 18 on or before the date of the election. An artificial entity shall be a domestic entity in the
36			State of Delaware.
37		(3)	These provisions shall be construed in accordance with the principle of 'one-person/entity, one
38			vote'. Where a voter is entitled to vote by virtue of being both a resident and as an owner of real
39			property, that voter shall be entitled to only one (1) vote; where a voter is entitled to vote by
40			ownership of two (2) or more parcels of real property, that voter shall be entitled to only one (1)
41			vote.
42		(4)	Any legal entity, other than a natural person entitled to vote, must cast its vote by a duly
43			executed and notarized power of attorney from the legal entity granting the authority to cast its
44			vote to its designated attorney-in-fact. Such power of attorney shall be surrendered to the
45			election officials who shall file the same in the office of the Town. Such power of attorney so
46			filed shall constitute conclusive evidence of the right of said person to vote in the election on
47			behalf of the legal entity granting the power. The person casting the ballot for such entity shall
48			be age 18 on or before the date of the election and a citizen of the United States.

## **SYNOPSIS**

This Act amends the Charter for the Town of Fenwick Island, to comply with changes to 15 <u>Del. C.</u> § 7501, et seq., enacted by the 143<sup>rd</sup> General Assembly concerning municipal elections and the 144<sup>th</sup> General Assembly concerning absentee voting, to provide for a registration procedure and to clarify and modify voter qualifications.
