DESCRIPTION:	AN ACT TO AMEND TITLE 7 OF THE DELAWARE CODE RELATING TO CHANGES TO AIR QUALITY PERMITTING FEE STRUCTURE FOR NATURAL MINOR PERMITS.

In accordance with 29 Del. C. §913, the following information is provided relating to licenses and fees.

Description of the Legislation:

This Act authorizes the Department of Natural Resources and Environmental Control (DNREC) to update the air quality permitting fee structure for natural minor permits. The schedule of fees established in this Act is the first of a phased fee adjustment necessary to establish a self-sustaining permitting program. The first phase of increases is expected to create revenue equivalent to 50% of the current program costs. Future phased evaluations will occur with recommended adjustments to fund 75% and 100% of the program costs respectively.

Affected Entities:

The affected entities of this Act are DNREC, and businesses that apply for air quality permits for equipment, facility, or device which has the potential to discharge air contaminants into the atmosphere.

Fiscal Impact:

This Act establishes the following fees to be collected by DNREC:

Currently, DNREC collects approximately 25% of the program costs (\$165,000) through existing fees. DNREC estimates that \$370,000, or 50% of the program costs will be collected upon implementation of the fee increases established in this Act.

Intended Use of Revenue:

The revenue will be deposited to DNREC and used to support the department's responsibilities concerning the Natural Minor Permitting Program.
