HOUSE BILL NO. 210

AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE PROVIDING FOR REAPPORTIONMENT OF THE STATE LEGISLATIVE DISTRICTS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend Chapter 8, Title 29 of the Delaware Code by striking §801 in its entirety and substituting in lieu  
2 thereof the following:

3 “§801. Composition of the House of Representatives.

4 The House of Representatives shall be composed of 41 members who shall be chosen to hold office for 2 years.  
5 The state shall be divided into 41 representative districts, from each of which shall be chosen, by the qualified electors  
6 thereof, 1 Representative.”.

7 Section 2. Amend Chapter 8, Title 29 of the Delaware Code by striking §821 in its entirety and substituting in lieu  
8 thereof the following:

9 “§821. Boundaries of the General Assembly House of Representative districts.

10 (a) The boundaries of the General Assembly House of Representative districts shall be described as follows:

11 (1) First Representative District. The 1st Representative District shall comprise: All that portion of City of  
12 Wilmington and New Castle County bounded by a line beginning at the point of intersection of Marsh Rd.  
13 and I- 95, and proceeding southerly along Marsh Rd. to Philadelphia Pike, and proceeding westerly along  
14 Philadelphia Pike to Edgemoor Rd., and proceeding easterly along Edgemoor Rd. to Governor Pritz Blvd.,  
15 and proceeding westerly along Governor Pritz Blvd. to Northwest Blvd., and proceeding westerly along  
16 Northwest Blvd. to E. 30<sup>th</sup> St., and proceeding westerly along E. 30<sup>th</sup> St. to Danby St., and proceeding  
17 southerly along Danby St. to Jessup St., and proceeding southerly along Jessup St. to Pine St., and  
18 proceeding westerly along Pine St. to Brandywine Crk., and proceeding northerly along Brandywine Crk.  
19 to I-95, and proceeding northerly along I-95 to the point of beginning.

20 (2) Second Representative District. The 2nd Representative District shall comprise: All that portion of New  
21 Castle County bounded by a line beginning at the point of intersection of the Brandywine Crk. and I-95,  
22 and proceeding southerly along the Brandywine Crk. to Pine St., and proceeding easterly along Pine St. to

23 Jessup St., and proceeding northerly along Jessup St. to Danby St., and proceeding northerly along Danby  
24 St. to E. 30th St., and proceeding easterly along E. 30th St. to Northeast Blvd., and proceeding easterly  
25 along Northeast Blvd. to Governor Printz Blvd., and proceeding easterly along Governor Printz Blvd. to  
26 Edgemoor Rd., and proceeding southerly along Edgemoor Rd. to I- 495, and proceeding westerly along I-  
27 495 to shoreline of Shellpot Crk., and proceeding southerly along shoreline of Shellpot creek to the  
28 Edgemoor/Wilmington census designated place/city line, and proceeding easterly along the  
29 Edgemoor/Wilmington census designated place/city line to the Wilmington city line, and proceeding  
30 easterly along the Wilmington city line to the Delaware – New Jersey state boundary, and proceeding  
31 southerly along the Delaware-New Jersey state boundary to nonvisible boundary designated as U.S.

49 and N. Tatnall St., and proceeding southerly along N. Tatnall St. to W. 2nd St., and proceeding westerly  
50 along W. 2nd St. to N. Madison St. N., and proceeding southerly along N. Madison St. N. to Maryland  
51 Ave., and proceeding westerly along Maryland Ave. to the Wilmington city line, and proceeding northerly  
52 along the Wilmington city line to S. Broom St., and proceeding northerly along S. Broom St. to Oak St.,

53 and proceeding westerly along Oak St. to S. Lincoln St., and proceeding northerly along S. Lincoln St. to

1365 Section 3. Further Amend Chapter 8, Title 29 of the Delaware Code by striking §841, §842, §843, §844 and §845  
1366 and substituting in lieu thereof the following:

1367 “§841 Filing of maps.

1368 Maps of the several representative and senatorial districts shall be prepared by the respective departments of  
1369 elections of each county. The maps shall be certified as to correctness by the president and administrative director of the  
1370 respective departments of elections and recorded in the offices of the recorder of deeds for the respective counties. Two

1371 true and correct copies of these maps shall also be filed, not later than January 1, 2012, in the respective county departments  
1372 of elections, with the State Election Commissioner, the respective state chairpersons of the 2 major political parties and the  
1373 State Archivist and Records Administrator.

1374 §842 Evidence.

1375 When the maps referred to in this chapter are so recorded in the respective recorder of deeds' offices, they shall be  
1376 prima facie evidence in all judicial proceedings as to the correctness of the boundaries shown thereon.

1377 §843 Copies of maps.

1378 The State Election Commissioner and the separate departments of elections shall cause such additional copies of  
1379 the maps to be prepared and distributed as they deem necessary to properly advise the public.

1380 §844 Designation of roadways.

1381 The term avenue, boulevard., drive, highway, lane, parkway, place, road, route, street, turnpike or any  
1382 abbreviations thereof shall be used interchangeably so as to make the descriptions used in this chapter conform to maps  
1383 currently in existence.

1384 §845 House district descriptions.

1385 In the descriptions of the various House of Representatives districts, all references to a road, highway, street, drive,  
1386 place, parkway, lane, avenue, boulevard, route, turnpike, river, stream, branch, gut, boundary line or other physical feature  
1387 shall refer to the center line thereof unless otherwise specified.”.

1388 Section 4. Severability. If any district described in this Act, or any provision of this Act, or the application thereof  
1389 to any person or circumstance is held invalid, such invalidity shall not affect other districts, other provisions, or applications  
1390 of the Act which can be given effect without the invalid district, provision or application, and to that end the descriptions  
1391 and provisions of this Act are declared to be severable.

#### SYNOPSIS

This bill reapportions the 41 House of Representative Districts.
