AN ACT TO AMEND TITLE 21 OF THE DELAWARE CODE RELATING TO COMMERCIAL LEARNER PERMITS  
AND COMMERCIAL DRIVER LICENSES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

- 1           Section 1. Amend § 2603, Title 21 of the Delaware Code by making insertions as shown by underlining and  
2 deletions as shown by strike through as follows:
- 3                   §2603. Definitions.
- 4           Notwithstanding any other provision of this title, the following definitions apply to this chapter:
- 5           (1) "Alcohol" means any substance containing any form of alcohol, including, but not limited to, ethanol,  
6 methanol, propanol and isopropanol.
- 7           (2) "Alcohol concentration" means:
- 8                   a. The number of grams of alcohol per 100 milliliters of blood; or
- 9                   b. The number of grams of alcohol per 210 liters of breath.
- 10           (3) "Alien" means any person not a citizen or national of the United States."
- 11           (4) "CDL downgrade" means either:
- 12                   a. Except where otherwise provided in this title, the Division allows the driver to change  
13 his or her self-certification to interstate but operating exclusively in transportation or operation excepted from 49 C.F.R.  
14 Part 391, as provided in § 390.3(f), § 391.2, § 391.68, or § 398.3;
- 15                   b. The Division allows the driver to change his or her self-certification to intrastate only if the  
16 driver is physically qualified for intrastate-only driving under § 4704(b) of this title;
- 17                   c. The Division allows the driver to change his or her certification to intrastate but operating exclusively in  
18 transportation or operations excepted under § 4704(c)(1) [or] (2) of this title driver physical qualification requirements; or
- 19                   d. The Division removes the CDL privilege from the driver license.

20 (5) "CDLIS driver record" means the electronic record of the individual CDL driver's status and history stored by the state  
21 of record as part of the Commercial Driver's License Information System (CDLIS) established under 49 U.S.C. § 31309.

22 (6) "CDLIS motor vehicle record" means a report generated from the CDLIS driver record meeting the  
23 requirements for access to CDLIS information and provided by states to users authorized in 49 C.F.R. §384.225(e)(3) and  
24 (4), subject to the provisions of the Driver Privacy Protection Act, 18 U.S.C.  
25 §21-2725, and § 305 of this title.

26 (7) ~~"Commercial driver instruction permit"~~ "Commercial Learner Permit" (CLP) means a permit issued pursuant  
27 to § 2608(d) of this title.

28 (8) "Commercial driver license" (CDL) means a license issued in accordance with the  
29 requirements of this chapter to an individual which authorizes the individual to drive a certain class of commercial motor  
30 vehicle.

31 (9) "Commercial driver license information system" (CDLIS) means the information system  
32 established pursuant to the CMVSA to serve as a clearinghouse for locating information related to the licensing and  
33 identification of commercial motor vehicle drivers.

34 (10) "Commercial motor vehicle (CMV)" means a motor vehicle or combination of motor vehicles used in  
35 commerce to transport passengers or property if the motor vehicle

36 a. Has a gross combination weight rating (GCWR) of 26,001 pounds or more inclusive of a towed unit(s) with a  
37 gross vehicle weight rating (GVWR) of more than 10,000 pounds; or

38 b. Has a gross vehicle weight rating (GVWR) of 26,001 pounds or more; or

39 c. Is designed to transport 16 or more passengers, including the driver; or

40 d. Is of any size and is used in the transportation of hazardous materials.

41 (11) "Controlled substance" means any substance so classified under § 102(6) of the Controlled Substances Act  
42 (21 U.S.C. § 802(6)), and includes all substances listed on Schedules I through V, of 21C.F.R. part 1308, as they may be  
43 revised from time to time.

44 (12) "Conviction" means an unvacated adjudication of guilt, or a determination that a person has violated or failed  
45 to comply with the law in a court of original jurisdiction or by an authorized administrative tribunal, an unvacated forfeiture  
46 of bail or collateral deposited to secure the person's appearance in court, a plea of guilty or nolo contendere accepted by the  
47 court, the payment of a fine or court cost, or violation of a condition of release without bail, regardless of whether or not the  
48 penalty is rebated, suspended, or probated.

49 (13) "Disqualification" means any of the following actions:

- 50 a. The suspension, revocation, or cancellation of a CDL or CLP by the state or jurisdiction of issuance.
- 51 b. Any withdrawal of a person's privileges to drive a Commercial Motor Vehicle (CMV) by a state or  
52 other jurisdiction as the result of a violation of state or local law relating to motor vehicle traffic control (other than parking,  
53 vehicle weight or vehicle defect violations).
- 54 c. A determination by the FMCSA that a person is not qualified to operate a commercial motor vehicle  
55 under Part 391 of 49 C.F.R.
- 56 (14) "Drive" means to drive, operate or be in physical control of a motor vehicle.
- 57 (15) "Driver" means any person who drives, operates, or is in physical control of a commercial motor vehicle, or  
58 who is required to hold a commercial driver license.
- 59 (16) "Driver license" means a license issued by a state to an individual which authorizes the individual to drive a  
60 motor vehicle.
- 61 (17) "Driving a commercial motor vehicle while under the influence of alcohol" means committing any one or  
62 more of the following acts in a CMV:
- 63 a. Driving a CMV while the person's alcohol concentration is 0.04 or more;
- 64 b. Driving under the influence of alcohol as prescribed by State law; or
- 65 c. Refusal to undergo such testing as is required by any State or jurisdiction in the enforcement of  
66 §383.51(b) or § 392.5(a)(2) of 49 C.F.R.
- 67 (18) "Employer" means any person, including the United States, a state, or a political subdivision of a state, who  
68 owns or leases a commercial motor vehicle, or assigns a person to drive a commercial motor vehicle.
- 69 (19) "Excepted interstate commerce" means a CDL/CLP applicant certifies that he or she operates or expects to  
70 operate in interstate commerce but engages exclusively in transportation or operations excepted under 49 C.F.R. § 390.3(f),  
71 § 391.2, § 391.68, or § 398.3 from all or parts of the qualification requirements of 49 C.F.R. Part 391 and is, therefore, not  
72 required to obtain a federal medical examiner's certification by 49 C.F.R. § 391.45.
- 73 (20) "Excepted intrastate commerce" means a CDL/CLP applicant certifies that he or she operates in intrastate  
74 commerce but engages exclusively in transportation or operations excepted from all or parts of the Delaware's driver  
75 medical qualification requirements in §§ 2621 and 4704(c)(2) of this title.
- 76 (21) "Fatality" means the death of a person as a result of a motor vehicle accident.
- 77 (22) "Felony" means any offense under state or federal law that is punishable by death or imprisonment for a term  
78 exceeding 1 year.
- 79 (23) "FMCSA" means Federal Motor Carrier Safety Administration.

80 (24) "Foreign jurisdiction" means any jurisdiction other than a state of the United States or District of Columbia.

81 (25) "Gross vehicle weight rating" (GVWR) means the value specified by the manufacturer or manufacturers as  
82 the maximum loaded weight of a single vehicle. The GVWR of a combination (articulated) vehicle (commonly referred to  
83 as the "Gross Combination Weight Rating" or (GCWR) is the GVWR of the power unit plus the GVWR of the towed unit  
84 or units.

85 (26) "Hazardous material" means any material that has been designated as hazardous under 49 U.S.C. § 5103  
86 and is required to be placarded under subpart F of 49 C.F.R. part 172 or any quantity of a material listed as a select agent or  
87 toxin in 42 C.F.R. part 73.

88 (27) "Imminent hazard" means the existence of a condition relating to hazardous material that presents a  
89 substantial likelihood that death, serious illness, severe personal injury, or a substantial endangerment to health, property, or  
90 the environment may occur before the reasonably foreseeable completion date of a formal proceeding begun to lessen  
91 the risk of that death, illness, injury or endangerment.

92 (28) "Issue and issuance" means initial licensure, license transfers, license renewals, license upgrades, and  
93 nonresident commercial driver's licenses.

94 (29) "Major Traffic Violation" means any conviction defined as "Major" as specified by 49 C.F.R. 383.51(b)  
95 Table 1.

96 (30) "Manual Transmission" means a transmission utilizing a driver-operated clutch that is activated by a pedal or  
97 lever and a gearshift mechanism either operated by hand or foot.

98 ~~(29)~~ (31) "Measurable amount of alcohol" means the alcohol concentration of the person's blood or breath is equal  
99 to or greater than 0.02 but less than 0.04.

100 ~~(30)~~ (32) "Medical examiner" for purposes of conducting U.S. Department of Transportation physical examination  
101 for CMV certification means a person who is licensed, certified, and/or registered, in accordance with applicable state laws  
102 and regulations, to perform physical examinations. The term includes but is not limited to, doctors of medicine, doctors of  
103 osteopathy, physician assistants, advanced practice nurses, and doctors of chiropractic. For medical examinations conducted  
104 on and after May 21, 2014, a medical examiner must be certified by FMCSA and listed on the National Registry of  
105 Certified Medical Examiners as defined in this section.

106 ~~(31)~~ (33) "Medical variance" means a driver has received 1 of the following from FMCSA that allows the driver to  
107 be issued a medical certificate:

108 a. An exemption letter permitting operation of a commercial motor vehicle pursuant to 49 C.F.R. Part  
109 381, Subpart C, or § 391.64;

110 b. A skill performance evaluation certificate permitting operation of a commercial motor vehicle pursuant  
111 to 49 C.F.R. § 391.49.

112 ~~(32)~~ (34) "Motor vehicle" means every vehicle which is self-propelled, and every vehicle which is propelled by  
113 electric power obtained from overhead trolley wires but not operated upon rails, except vehicles moved solely by human  
114 power, motorized wheel chairs, farm implements of husbandry, mopeds, tripeds and OHV's.

115 ~~(33)~~ (35) "Motor vehicle record" means the report of the driving status and history of a driver generated from the  
116 driver record, provided to users, such as drivers or employers, and subject to the provisions of the Driver Privacy Protection  
117 Act, 18 U.S.C. §§ 2721-2725 and § 305 of this title.

118 (36) "National Registry of Certified Medical Examiners" means a program administered by the  
119 Federal Motor Carrier Safety Administration (FMCSA) that establishes requirements for healthcare professionals who  
120 perform physical qualification examinations for commercial motor vehicle (CMV) drivers. All healthcare professionals  
121 whose scope of practice authorizes them to perform physical examinations and who intend to perform physical  
122 examinations and issue medical certificates for CMV drivers to meet the requirements of Section 391.41 of the Federal  
123 Motor Carrier Safety Regulations (FMCSRs) must be certified and listed on FMCSA's National Registry no later than May  
124 21, 2014.

125 ~~(34)~~(37) "Non-CMV" means a motor vehicle or combination of motor vehicles not defined by the term  
126 "commercial motor vehicle (CMV)" in this section.

127 (35) (38) "Non-excepted interstate commerce" means a CDL/CLP applicant certifies that he or she operates or  
128 expects to operate in interstate commerce, is both subject to and meets the qualification requirements under 49 C.F.R.  
129 Part 391, and is required to obtain a federal medical examiner's certification by 49 C.F.R. § 391.45.

130 ~~(36)~~ (39) "Non-excepted intrastate commerce" means a CDL/CLP applicant certifies that he or she operates only in  
131 intrastate commerce and, therefore, is subject to the Delaware driver medical qualification requirements in § 4704(a), (b),  
132 and (c)(1) of this title.

133 ~~(37)~~ (40) ~~Nonresident~~ Non-Domiciled CDL means a CDL or CLP issued by a State under either of the following  
134 two conditions:

135 a. To an individual domiciled in a foreign country meeting the requirements of § 383.23(b)(1) of  
136 49 C.F.R.

137 b. To an individual domiciled in another state meeting the requirements of § 383.23(b)(2) of 49  
138 C.F.R.

139                   (38) (41) "Out-of-service order" means a declaration by the Federal Highway Administration or an  
140 authorized enforcement officer of a federal, state, local or governmental agency from Puerto Rico, Canada or Mexico that  
141 a driver or a commercial motor vehicle or motor carrier operation (as defined in the Federal Motor Carrier Safety  
142 Regulations [49 C.F.R. Part 390]) is out-of-service pursuant to § 386.72 (imminent hazard), § 392.5 (intoxicating  
143 beverage), § 395.13 (drivers declared out-of-service) or § 396.9 (inspection of motor vehicles in operation) of the Federal  
144 Motor Carrier Safety Regulations or comparable laws of any governmental agency referred to above or the North  
145 American Uniform Out-of-Service Criteria.

146                   (39) (42) "Railroad-highway grade crossing violation" means ~~convictions in a commercial motor vehicle~~  
147 ~~of violations of a federal, State or local law or regulation pertaining to 1 of the following 6 offenses at~~ railroad-  
148 ~~highway grade crossings:~~  
149 \_\_\_\_\_ a. ~~For drivers who are not required to always stop, failing to slow down and check that the tracks~~  
150 ~~are clear of an approaching train;~~  
151 \_\_\_\_\_ b. ~~For drivers who are not required to always stop, failing to stop before reaching the crossing if~~  
152 ~~the tracks are not clear;~~  
153 \_\_\_\_\_ c. ~~For drivers who are always required to stop, failing to stop before driving onto the crossing;~~  
154 \_\_\_\_\_ d. ~~For all drivers, failing to have sufficient space to drive completely through the crossing~~  
155 ~~without stopping;~~  
156 \_\_\_\_\_ e. ~~For all drivers, failing to obey a traffic control device or the directions of an enforcement~~

159 ~~any conviction defined as "Railroad -highway grade crossing" as specified by 49 C.F.R. 383.51(d) Table 3.~~

160                   (40) (43) "School bus" means a commercial motor vehicle used to transport preprimary, primary, or  
161 secondary school students from home to school, from school to home, or to and from school-sponsored events, or any  
162 vehicle which meets the regulatory requirements adopted by the Department of Education with the advice of the Division of  
163 Motor Vehicles as specified under § 2901 of Title 14. "School bus" does not include a bus used as a common carrier.

164                   (41)-(44) "Serious traffic violation" means any conviction defined as "Serious", specified by 49 C.F.R.  
165 383.51(c) Table 2. ~~of any of the following offenses when operating a CMV, except weight, defect and parking violations:~~  
166 \_\_\_\_\_ a. ~~Excessive speeding, involving any single offense for any speed of 15 miles per hour or more~~  
167 ~~above the posted speed limit;~~

- 168 ~~\_\_\_\_\_ b. Reckless driving, as defined by state or local law or regulation, including but not limited to~~  
169 ~~offenses of driving a CMV in willful or wanton disregard for the safety of persons or property;~~  
170 ~~\_\_\_\_\_ c. Improper or erratic traffic lane changes;~~  
171 ~~\_\_\_\_\_ d. Following the vehicle ahead too closely;~~  
172 ~~\_\_\_\_\_ e. A violation, arising in connection with a fatal accident, of state or local law relating to motor~~

181 ~~(42)~~ (45) "State" for the purpose of this chapter means a state, territory or possession of the United States, the  
182 District of Columbia, the Republic of Mexico, the Commonwealth of Puerto Rico and any province of the Dominion of  
183 Canada.

184 (46) "Tank Vehicle" means any commercial motor vehicle that is designed to transport any liquid or  
185 gaseous materials within a tank or tanks, having an individual rated capacity of more than 119 gallons and an aggregate  
186 rated capacity of 1,000 gallons or more that is either permanently or temporarily attached to the vehicle or chassis.

187 ~~(44)~~ (47) "United States" means the 50 states and the District of Columbia.

188 Section 2. Amend § 2606, Title 21 of the Delaware Code by making insertions as shown by underlining and  
189 deletions as shown by strike through as follows:

190 § 2606. Employer responsibilities.

191 (a) Each employer must require the applicant to provide the information specified in § 2605(c) of this title.

192 (b) No employer may allow, permit, or authorize a driver to drive a commercial motor vehicle during any period:

193 (1) In which the driver has had a ~~commercial driver license~~ CDL/CLP suspended, revoked, or cancelled  
194 by any state, is currently disqualified from driving a commercial vehicle, or has been issued an out of service order  
195 in any state; or

196 (2) In which the driver has more than 1 driver license.

197 (3) In which the driver does not have a CDL/CLP license for the type vehicle the employer requires the  
198 driver to drive.

199 (c) No employer may knowingly allow, require, permit or authorize a driver to operate a commercial motor vehicle  
200 in violation of a federal, state or local law or regulation pertaining to railroad-highway grade crossing violations.

201 (d) No employer may knowingly allow, require, permit or authorize a driver to operate a commercial motor  
202 vehicle in violation of an out-of-service order.

203 Section 3. Amend § 2607, Title 21 of the Delaware Code by making insertions as shown by underlining and deletions as  
204 shown by strike through as follows:

205 § 2607. Commercial driver license required.

206 (a) Except when driving under a ~~commercial driver instruction permit~~ commercial learner permit and accompanied  
207 by the holder of a commercial driver license valid for the vehicle being driven or while being tested by the  
208 Department for a commercial driver's license, no person may drive a commercial motor vehicle unless the person  
209 holds a commercial driver license and applicable endorsements valid for the vehicle being driven and is in  
210 possession of such license.

211 (b) No person may drive a commercial motor vehicle while that person's driving privilege is denied, withdrawn,  
212 barred, canceled, suspended, revoked, or disqualified.

213 (c) No person may drive a commercial motor vehicle in violation of an out-of-service order.

214 (d) No person may drive a commercial motor vehicle while an out-of-service order is in effect while transporting  
215 hazardous materials required to be placarded or while operating a vehicle designed to transport 16 or more  
216 passengers, including the driver.

217 (e) Conditional or occupational licenses may not be issued to holders of a CDL or CLP licenses, nor may any  
218 person drive a commercial motor vehicle while in possession of a conditional or occupational license.

219 (f) Any violation of this section shall be an unclassified misdemeanor, with the penalties set forth in § 2622 of this  
220 title.

221 Section 4. Amend § 2608, Title 21 of the Delaware Code by making insertions as shown by underlining and  
222 deletions as shown by strike through as follows:

223 § 2608. Commercial driver license qualification standards.

224 (a) Testing. –

225 (1) General. -- No person may be issued a commercial driver license unless that person is a resident of this State  
226 and has passed a knowledge and skills test for driving a commercial motor vehicle which complies with minimum federal



227 standards established by federal regulation enumerated in 49 C.F.R. part 383, subparts G and H, and has satisfied all other  
228 requirements of the CMVSA in addition to other requirements imposed by state law or federal regulation. The tests must be  
229 prescribed and conducted by the Division of Motor Vehicles.

230 (2) Third-party testing. -- The Division of Motor Vehicles may authorize a person, including an agency of this or  
231 another state, an employer, a private driver training facility, or other private institution, or a department, agency or  
232 instrumentality of local government, to administer the skills test specified by this section, provided:

233 a. The test is the same which would otherwise be administered by the State; and

234 b. The 3rd party has entered into an agreement with the State which complies with requirements of 49  
235 C.F.R. part 383.75.

236 (3) Testing by State. -- ~~After June 30, 1992.~~ Only an agency of the State, as approved by the Division of Motor  
237 Vehicles, shall be permitted to administer the skills test specified by this chapter.

238 (b) Waiver of skills test. -- The Division of Motor Vehicles may waive the skills test as specified in this section for a  
239 commercial driver license applicant who meets the requirements of 49 C.F.R. part 383.77.

240 (c) Limitations on issuance of license. -- A commercial driver license or ~~commercial driver instruction permit~~  
241 commercial learner permit may not be issued to a person while the person is subject to a disqualification from driving a  
242 commercial motor vehicle, or while the person's driver license is suspended, revoked, denied or cancelled in any state; nor  
243 may a commercial driver license be issued to a person who has a commercial driver license issued by any other state unless  
244 the person first surrenders all such licenses, which must be returned to the issuing state(s) for cancellation.

245 (d) ~~Commercial driver instruction permit~~ Commercial Learner Permit (CLP). --

246 (1) ~~The issuance of a CLP is a precondition to the initial issuance of a CDL. A commercial driver~~  
247 ~~instruction permit~~ CLP may be issued to an individual who has satisfied the following requirements:

248 a. Is at least 18 year of age;

249 b. Holds a valid Delaware driver license and;

250 c. ~~who~~ Has passed the vision and written tests required for a CDL. ~~commercial motor vehicle~~  
251 ~~driver license.~~

252 (2) The ~~commercial driver instruction permit~~ CLP may not be issued for a period to exceed 6 months.  
253 Only one renewal or re-issuance may be granted within a ~~2~~ 1-year period. The ~~2~~ 1-year period shall begin with the issuance  
254 date of the original permit. The holder of a ~~commercial driver instruction permit~~ CLP may, unless otherwise disqualified,  
255 drive a commercial motor vehicle only when accompanied by the holder of a commercial driver license, valid for the type  
256 of vehicle driven who occupies a seat beside the individual for the purpose of giving instruction in driving the commercial

257 motor vehicle; provided that the ~~commercial driver instruction permit~~ CLP holder may not operate a commercial motor  
258 vehicle transporting hazardous materials as defined in § 2603 of this chapter.

259 (3) A CLP holder is not eligible to take the CDL pre-trip, skills or road test in the first 14 days after initial  
260 issuance of the CLP.

261 (4) A CLP holder is eligible to apply a passenger, school bus or tank endorsement while holding a CLP  
262 provided the written test is passed for each endorsement prior to the permit issuance. A CLP holder with a passenger or  
263 school bus endorsement is prohibited from carrying passengers or students. A CLP holder with a tank endorsement may  
264 only operate an empty tank vehicle. All other endorsements as defined by 49 C.F.R. §383.153(b) are prohibited on a CLP.

265 (5) The issuance of a CLP is a precondition to the upgrade of a CDL if the upgrade requires a skills test.

266 (6) Content of CLP – The commercial learner permit must be marked “Commercial Learner Permit” or  
267 “CLP” and must be, to the maximum extent possible, tamperproof. The CLP must include, but not be limited to, the  
268 following information:

269 (A) The name and residential address of the person;

270 (B) The person's photograph;

271 (C) A physical description of the person including sex, height, weight, and eye color;

272 (D) Date of birth;

273 (E) Any unique number or identifier deemed appropriate by the Division of Motor Vehicles;

274 (F) The person's signature;

275 (G) The class or type of commercial motor vehicle(s) which the person is authorized to drive together with any  
276 endorsements or restrictions;

277 (H) The name of this State;

278 (I) The issue date of the current license; and

279 (J) The expiration date of the current license.

280 (7) Commercial Learner Permit Restrictions

281 (A) “P” – Restricts the driver from operating CMV with passengers.

282 (B) “X” – Restricts the driver from operating tank vehicle with cargo.

283 (C) “L” – Restricts the driver from operating a vehicle with airbrakes.

284 (D) “V” – Restricts the driver from operating a CMV without a valid medical variance issued by the Federal Motor  
285 Carrier Safety Administration.

286 (E) “M” – Restricts the driver from operating a Class A passenger vehicle.

287 (F) "N" – Restricts the driver from operating a Class A or B passenger vehicle.

288 (G) "K" – Restricts the driver from operating a CMV out of the State of Delaware.

289 Section 5. Amend § 2609, Title 21 of the Delaware Code by making insertions as shown by underlining and deletions as  
290 shown by strike through as follows:

291 § 2609 ~~Non-resident CDL.~~ Non-Domiciled CDL or CLP

292 (a) The Division of Motor Vehicles may issue a ~~non-resident~~ non-domiciled CDL or CLP to a an applicant who:

293 (1) is domiciled in a resident of a foreign jurisdiction if the United States Secretary of Transportation has

402 a. "L" -- Restricts the driver from operating vehicles equipped with airbrakes.

- 405           d. "O" – Restricts the driver from operating tractor-trailer CMVs.
- 406           e. "M" – Restricts the driver from operating a Class A passenger vehicle.

485 operating a commercial motor vehicle, the driver's CDL is revoked, suspended, or canceled, or the driver is disqualified  
486 from operating a commercial motor vehicle.

595 (1) Beginning January 30, 2012, any person applying for an initial CLP/CDL must self-certify to  
596 the Division that he or she is operating commercial motor vehicles in a non-excepted interstate commerce, excepted  
597 interstate commerce, non-excepted intrastate commerce or excepted intrastate commerce status.

598 (2) Existing CDL holders must self-certify to the Division on or after January 30, 2012, but not  
599 later than January 30, 2014, that he or she operates commercial motor vehicles in a non-excepted interstate commerce,  
600 excepted interstate commerce, non-excepted intrastate commerce or excepted intrastate commerce status.

601 (3) It is the responsibility of the CDL/CLP holder to immediately notify the Division if/when his  
602 or her medical certification status changes.

603 (b) Medical certification documentation requirements for non-excepted interstate commerce drivers after  
604 January 30, 2012. --

605 (1) Any person applying for an initial CLP/CDL who certifies that he or she will operate CMVs  
606 in non-excepted, interstate commerce must provide the Division with the current, original medical examiner's certificate  
607 prepared by a medical examiner who, on and after May 21, 2014, is currently certified by FMCSA and is listed on the  
608 National Registry of Certified Medical Examiners confirming the applicant meets the minimum physical qualifications for  
609 CMV operators in accordance with federal regulations.

610 (2) On or after January 30, 2012, but not later than January 30, 2014, existing CDL holders must  
611 provide the Division with the current original or copy of the medical examiner's certificate prepared by a medical examiner

612 who, on and after May 21, 2014, is currently certified by FMCSA and is listed on the National Registry of Certified  
613 Medical Examiners confirming the CDL holder meets the minimum physical qualifications for CMV operators in  
614 accordance with federal regulations.

615 (3) In order to maintain a medical certification status of certified, the CDL/CLP holder who  
616 certifies that he or she will operate CMVs in non-excepted interstate commerce must provide the Division with a current  
617 original or copy of each subsequent medical examiner's certificate prepared by a medical examiner confirming the  
618 CDL/CLP holder meets the minimum physical qualifications for CMV operators in accordance with federal regulations.

619 (c) CDL/CLP issuance procedures for drivers who after January 30, 2012, self-certify as operating in non-  
620 excepted interstate commerce. --

621 (1) The Division must verify the driver has self-certified as a non-excepted interstate commerce  
622 operator.

623 (2) The Division must verify the driver has a "certified" medical status on the medical  
624 examiner's certificate and on the CDLIS driver record.

625 (3) In the event that the driver has not self-certified or the medical certification status of the  
626 individual is "not-certified," the applicant will be denied a CDL/CLP issuance, renewal, upgrade or transfer, and the CDL  
627 will be downgraded.

628 (4) Approximately 60 days before a medical examiner's certificate expires, the Division will  
629 attempt to notify the CDL/CLP holder requiring him or her to either submit a current medical certificate or self-certify that  
630 he or she now operates a CMV in excepted interstate commerce, non-excepted intrastate commerce or excepted intrastate  
631 commerce. The CDL/CLP will be downgraded no later than 60 days after the CDL/CLP holder's current medical  
632 certification expires or when determined to be "not-certified" if:

640 updated, and the CDL/CLP document will show a restricted code "V" indicating there is information about a medical  
641 variance on the CDLIS driver record. Within 10 calendar days of receiving information from the FMCSA regarding the

646 (1) A CDL/CLP holder who is subject to the physical requirements contained in 49 C.F.R. §  
647 391.41 must not operate a commercial motor vehicle unless he or she is medically certified as physically qualified to do so,  
648 and, except as provided in paragraph (b)(2) of this section, when on duty, has on his or her person the original or a copy of  
649 a current medical examiner's certificate that he or she is physically qualified to drive a commercial motor vehicle.

650 (2) Beginning January 30, ~~2012~~, 2014, a CDL/CLP holder who has submitted a current medical  
651 examiner's certificate to the Division in accordance with 49 C.F.R. § 383.71(h) substantiating he or she is medically  
652 "certified," no longer needs to carry on his or her person the medical examiner's certificate once the medical certification  
653 information is posted on the CDLIS driver record. The Division will post the medical information in CDLIS within 10 days  
654 after the driver submits a current medical certificate. If there is no medical certification information on that driver's CDLIS  
655 driver record, a current medical examiner's certificate issued prior to January 30, 2012, will be accepted until January 30,  
656 2014.

657 (3) A CDL/CLP driver who obtained a medical variance from the FMCSA must continue to  
658 have in his or her possession the original or copy of that medical variance documentation at all times when driving a CMV.

659 (4) Canadian and Mexican CMV drivers are not required to have in their possession a medical  
660 examiner's certificate if the driver has been issued and possesses a valid commercial driver license issued by the United  
661 Mexican States or Canadian Province or Territory and whose license and medical status, including any waiver or  
662 exemption, can be electronically verified. Drivers from any of the countries who have received a medical authorization that  
663 deviates from the mutually accepted compatible medical standards of the resident country are not qualified to drive a CMV  
664 in the other countries. Canadian and Mexican drivers who do not meet the medical fitness provisions of their home country  
665 for motor carriers are not qualified to drive a CMV in the United States even if that driver has received a medical variance  
666 or waiver. In addition, U.S. drivers who receive a medical variance from the FMCSA are not qualified to drive a CMV in  
667 Canada or Mexico.

668 (e) CDL/CLP holders self-certifying that they operate or expect to operate CMVs in excepted interstate  
669 commerce must:

670 (1) Meet the minimum physical qualifications for CMV operators as determined in 49 C.F.R. §  
671 390.3(f), § 391.2, § 391.68, or § 398.3; and

672 (2) Self-certify to the Division that that operate or expect to operate CMVs in excepted interstate  
673 commerce upon each renewal of their CDLs.

674 (f) CDL/CLP holders self-certifying that they operate or expect to operate CMVs in non-excepted  
675 intrastate or excepted intrastate commerce must:

676 (1) Meet the minimum physical qualifications for CMV operators as determined in § 4704 of  
677 this title;

678 (2) Self-certify to the Division that they operate or expect to operate CMVs in non-excepted  
679 intrastate or excepted intrastate commerce upon each renewal of their CDLs;

680 (3) Meet the minimum physical qualification requirements for CMV operators as determined in

683 (g) Release of medical certification information in the CDLIS driver record. -- Except where prohibited  
684 by § 305 of this title or Division policies, the following authorized agents may receive CDLIS driver record information:

685 (1) States. -- All information on all CDLIS driver records.

686 (2) Secretary of Transportation. -- All information on all CDLIS driver records.

687 (3) Driver. -- All information on that driver's CDLIS driver record obtained on the CDLIS motor vehicle  
688 record.

689 (4) Motor carrier or prospective motor carrier. -- After the employer or prospective employer notifies the  
690 driver, all information on that driver's or prospective driver's CDLIS driver record obtained on the CDLIS  
691 motor vehicle record.

#### SYNOPSIS

This bill will bring Delaware into compliance with the Federal Motor Carrier Safety Administration's new commercial driver license and commercial learner permit issuance standards. Much of the bill is housekeeping and includes changes such as altering the language "commercial driver instructor permit" to "commercial learner permit", changing the language "non-resident" to non-domiciled", adding new definitions, and adding commercial learner permit specifications to Delaware law. Other changes include limiting certain endorsements to the commercial learner permit, requiring medical examiners to be certified by FMCSA, and adding new restrictions to the commercial driver license.
