HOUSE BILL NO. 230

AN ACT MAKING APPROPRIATIONS FOR CERTAIN GRANTS-IN-AID FOR THE FISCAL YEAR ENDING JUNE 30, 2016; SPECIFYING CERTAIN PROCEDURES, CONDITIONS AND LIMITATIONS FOR THE EXPENDITURE OF SUCH FUNDS, AMENDING THE FISCAL YEAR 2016 APPROPRIATIONS ACT.

The sums appropriated to the various Senior Centers in Section 1 of this Act shall be made available to the Division of Services for Aging and Adults with Physical Disabilities in order to meet the State's matching requirement for federal funds appropriated under the Older Americans Act of 1965, as amended. Those senior centers receiving funds under the Older Americans Act of 1965, as amended, shall present to the Division of Services for Aging and Adults with Physical Disabilities a proposal for expenditure of State funds. The proposal submitted to the Division of Services for Aging and Adults with Physical Disabilities shall be prepared in accordance with the guidelines established for the administration of programs under the Older Americans Act. To be considered for funding, a senior center must meet the criteria established in Section 5. Funding will be determined by the Joint Finance Committee based upon its evaluation and with advice from the University of Delaware Institute for Public Administration.

Section 13. Section 1 of this Act makes an appropriation to the Department of Health & Social Services, Public Health, Emergency Medical Services (35-05-30), for the state component of the operational costs associated with each

25	shall be distributed based on (a) \$3,000 to each police agency; (b) any funds in excess of "(a)" based on the ratio of the
26	number of police officers each police agency has to the total number of police in all agencies.
27	Section 17. (a) The State Treasurer is authorized to take the necessary steps to make a total payment of the

18	organizations funded on a one-time basis in Section 1 of this Act at the beginning of the first quarter of Fiscal Year 2015

20	Section 18. Section 2 of this Act makes an appropriation to the Delaware State Fair. Of that amount, \$121,614
21	shall be used for prizes for achievements in agriculture, animal raising and in works of manual training and the domestic
22	arts to be awarded at the annual State Fair and \$5,000 shall be used for purses on Governor's Day which shall be paid by
23	the State Treasurer at the beginning of the first quarter of Fiscal Year 20152016. The remainder of the appropriation shall
24	be paid in quarterly allotments, as provided in Chapter 65, §6505 of Title 29, Delaware Code.
25	Section 19. The appropriation in Section 2 of this Act to Camp Barnes, Inc. shall be used for the purpose of
26	maintaining and operating Camp Barnes for the recreation of deserving youths from throughout the State.
27	Section 20. Section 2 of this Act appropriates funds to the Delaware State Police Museum, Inc. These funds may
28	not be used for capital/construction costs.
29	Section 21. Section 2 of this Act makes an appropriation to the Historical Society of Delaware. Of that amount,

1	Section 22. The Delaware Safety Council may not discriminate against similar programs offered by other non-
2	profit or private agencies.
3	Section 23. It is the intent of the General Assembly that the Department of Health and Social Services, Division of
4	Public Health, continue funding the Alliance for Adolescent Pregnancy Prevention at the Fiscal Year 2006 contract levels.
5	Section 24. For Fiscal Year 20152016, the remaining balance in the Fiscal Year 2006 account (25-01-01-21187)
6	Delaware Volunteer Fire Service Revolving Loan Fund shall remain as a continuing appropriation and shall not be subject
7	to reversion until June 30, 2015 2016.
8	Section 25. Section 2 of this Act makes an appropriation to the Christina Cultural Arts Center. It is the intent of
9	the General Assembly that these funds shall support the Black Heritage Theater Ensemble and their efforts to educate
10	Delawareans on the contributions of Black Americans to the State's growth and development.
11	Section 26. Section 2 of this Act makes an appropriation to the Greater Philadelphia Chapter of the ALS
12	Association. It is the intent of the General Assembly that these funds shall only support Delaware residents.
13	Section 27. Section 1 of this Act makes an appropriation to the County Seat Package, of the amount appropriated
14	to the City of Wilmington up to \$300,000 shall be used for public safety.
15	Section 28. Section 1 of this Act makes an appropriation to the County Seat Package, of that amount \$50,000 is
16	appropriated to the City of Dover, \$7,000 is appropriated to the City of Georgetown and the balance will appropriated by
17	formula.
18	Section 29. It is the intent of the General Assembly that beginning in for Fiscal Year 2016 the State
19	reimbursement for the county paramedic program pursuant to 16 Del. C. 98 will be based on each county's expenditures for
