DELAWARE STATE SENATE 148th GENERAL ASSEMBLY

SENATE BILL NO. 262

AN ACT TO AMEND TITLE 2 OF THE DELAWARE CODE RELATING TO TRANSPORTATION NETWORK COMPANIES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

1	Section 1. Amend Title 2 of the Delaware Code by making deletions as shown by strike through and insertions as
2	shown by underline as follows:
3	Chapter 19. Transportation networks.
4	§ 1901. Definitions. As used in this Chapter:
5	As used in this Chapter:
6	(a) "Personal Vehicle" means a vehicle that is used by a Transportation Network Company Driver and is:
7	(1) Owned, leased or otherwise authorized for use by the Transportation Network Company Driver; and
8	(2) Not a taxicab, limousine, or public carrier as defined in Chapter 18 of this Title.
9	(b) "Digital Network" means any online-enabled technology application service, website or system offered or
10	utilized by a Transportation Network Company that enables the prearrangement of rides with Transportation Network
11	Company Drivers.
12	(c) "Transportation Network Company" or TNC means a corporation, partnership, sole proprietorship, or other
13	entity that is licensed pursuant to this Chapter and operating in Delaware that uses a Digital Network to connect
14	Transportation Network Company Riders to Transportation Network Company Drivers who provide Prearranged Rides. A
15	Transportation Network Company shall not be deemed to control, direct or manage the Personal Vehicles or Transportation
16	Network Company Drivers that connect to its Digital Network, except where agreed to by written contract.
17	(d) "Transportation Network Company Driver" or "TNC Driver" means an individual who:
18	(1) Receives connections to potential passengers and related services from a Transportation Network
19	Company in exchange for payment of a fee to the Transportation Network Company; and
20	(2) Uses a Personal Vehicle to offer or provide a Prearranged Ride to riders upon connection through a
21	Digital Network controlled by a Transportation Network Company in return for compensation or payment of a fee.

22	(e) "Transportation Network Company Rider" or "rider" means an individual or persons who use a Transportation
23	Network Company's Digital Network to connect with a Transportation Network Company Driver who provides
24	Prearranged Rides to the rider in the TNC Driver's Personal Vehicle between points chosen by the rider.
25	(f) "Prearranged Ride" means the provision of transportation by a TNC Driver to a rider, beginning when a TNC
26	Driver accepts a ride requested by a rider through a Digital Network controlled by a Transportation Network Company,
27	continuing while the TNC Driver transports a requesting rider, and ending when the last rider departs from the Personal
28	Vehicle. A Prearranged Ride does not include:
29	(1) transportation provided using a taxicab, limousine, or other public carrier pursuant to Chapter 18 of
30	this Title; or
31	(2) a shared expense carpool or vanpool arrangement or service or any other type of arrangement or
32	service in which the driver receives a fee that does not exceed the costs associated with providing the ride; or
33	(3) a regional transportation provider.
34	§ 1902. Not other carriers.
35	TNCs or TNC Drivers are not public carriers, as defined in Chapter 18 of this title, nor do they provide taxicab or
36	limousine service. A TNC Driver shall not be required to register with any state or local agency the vehicle such TNC
37	Driver uses to provide Prearranged Rides as a commercial or public carrier vehicle. A TNC Driver shall also not be
38	required to obtain a Delaware business license from the Delaware Division of Revenue.
39	§1903. TNC permit required.
40	(a) A person shall not operate a TNC in Delaware without first having obtained a permit from the Delaware
41	Department of Transportation, Delaware Transit Corporation ("Division").
42	(b) The Division shall issue a permit to each applicant that meets the requirements for a TNC set forth in this
43	Chapter, and pays an annual permit fee of \$5,000 to the Division.
44	§ 1904. Agent and registration requirements.
45	(a) The TNC must maintain an agent for service of process in the State of Delaware.
46	(b) The TNC must file with the Delaware Secretary of State Articles of Incorporation or Foreign Articles of
47	Incorporation and must meet all applicable business licensure requirements under the Delaware Code and Delaware
48	Division of Revenue's regulations
49	§ 1905. Fare collected for services.
50	On behalf of a TNC Driver, a TNC may charge a fare for the services provided to riders; provided that, if a fare is
51	collected from a rider, the TNC shall disclose to the rider the fare or fare calculation method on its website or within the

52	online-enabled technology application service. The TNC shall also provide riders with the option to receive an estimated
53	fare before the rider enters the TNC Driver's vehicle.
54	§ 1906. Identification of TNC vehicles and TNC Drivers and customer service.
55	(a) <u>The TNC's online-enabled technology application service or website shall display a picture of the TNC</u>
56	Driver, and the license plate number of the motor vehicle utilized for providing the Prearranged Ride, before the
57	rider enters the TNC Driver's vehicle.
58	(b) <u>A TNC Driver must display on their vehicle at all times while logged into a TNC's digital platform, a</u>
59	sign, emblem, or logo that can sufficiently identify the vehicle as being associated with the TNC or its associated
60	digital platform.
61	(c) <u>A TNC must provide a customer support telephone number, email address, or hyperlink on its digital</u>
62	application or website.
63	§ 1907. Electronic receipt.
64	Within a reasonable period of time following the completion of a trip, a TNC shall transmit an electronic receipt
65	to the rider on behalf of the TNC Driver that lists:
66	(a) The origin and destination of the trip;
67	(b) The total time and distance of the trip; and
68	(c) An itemization of the total fare paid, if any.
69	§ 1908. Financial responsibility of Transportation Network Companies.
70	On or before the effective date of this Act and thereafter, a Transportation Network Company Driver or
71	Transportation Network Company on the TNC Driver's behalf shall maintain primary automobile insurance that:
72	(a) Recognizes that the TNC Driver is a Transportation Network Company Driver or otherwise uses a vehicle to
73	transport passengers for compensation and covers the TNC Driver:
74	(1) while the TNC Driver is logged on to the Transportation Network Company's Digital Network; or
75	(2) while the TNC Driver is engaged in a Prearranged Ride.
76	(b) The following automobile insurance requirements shall apply while a participating Transportation Network
77	Company Driver is logged on to the Transportation Network Company's Digital Network and is available to receive
78	transportation requests but is not engaged in a Prearranged Ride:
79	(1) Primary automobile liability insurance in the amount of at least \$50,000 for death and bodily injury
80	per person, \$100,000 for death and bodily injury per incident, and \$25,000 for property damage; and

81	(2) Personal injury protection benefits that meet the minimum coverage amounts where required by§
82	2118 of Title 21 of the Delaware Code;
83	(3) The coverage requirements of this subsection (b) may be satisfied by any of the following:
84	a. Automobile insurance maintained by the Transportation Network Company Driver; or
85	b Automobile insurance maintained by the Transportation Network Company; or
86	c. Any combination of subparagraphs a. and b.
87	(c) The following automobile insurance requirements shall apply while a Transportation Network Company Driver
88	is engaged in a Prearranged Ride:
89	(1) Primary automobile liability insurance that provides at least \$1,000,000 for death, bodily injury and
90	property damage;
91	(2) Personal injury protection benefits that meet the minimum coverage amounts where required by §
92	2118 of Title 21 of the Delaware Code.
93	(3) The coverage requirements of this subsection (c) may be satisfied by any of the following:
94	a. Automobile insurance maintained by the Transportation Network Company Driver; or
95	b Automobile insurance maintained by the Transportation Network Company; or
96	c. Any combination of subparagraphs a. and b.
97	(d) If insurance maintained by TNC Driver in subsections (b) or (c) has lapsed or does not provide the required
98	coverage, insurance maintained by a Transportation Network Company shall provide the coverage required by c beginning
99	with the first dollar of a claim and have the duty to defend such claim.
100	(e) Coverage under an automobile insurance policy maintained by the Transportation Network Company shall not
101	be dependent on a personal automobile insurer first denying a claim nor shall a personal automobile insurance policy be
102	required to first deny a claim.
103	(f) Insurance required by § 1908 may be placed with an insurer licensed under Delaware law or with a surplus
104	lines insurer eligible under 18 Del. C. § 1912 that has a credit rating of no less than "A-" from A.M. Best or "A" from
105	Demotech or similar rating from another rating agency recognized by the Department of Insurance.
106	(g) Insurance satisfying the requirements of § 1908 shall be deemed to satisfy the financial responsibility
107	requirements of Chapter 29 of Title 21 of the Delaware Code.
108	(h) A Transportation Network Company Driver shall carry digital or physical proof of coverage satisfying §
109	1908(b) and § 1908 (c) with him or her at all times during his or her use of a vehicle in connection with a Transportation
110	Network Company's Digital Network. In the event of an accident, a Transportation Network Company Driver shall provide

SYNOPSIS

The purpose of this Chapter is to ensure the safety, reliability and cost-effectiveness of rides provided by Transportation Network Company Drivers within the State of Delaware and to preserve and enhance access to these important transportation options for residents and visitors to the State. To facilitate the regulatory process in a quickly changing industry, the Division is authorized to promulgate rules and regulations to ensure compliance with this Chapter or to address new industry developments not addressed explicitly in this Chapter.
