DESCRIPTION:	AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO THE OFFICE OF THE INSPECTOR GENERAL.

Assumptions:

- 1. This Act becomes effective upon signature by the Governor.
- 2. This Act establishes the Office of the Inspector General (OIG). The OIG will investigate the recovery of misspent funds, investigate the management of state agencies to determine waste, fraud, abuse, corruption, and other conduct that is harmful to the public interest.
- 3. The OIG is to hire a Deputy Inspector General and qualified staff with experience in areas such as investigation, law enforcement, auditing, and government evaluation.
- 4. Within three years of hire, investigative staff from the OIG are required to be certified by the Association of Inspectors General in at least one of the following areas: Investigation, Auditing, and/or Evaluation.
- 5. The OIG may also contract for services, including legal counsel.
- 6. Duties and responsibilities of the Inspector General are effective as of March 1, 2023. Funding for the OIG, including the timeline for hiring of necessary staff has been adjusted accordingly.
 - a. For Fiscal Year 2023 a total of \$457,038 which includes:
 - i. \$255,538 Personnel Costs for 7.0 FTEs including 1.0 Inspector General, 1.0 Deputy Inspector General, 1.0 Investigator Supervisor, 1.0 Investigator, 1.0 Management Analyst, 1.0 Fiscal Administrative Officer, and 1.0 Administrative Assistant.
 - ii. \$101,500 Operating Costs (Rent, Legal, Capital, Misc.).
 - iii. \$100,000 One-Time Costs (start-up).
 - b. For Fiscal Year 2024, a total of \$1,095,175 which includes:
 - i. \$906,175 Personnel Costs for 10.0 FTEs, including the 7.0 FTEs previously authorized, plus 2.0 Investigator and 1.0 Management Analyst.
 - ii. \$189,000 Operating Costs (Rent, Legal, Capital, Misc.).
 - c. For Fiscal Year 2025, a total of \$1,152,717 which includes:
 - i. \$963,717 Personnel Costs annualized for all 10.0 FTEs.
 - ii. \$189,000 Operating Costs (Rent, Legal, Capital, Misc.).
