DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

SENATE CONCURRENT RESOLUTION NO. 34

COMMENDING THE FOOD BANK OF DELAWARE FOR ITS CONTRIBUTIONS TO THE STATE OF DELAWARE.

1	WHEREAS, the Food Bank of Delaware has successfully developed and implemented programming for more than
2	110,000 Delawareans; and
3	WHEREAS, in the last fiscal year, the Food Bank of Delaware:
4	a. Distributed approximately 7.1 million pounds of food through its network of 550 Hunger Relief
5	Program Partners;
6	b. Served 3,783 households through its mobile pantry vehicle;
7	c. Distributed 160,800 backpacks stocked with food to at-risk youth through its Backpack Program;
8	d. Produced 243,390 meals for its After-School Nutrition Program;
9	e. Produced and delivered 87,138 meals for children at risk of hunger during the summer months through
10	its Summer Food Service Program;
11	f. Provided 23,893 supplemental food boxes to an estimated 2,300 senior citizens per month through the
12	Commodity Supplemental Food Program and Palmer Home Foundation;
13	g. Had 18,217 volunteer visits for a total of 46,123 donated hours, which is the equivalent of 22 full-time
14	staff members; and
15	WHEREAS, the Food Bank of Delaware currently employs 61 full-time and part-time employees at its Newark
16	and Milford facilities; and
17	WHEREAS, the Food Bank of Delaware has played a significant role in improving the access to and the efficiency
18	of the USDA's Supplemental Nutrition Assistance Program (formerly the Food Stamp Program) in Delaware; and
19	WHEREAS, the Food Bank of Delaware has purchased a new facility at 222 Lake Drive, Newark, DE to improve
20	operational efficiency, increase workforce development opportunities for Delawareans, and provide more nutritious foods
21	to those in need. Retrofit of the facility will begin shortly and will be completed within 8-10 months; and
22	WHEREAS, the Food Bank of Delaware has successfully graduated over 520 Culinary School students through its
23	62 graduating classes since the program began in 2002; and

24	WHEREAS, the Food Bank of Delaware will continue to provide nutritious foods to Delawareans in need and
25	facilitate long-term solutions to the problems of hunger and poverty through community education and advocacy; and
26	WHEREAS, the Food Bank of Delaware continues to leverage additional resources through strategic partnerships
27	including the further development of the Coalition to End Hunger, engaging clients as advocates and increasing donations
28	of food items from both grocers and farmers through the Food Sourcing Program and Produce Access Program;
29	NOW, THEREFORE:
30	BE IT RESOLVED by the Senate of the 149th General Assembly of the State of Delaware, the House of
31	Representatives concurring therein, that the Food Bank of Delaware is hereby commended for its continued dedication to
32	the health and nourishment of the citizens of Delaware, and is supported in its endeavors to further expand its services
33	throughout the State.
34	BE IT FURTHER RESOLVED that a suitable copy of this Senate Concurrent Resolution be presented to
