

# 152nd GENERAL ASSEMBLY FEE IMPACT

BILL: HOUSE SUBSTITUTE NO. 1 FOR HOUSE BILL NO. 255 AS AMENDED BY HOUSE

**AMENDMENT NO. 2** 

SPONSOR: Representative Osienski

DESCRIPTION: AN ACT TO AMEND TITLE 7 OF THE DELAWARE CODE RELATING TO THE

**BOILER SAFETY PROGRAM.** 

In accordance with 29 Del. C. §913, the following information is provided relating to licenses and fees.

## **Description of the Legislation:**

This Act, as amended, updates the Department of Natural Resources and Environmental Control (DNREC), Division of Waste and Hazardous Substances Boiler Safety Program as follows:

- Authorizes DNREC to update certain statutory fees within the Boiler Safety Program.
- Establishes a dedicated Boiler Safety Administration Fund administered by DNREC.
- Adds a 6th member to the Council on Boiler Safety.
- Adds an enforcement section and Civil Penalties for violators who fail to comply with Program requirements.

### **Affected Entities:**

Affected entities of this legislation are DNREC and boiler, pressure vessel, or nuclear installation owners in the State.

#### **Fiscal Impact:**

The current annual revenue generated from the Boiler Safety Program fees is approximately \$117,648. The proposed increases would create annual revenue of approximately \$470,095, an increase of \$352,447. This Act updates statutory fees within the Boiler Safety Program as follows:
