

#### 153rd GENERAL ASSEMBLY FEE IMPACT

BILL:	HOUSE BILL NO. 124

DESCRIPTION:	AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO STATE FIRE MARSHAL FEES.

In accordance with 29 Del. C. §913, the following information is provided relating to licenses and fees.

## **Description of the Legislation:**

This Act increases the maximum amount of fees that the State Fire Marshal can charge for portable unit fire suppression appliances and for all other permits, licenses, and certifications as required with the approval of the State Fire Prevention Commission as required in the State Fire Prevention Regulations.

#### **Affected Entities:**

The Delaware State Fire Prevention Commission and the Delaware State Fire Marshal.

## **Fiscal Impact:**

This Act increases the maximum amount of fees that the Office of the State Fire Marshal can charge for portable unit fire suppression appliances and for all other permits, licenses, and certifications as required in the State Fire Prevention Regulations. The proposed fee adjustments would increase rates from \$50 to \$100 and from \$25 to \$100. The proposed fees are projected to generate a minimum of \$13,300 in revenue. Upon enactment, the State Fire Marshal anticipates the following fee changes:
