

# 153rd GENERAL ASSEMBLY FEE IMPACT

BILL: HOUSE BILL NO. 164

SPONSOR: Representative Morrison

DESCRIPTION: AN ACT TO AMEND TITLES 21 AND 30 OF THE DELAWARE CODE RELATING TO

**MOTOR VEHICLES.** 

In accordance with 29 Del. C. §913, the following information is provided relating to licenses and fees.

### **Description of the Legislation:**

This Act amends Titles 21 and 30 of the Delaware code relating to motor vehicles, and authorizes the Department of Transportation (DOT), Division of Motor Vehicles (DMV) to update certain statutory fees and establishes alternative fuel registration fees.

#### **Affected Entities:**

The affected entities of this Act are DOT, DMV, and DMV customers.

#### **Fiscal Impact:**

This Act establishes or updates the following fees to be collected by DMV. Total revenue collections are estimated at \$38,868,000. Fee changes are outlined below.
