

# 153rd GENERAL ASSEMBLY FEE IMPACT

BILL: HOUSE BILL NO. 175

SPONSOR: Representative Heffernan

DESCRIPTION: AN ACT TO AMEND TITLE 7 OF THE DELAWARE CODE RELATING TO THE

DEPARTMENT OF NATURAL RESOURCES AND ENVIRONMENTAL CONTROL FEES AND ASSESSMENT AND TO AUTHORIZE AND APPROVE VARIOUS DNREC

**FEES AND ASSESSMENTS.** 

In accordance with 29 Del. C. §913, the following information is provided relating to licenses and fees.

### **Description of the Legislation:**

This Act authorizes the Department of Natural Resources and Environmental Control (DNREC) to update certain statutory fees and establishes or updates certain permit and licensing fees.

#### **Affected Entities:**

The affected entities of this Act are DNREC, individuals, and businesses that apply for permits.

#### Fiscal Impact:

Upon implementation, the total estimated revenue will be approximately \$7,200,000.
